Directions to Show Site

From Toronto: Take 401 west to 402. Use Exit 82 (Cty road 14 Glendon Drive/Komoka/ Mt Brydges). Turn left onto County Road 14 at stop sign. Proceed north through Komoka until you reach the NEW ROUNDABOUT. Use 3rd Exit onto Vanneck Road (County Road 38). Facility is near the top of the hill on your left. 20215 Vanneck Road.

From Windsor: Take 401 East, Exit 157 road 14 Iona Road, Melbourne, Iona. Turn left towards Melbourne on County Road 14. This will change to County Road 9. Proceed through Melbourne. Turn Right onto Glendon Drive (County Rd 14) and pass through Mount Brydges and Komoka until you reach the NEW ROUNDABOUT. Use 3rd Exit onto Vanneck Road (County Road 38). Facility is near the top of the hill on your left. 20215 Vanneck Road. .

From North: Take Vanneck Road south to 20215 Vanneck Road. Facility is on your Right as you descend hill.
