Lunch break will be at the judge's discretion.

10 min/20 participants will be allowed for competitors to walk the course prior to trial except for C-Stream and Team events where the walkthrough is 3 minutes for 10-12 participants/teams.

Please Note: Food or toys **MUST** be in the **RIGHT-HAND POCKET** of the handler, **OUT OF SIGHT** **NO TREAT/BAIT BAGS.** **NO ACTIVE TOYS** (clickers, laser, squeak toys, etc)

To keep the event running smoothly, all competitors will be expected to keep track of the running order and to be in the 'on deck' area prior to your run.

*** IMPORTANT ***

ALL DOGS COMPETING MUST BE REGISTERED WITH CARO TO COMPETE. REGISTRATION FORMS ARE AVAILABLE AT <http://www.canadianrallyo.ca> AND MUST BE SUBMITTED TO CARO BEFORE THE TRIAL OR ACCOMPANY YOUR ENTRY.

REGISTERING YOUR DOG WITH CARO IS YOUR RESPONSIBILITY. UNLESS YOU ARE SUBMITTING YOUR DOGN REGISTRATION WITH YOUR ENTRY, YOU MUST SHOW YOUR DOG'S REGISTRATION CARD AT THE TRIAL.

CARO MEMBERS RECEIVE DISCOUNTED ENTRY FEES. MEMBERSHIP APPLICATION AVAILABLE AT <http://www.canadianrallyo.ca> APPLICATION MUST BE SUBMITTED TO CARO FOR PROCESSING. MEMBERSHIP NUMBER MUST BE INCLUDED ON TRIAL ENTRY FOR DISCOUNT.

FACILITIES

This is an indoor facility in Brandon, Manitoba. Limited space for crating indoors is available and there are washrooms and water onsite. Bring your own lunch or take advantage of numerous restaurants/grocery stores within a 10 minute drive.

All dogs must be crated, in an ex-pen, or on leash when not in the ring. Any dog engaging in aggressive behaviour at any time will be required to leave the trial grounds. We ask that all dogs be exercised in our enclosed area to the back of the building or across the road in the off leash dog park.

ALL CHILDREN MUST BE SUPERVISED BY A PARENT NOT COMPETING IN THE TRIALS.

ANYONE OBSERVED NOT PICKING UP AFTER THEIR DOG WILL BE EXCUSED AND WILL FORFEIT ENTRY FEES.

AN OFFICIATING JUDGE, AND/OR THE CHAIRPERSON OF THE TRIAL, MAY DISMISS FROM THE TRIAL SITE ANY PERSON SUBJECTING THE JUDGE OR MEMBERS OF THE ORGANISING COMMITTEE TO ABUSE, WHETHER THAT PERSON IS COMPETING IN THE TRIAL OR NOT.

ANYONE OBSERVED DISCIPLINING THEIR DOG IN A MANNER THAT OFFENDS A JUDGE'S SENSIBILITIES WILL BE EXCUSED AND WILL FORFEIT ENTRY FEES.

Blue qualifying ribbons will be awarded to each dog/handler team achieving a score of 170 or better. Rosettes will be awarded for new titles.

In addition there will be rosettes for: High Scoring Puppy in Trial, High Scoring Senior Dog in Trial, High Scoring Visitor in Trial, High Scoring Two Brown Dogs Student in Trial, High Scoring Team in Trial and Perfect Score
