GENERAL INFORMATION

PAYMENT: Please make all cheques or money orders payable to Forbidden Plateau Obedience & Tracking Club. A listing fee of \$9.30 must accompany payment if the dog entered does not have an individually registered C.K.C. number or an E.R.N. number.

U.S. entrants may pay fees by money order made payable in Canadian funds or personal cheque in U.S. funds for the full amount of the fee(s). Personally discounted cheques will not be accepted. Please **DO NOT** mark cheques "Payable in Canadian Funds" or "at par" as these are not readily cleared by the banks. Tendering an NSF or post-dated cheque will be considered as non-payment of fee(s) and will subject the maker of the cheque to a \$15.00 "handling fee" and disciplinary action.(C.K.C.)

Due to the limited entry we shall be accepting entries by MAIL ONLY, with only one entry per envelope. NO EXCEPTIONS! Positions will be assigned on a first come first served basis. The first six UTD entries and the first UTDX entry will get the tracks on Saturday, June 25. The next six UTD entries and the second UTDX entry will get the tracks on Sunday June 26. No trading of tracks is permitted. Once the limit has been reached, all remaining entries will be assigned a position on the "Alternate List" in the order they are received. Entrants will be notified by phone or email that their entry has been received and accepted for the primary test or alternately the position number as an alternate. Entry fees will be returned within 10 days of the day of the test to Alternates who did not participate in the test.

MEETING PLACE AND DRAW: Rendezvous is scheduled for 6:15 a.m. each day at Tim Horton's, 789 Ryan Road (by Superstore), where the draw for tracks will take place. Any primary entrant(s) who is absent at this time will forfeit their position to the first Alternate present.

BITCHES IN SEASON may compete, however, they will run last on their assigned test day. Please advise the Test Secretary upon arrival.

GALLERY: In Urban Tracking the gallery may follow the dog and handler, but must obey the accompanying Marshall's instructions.

AWARDS & NO-HOST LUNCHEON: A no-host luncheon will be held following the tracking test at which time the Judge will present ribbons to all the successful teams. Also, the Club will award keepsake trophies to those same teams.

REFUNDS: When an entered dog is withdrawn after the closing date, refunds will **only** be permitted when the vacancy is accepted by an "Alternate". If a position becomes available, Alternates will be contacted in catalogue order and asked to either accept or decline the position. (ie. if #1 declines #2 will be contacted, etc.)

RULE 14.7: It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Effective January 1, 2011 Non-Member Participation Fee

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will
 match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- c) These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.
