FEES: \$60.00 per entry, \$55 for WAC members (*payable in Canadian funds*)
\$70 day of entry, if space allows
*Dogs not registered with the CKC but eligible to be registered with the CKC
must have obtained a Temporary Competition Number (TCN) prior to entry
and must pay a \$11.30 TCN fee per test.*

DAY OF ENTRIES: will be accepted only for FDJ and FD tests, subject to limitations

ENTRIES CLOSE at 10:00 PM on Friday, October 7, 2022 by email (Entry Line 5:00 PM)

DRAWING at 8:00 p.m. on Tuesday, October 11th, 2022

- Entries will be limited to number of dogs able to run during daylight hours
- Entries may close prior to 10:00 p.m. Friday, October 7, if full
- Entries withdrawn after closing must still pay the appropriate fees, failure to do so, will be considered “*outstanding*” payment
- Running order draw will take place at the home of the Test Secretary and will be published after drawing
- The order & time of tests will be determined once entries close
- The drawing will be “random”, and specific times cannot be assigned
- It is the responsibility of entrants to confirm receipt of their entries
- **NOTE:** Bitches in season will be run on Saturday, October 15 and Sunday, October 16 after all dogs entered in all the tests (FDJ/FD/FDA/FDX/FDXCh) have been run (i.e. only in the 2nd tests at the very end of each day)

SAFETY: **Blaze orange** MUST be worn in the form of a hat **and** a vest during all test categories: FDXCh, FDX, FDA, FD and FDJ. This includes gunners, handlers, judges, apprentice judges and volunteers. **NO EXCEPTIONS!!!**

COURSES AND GAME: Chukar will be used in all categories. Chukar, pheasant, pigeons or ducks may be used in the FDXCh and FDX water retrieve. **Gunning will be done by "official" gunners only.** The FDXCh, FDX, FDA, FD and FDJ course will be a single course with a bird field. FD and FDJ dogs will be run individually. FDX & FDA dogs will be run in braces. **All handlers must carry a starter pistol.**

OTHER RULES:

- No dogs will be allowed to exercise or be trained on the test grounds
- Bitches in season will be allowed to run at the end of the test at the discretion of the Field Chair and Test Secretary, only if there are gunners and bye-dogs available to accommodate where applicable. Current record of vaccination may be required.
- If a dog is not present at its starting pointing within five minutes after it is called for by the judges it may be disqualified.
- Test scores will be available from the Test Secretary after the completion of each test category
- **NOTE:** If you have twice qualified your dog with any of our Judges, please notify the Test Secretary before the drawing time.
- Qualifying scores available at the end of each test from the Test Secretary.
- **Bottled water will be provided. Please bring your own lunch or snacks.**
- It is the responsibility of the entrants to confirm receipt of entries and running times.

PRIZES

- Standard CKC blue flat ribbon to all dogs with a qualifying score.
- Rosettes will be given to the Top Pointing Dog (non-Weimaraner) in each category and the Top Weimaraner in each category.
- Prizes and score sheets can be collected from the secretary's table.
- New title rosettes will be available for any dog completing title requirements

SPECIAL NOTE:

It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer or competitor at a Field Dog Test is not subject to indignities. The Field Test Committee Chairman shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

WAIVER

All attendees, volunteers and participants are required to sign a Release, Consent and Indemnity for Field Tests Waiver before being allowed to participate in or view the test.

MOVE-UPS

Forms for Test 2 (October 15) must be submitted in writing to the Test Secretary one hour before Test 2 starts. Move ups for Test 3 (October 16) must be submitted before the Secretary leaves the grounds on Saturday, October 15. Forms for Test 4 (October 16) must be submitted in writing to the Test Secretary one hour before Test 4 starts. Move-up to a braced class is only permitted if another brace mate or bye dog is available.

CANCELLATIONS & REFUNDS

Cancellations with full refund must be in writing to wactrials@gmail.com and received before official closing at 10:00 PM, Friday, October 7, 2022. No refunds after closing. Bitches that come into season after closing will be refunded for the tests they are not allowed to run in (Tests 1 and 3). **If no bye dog is available for braced classes (FDA, FDX, FDXCh), entries will be fully refunded.**

NON-PAYMENT OR DISHONOURED PAYMENT

Payment must be made in full and accompany the entry form. The WAC reserves the right to refuse entries from persons who have failed to pay entry fees in full at prior tests. Tendering of a dishonored cheque or declined credit card shall be considered non-payment of entry fees and is an offense punishable by disciplinary action and cancellation of awards. Postdated cheques are not acceptable tender.

CKC NON-MEMBER PARTICIPATION FEE

Before a title is awarded, a non-member participation fee of \$170 will be charged if the owner of the dog is a resident of Canada but is not a member of the CKC. The fee applies only to dogs wholly owned by non-member residents of Canada. Basic membership in the CKC is \$54. The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by the individual. In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved to the next level.
