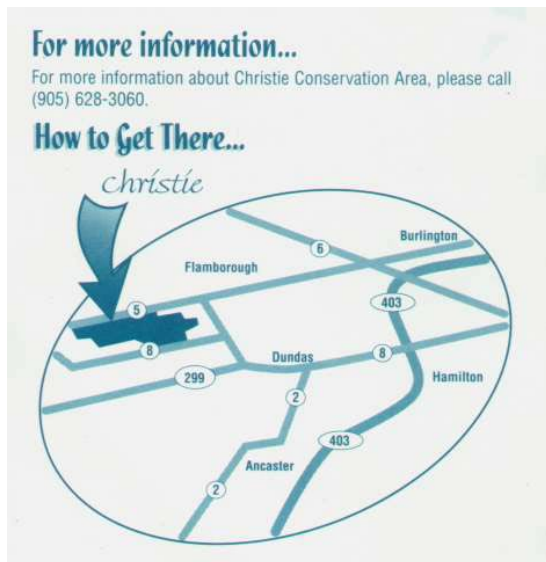

This is a limited entry stake. For both Junior and Senior stake there will be a limit of 20 dogs per day. For Master stake there will be a limit of 25 dogs per day.

Test Details:

- Standard CKC Rosettes awarded to all qualifying dogs at the end of each day
- Game birds will be used
- Shotguns may not necessarily be used
- All handlers **MUST** wear dark or camouflage clothing
- Refunds will be given for bitches in season. A veterinarian certificate must be submitted before the start of the test
- Separate entry forms **MUST** be completed for each test
- Handlers may be required to handle a gun during the test. Gun safety is considered part of the test
- There will be a BBQ with raffle. The fee will be \$10 and can be paid in advance with Dogshow.ca entry fees

LISTING FEE: The \$9.49 (HST included) listing fee must be submitted for any dog without an individual CKC registration number or ERN number.

A TCN must be obtained before submitting an entry for an event and the same TCN must be used for all event entries for a dog until the dog is permanently registered. Once a dog is permanently registered or has an ERN, the TCN will be replaced with the registration number or ERN. A TCN cannot be used for Listed Breeds (MCN) or dogs that will require a (Performance Event Number) PEN or (Canine Companion Number) CCN.

While there is no fee to obtain a TCN, exhibitors will still be required to pay TCN Fees (formerly called listing fees) when entering events using this number.

The process of obtaining a TCN will be self-serve; exhibitors will be directed to the CKC website to complete an online application and a TCN will be issued instantly upon completion.'

IMPORTANT NOTE regarding Non-Member Participation Fee (effective January 1, 2011)

An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of the CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

ENTERING THE TEST: Entries will only be accepted through Dogshow.ca. The Dog Show.ca entries will open on May 13, 2023, at 7:00 pm and close on May 27, 2023, at 7:00pm
