TCN fee per dog per trial (charged by CKC)	\$11.30 each trial (there are 2 trials)

Temporary Competition Number (TCN) is a number issued by the CKC that allows a dog of recognize breed, eligible for CKC registration to participate in CKC events. Dogs that require a Miscellaneous Certification Number, Performance Event Number, or Canine Companion Number, are not eligible for a Temporary Competition Number. **Please note each run entry fee includes the CKC Recording Fee of \$4.70 + HST**

Entries will only be accepted when payment in full is received. Payments must be received within 48 hours of entry or by closing whichever is first. You will receive a confirmation of entry usually within 48 hours of payment. Please email <u>dlmagility@gmail.com</u>ONLY if you do not receive a confirmation of entry by closing date (or within 24 hours of entry if entered within 24 hours of closing or if you have a concern with the information on your confirmation. A judging schedule with trial starting time will be sent to all confirmed entries at least 6 days before the trial.

E-transfer payment to: <u>dlmagility@gmail.com</u>If you are asked for a password, please use AGILITY. Please put the date of this agility trial in the comments so we know what to apply it to. There are NO extra fees for e-transfers. We will not be accepting any paper or emailed entries. All fees are payable in Canadian Funds. Entries will only be accepted if accompanied with payment in full within 48 hours (if entry is less than 48 hours of closing payment is due immediately) confirmation and judging schedule will only be sent to entries that are accompanied by full payment. Unpaid entries will be deleted without notice. We do not accept cheques for payments.

Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made.

CKC has a Non-Member Participation Fee of \$64.00 + HST. This fee only applies to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members. "These events held under the rules of The Canadian Kennel Club".

It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.

The Trial Secretary, Dara Murphy, is in full charge of the trials. Trial precincts consist of the Red Barn property. Whistles, clickers, "squeaky" toys, flexis and prong collars are NOT permitted within 20 feet of any active agility ring and no food or toys within 10' of the ring gates. (Non squeaky toys are permitted in ring with judge approval for FFO runs). Bitches in season are NOT permitted anywhere on the trial precincts. Ring is Top Dog rubber agility flooring with underlay. Ring enclosure is floor to ceiling walls (2 walls) 1 wall of 3 ft wood enclosure with plastic link fence gates and 1 wall of plastic link fencing. Ring dimensions are 90 ft x 90 ft. NO OUTDOOR SHOES ARE ALLOWED IN THE BUILDING. Handlers in all classes may walk the course without their dog prior to the start of

their class. Obstacles shall meet the specifications in the CKC Agility Rules & Regulations effective January 1st, 2023. The broad jump and wall jump will not be offered at this trial.

To be eligible to compete in these trials, a dog must be 18 months of age and eligible for a registration with the CKC, have an ERN or CKC Misc. Certificate, TCN or a CKC Performance Event Number. Spayed bitches, debarked dogs and neutered males are eligible to compete. Mixed breed dogs may enter these trials with a CKC Canine Companion Number.

HEALTH REMINDERS:

No dog may be brought onto the grounds or premises of an event if it:

1. Is known to have distemper, parvovirus, kennel cough or other communicable disease.

2. Has recovered from distemper, parvovirus, kennel cough or other communicable disease within the last 30 days (prior to the event).

3. Has been housed within 30 days prior to the event on premises on which there existed distemper, parvovirus, kennel cough or other communicable disease.

Clubs do have the right to remove a dog from the event premises and the exhibitor may be subject to disciplinary action if it is found that CKC rules have been contravened.

No entries will be accepted, altered, cancelled or substituted after the official closing date and time for entries, except as provided in the rules. Exhibitors must abide by errors made in entering their dogs regardless of how and by whom the errors were made.

Senior handlers 65 an older or handlers with a disability: can request a modified course time or point requirement as of Jan. 1, 2020. Please ensure you check the box on the entry form (in Agility Rocks) to qualify for this if you wish.

Vendors: Vendors or persons providing any services for a fee (including photographers) are not permitted to offer products or services without written permission from Simcoe Performance Dogs.

Check in: Is at the registration desk by the Red Barn front door.

NEW: Course maps: Course maps will be posted in the breezeway heading towards the kitchen, please feel free to take a picture. We no longer provide paper maps.

Running Order:

Novice warm up run (optional run for dogs entered in novice standard run, \$10.00 one run per dog allowed. Standard Novice Standard Intermediate Standard Excellent, Excellent/Master Jumps and Tunnels (all) Jumpers with Weaves 1 Novice Jumpers with Weaves 2 Novice Jumpers with Weaves 2 Intermediate Jumpers with Weaves 2 Intermediate Jumpers with Weaves 1 Excellent, Excellent/Master Jumpers with Weaves 2 Excellent, Excellent/Master Jumpers with Weaves 2 Excellent, Excellent/Master Running Small to Tall

Leashes: There will be a leash runner.

Move-ups: Move-ups will be allowed between events.

Volunteers & Course building: All competitors are required to help with a minimum of 2 positions a day. If you can provide a volunteer, please email volunteer@redbarneventcentre.com

Results: Results will be posted in the breezeway beside the ribbons. They will also be posted on the Red Barn Event Centre website within 48 hours after the trial.


Ribbons: Qualifying and placement ribbons are self serve from the box in the breezeway. **New title rosettes** will be offered at a cost of \$10.00 per rosette, exact change only & pick up before you leave. They are available at the registration desk.

Refunds: Bltches in season may not compete. When a bitch comes into season after the entry has closed, a Vet's certificate certifying the bitch was in season within a 10-day period preceding the trials must reach the trial secretary on or before the start of the first trial. A full refund of entry & listing fees will be given.

As of January 1, 2020, as per CKC regulations if a dog is injured after entry has been submitted to the Trial Secretary, a veterinarian's certificate, certifying the dog was injured before a 3-day period preceding the trial, must reach the Trial Secretary on or before the start of the trial. The club will refund the entry minus the TCN fee and a 30% administration fee per trial.

SPD understands that sometimes important matters prevent someone from attending a trial they entered and paid for, and we will grant up to 90% credit of entry fees on a CASE-BY-CASE BASIS. CKC fees must be paid by the competitor if request after closing. If you have entered this trial and paid prior to the closing date but cannot attend, please write to the secretary by email to r equest a credit. The secretary must receive your request at least one hour before the event starts to be considered by our trial committee and all requests will receive a response within 24 hours of the trial's competition.

RV parking: We have limited30-amp service for those wishing to bring RV's, cost is only \$50 plus HST per day. Washrooms and shower available 24 hours to those that are camping. Please contact registration@redbarneventcentre.com for more details or to book.



Directions to The Red Barn Event Centre: 8464 County Road 27, Barrie, ON L4N 9C4

From the 400: Take the Essa Road exit. Turn west on Essa (sign says Essa Road South). Turn right at Ardagh Road. Follow Ardagh to County Road 27. Go South on County Road 27.(aka Town Line Road) Property is on the west side of the road down a long driveway. There is a private residence at the front of the property.

From Hwy 27: When traveling North on CR 27 you must turn left shortly after passing through the town of Thornton. Look for the 20th Sideroad on your left and then the 10th Line on your right, that's your cue to slow down. Then you will see a small sign on your right that shows you must turn left to stay on CR 27. Turn left on CR 27 and continue north. After passing Mapleview Dr. W. you will go down a big hill, the Red Barn is on your left at the bottom of the hill.

To make everyone's visit a safe and enjoyable one, please respect Red Barn rules:

- 1) PLEASE drive slowly down the long driveway. 10 km limit!
- 2) There is a private residence at the front of the property. Do not walk your dogs down the driveway towards the residence as it upsets the dogs who live there.
- 3) Only Park in the designated parking area.
- 4) Dogs must be on leash always allowed, except when competing in the ring. No exceptions.
- 5) No prong collars or flexi leashes are allowed on the Red Barn Event Centre property

6) Not all dogs love other dogs. Please keep your dog under control and out of other dogs' faces, even if your dog is friendly.

7) Please pick up your dog's waste. Disposal bags and sites are readily available. Green garbage cans are doggy waste only.

7) Please clean up after yourself. Please take home your garbage and recycling (other than doggy waste-green garbage bins).

- 8) No smoking or vaping anywhere on the trial site.
- 9) Please do your best to keep barking to a minimum
- 10) Be nice to our volunteers. Remember if you want to be treated with respect give others the same respect.
