Non-member participation fee

- An annual non-member participation fee for awards and titles will be charged to a Canadian nonmember of CKC.

AWARDS

Standard CKC Rosettes to all dogs qualifying in each event.

SCRATCHES

Scratches for a bitch in season shall be refunded in full. All other scratches will be refunded at the hunt test committee's discretion, other than a scratch fee of \$10.00. Prior to paying such a refund, the club may require an appropriate veterinary certificate. Refunds must be requested in writing to the Hunt Test Secretary no later than seven days after the test event, explaining the reason for the scratch.

BIRDS

Ducks and pheasants may be used in all stakes. Live pigeons may be used for the upland hunting test in the Master Hunt Tests
