DIRECTIONS TO SHEEP THRILLS FARM - Located approx. 15 minutes from Saskatoon.

Head west on 22nd Street and onto Hwy 14. Turn left (south) at the Sandyridge Gas Station onto Young Road. Go 1 mile to the stop sign, turn right (west) onto the paved road. Go about 1 mile; Sheep Thrills is the last place on the right hand side just before the train tracks. There is a gate (with dogs on it) across the drive, open it up and come on in, please close behind you. A map is available on <u>www.sheepthrills.ca</u> or can be found on Google Maps.

The Herding Trials Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.
