BITCHES IN SEASON: Bitches in season shall not be eligible to enter the match.

BORDER CROSSING: A valid rabies certificate is required to bring a dog into Canada and it must be dated at least 30 days prior to entry into Canada.

MATCH SITE: Bring water, shade and shelter for you and your dogs. The matches will be run **rain or shine**. All dogs must be under control, on a leash except during the match. **Flexi leads will not be allowed on the match site.** Clean up after yourself and your dog.

REGULATIONS: It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing.
