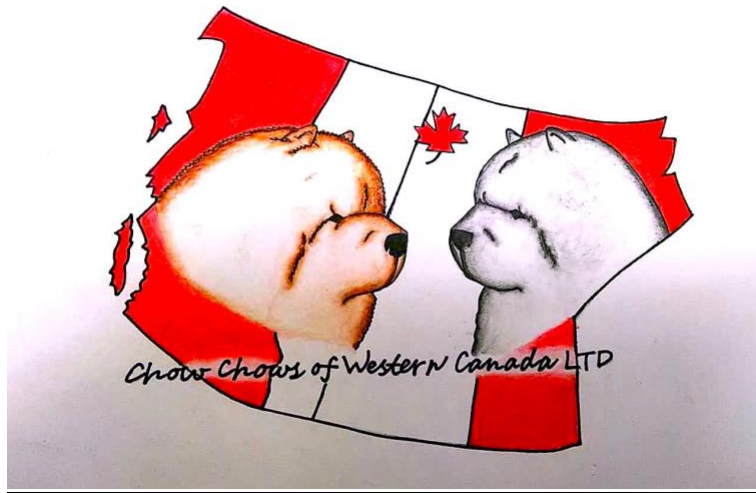

Leeza Friedman-Prokopishyn has been breeding and exhibiting Finnish Lapphunds under the Bearspaw prefix since 2005. Leeza began with a single Finnish Lapphund at UKC shows in the US. Over the years, Bearspaw has worked towards creating and maintaining a sustainable breed population through international collaboration, importing, and exporting DNA. In the show ring, Leeza has bred, owned, and/or shown Finnish Lapphunds winning CKC and/or Finnish BIS, NBISS, and FCI World Winner titles, major wins at Westminster and Eukanuba in the US. Bearspaw dogs have earned champion titles in Canada, US, Finland, Belgium, and the Czech Republic. Bearspaw Lappies have also demonstrated versatility in rally-o, agility, herding, therapy, sprinters, dog dancing, and trick dog. Leeza is a lifetime member of Lappalaiskoirat ry (The Lapphund Club of Finland). Leeza has a love for all dogs, in particular, a passion for spitz and other primitive (FCI group 5) breeds.

Our Judge will give a very interesting talk about her experience with Spitz breeds, after the match concludes! No charge to attend the Judge's talk.

SANCTION MATCH CLASSES

The following conformation classes (divided by sex) will be provided. Only dogs entered in one of the regular, non- regular or unofficial classes shall be allowed within the show precincts.

SANCTION MATCH CLASSES (divided by sex):

PUPPY: 4-6 Month – any Chow Chow 4- 6 months of age on the day of the match.

PUPPY: 6 - 9 Month – any Chow Chow 6- 9 months of age on the day of the match.

PUPPY: 9- 12 Month - any Chow Chow 9 to 12 months of age on the day of the match.

Open - for all Chow Chows, excluding Chow Chows with 5 or more Championship points.

Graduate Class – all Chow Chow males and females with five (5) or more championship points in any country, Champions included.

Sexually Altered - for all Chow Chows that have been neutered or spayed

UNOFFICIAL CLASSES: (to be judged after the Sanction Match classes)

Best Chow Chow Head – for all Chow Chows entered in a sanction match class. This class shall be divided by gender. The winner of each gender shall compete for Best Chow Chow Head in Match.

Best Stilted Gait – for all dogs entered in a sanction match class. This class shall be divided by gender. The winner of each gender shall compete for Best Stilted Gait in Match.

Novice Chow Chow Handler: for any person who has not shown a Chow Chow, prior to the date of this sanction match. Handlers will be judged on their ability to follow the judge's instructions in a basic ring pattern, and present their dog for examination on the ramp.

Parade of Chow Chows: Each Chow Chow may have up to two minutes with one handler, to parade around the ring or to demonstrate the Chow Chow's special attribute, skill or costume. Each handler may submit in advance of the close of entries, a short paragraph for publication in the catalogue, describing why the handler or family love and appreciate their Chow Chow. Each participant in this class will receive a participation certificate.

Sanction Match Class Procedure: Judging to start at 10 a.m.

The undefeated winners of each of the three puppy classes, plus the open class, will compete for Best Dog and Best Bitch. Reserve Dog will be for dogs and bitches undefeated by any dog except the Best Dog and Best Bitch.

Best Dog and Best Bitch will compete for Best of Breed. Best of Opposite Sex will be awarded to the dog that is of best of the sex opposite to Best of Breed.

After Best of Breed judging, each of the undefeated puppy class winners will compete for Best Puppy in Breed

After Best Puppy in Breed judging, Graduates males will be judged. Entries will be placed first, second, third and fourth. Graduate females will then be judged next, and placed first, second, third and fourth. Best Graduate Male will compete against Best Graduate female, for Best Graduate in Match

After Best Graduate in Match, the sexually altered males will be judged. Entries will be placed first to fourth. Then, sexually altered females will be judged and placed first to fourth. The Best Sexually Altered Male will compete against the Best Sexually Altered Female, for Best Sexually Altered in Match.

Unofficial Class Procedure:

After Best Sexually Altered in match is chosen, the Order of judging for the unofficial classes shall be:

Best Head
Best Stilted Gait

GENERAL INFORMATION & RULES GOVERNING THESE SHOWS:

1. This sanction match (“the event”) is an official CKC approved event. The CCWC adhere to the CKC Conformation Dog Show Rules, for this event, a copy of which can be obtained from the Canadian Kennel Club, #400, 200 Ronson Drive, Etobicoke, ON M9W 5Z9 or online at www.ckc.ca.
2. It is the responsibility of the exhibitor to be familiar with, and abide by, the rules pertaining to this event.
3. The Show Superintendent will be in full charge of the event.
4. Entries will be acknowledged after entry closing, with receipt, judging schedule and exhibitor passes. If such acknowledgement is not received please contact the Show Secretary.
5. It shall be the duty and obligation of the event giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities”. The Event superintendent shall promptly report to the Event Committee, who shall have the authority to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
6. We welcome all exhibitors, including persons with disabilities. If you require accommodation of a disability, please make your accommodation known to the CCWC Ltd. in advance of the show by contacting the show secretary.
7. CCWC Ltd reserves the right to remove any person from the event. The Event Superintendent shall have full control of the above fun match
8. Any dog excused by the Event Superintendent for any reason shall not, after being excused, compete in any class for any award for the balance of the sanction match.
9. The event committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
10. Exhibitors are solely responsible for the conduct or actions of their animals while they are within the sanction match precincts.
11. **DOGS MUST BE READY FOR JUDGING.** The CCWC Ltd. will not be responsible for, and is not obligated to provide, any service to notifying owners or agents of breed or class judging.
12. Exhibitors & Handlers with more than one dog shall have alternate handlers available so the judging will not be delayed. All start times are Mountain Daylight Time.
13. Exhibitors and handlers will be responsible for their dogs.

14. For the benefit of the health of animals and the pleasure of the exhibitors we insist that you keep the grounds and buildings as clean as possible. Exhibitors are responsible for cleaning up after their dogs and, if camping, their camp site. Dogs are to be exercised in the designated areas only, not in the ring areas.
15. **Entry fees will not be refunded if the Event cannot open, or be completed, by reason of covid regulations**, changes to venue use policy, riots, civil disturbances, fire, Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of CCWC Ltd..
16. Entry fees will not be refunded if a dog is absent, disqualified, excused by the Judge, or barred from competition by action of the Event Committee.

ADDITIONAL RULES:

- Dogs must be on leash at all times. Absolutely no dogs off leash at any time.
- Exhibitors will be responsible for cleaning up after their dogs. Violators will be asked to leave the event grounds..
- Dogs are not allowed in washrooms.
- The welfare of an exhibitor's child is the responsibility of the exhibitor.
- CCWC Ltd. is not responsible for lost or stolen property.
- CCWC Ltd. will use due care and diligence for the welfare of dogs and exhibitors but will not be responsible for, or assume any liability, in the event of accident or misfortune to dogs, or exhibitors.
