Listing fees are payable with the entry fee for dogs that do not have their Individual registration number at closing date. A litter registration is not acceptable. Official CKC entry forms must be used. **Please photocopy the enclosed entry forms if you require more than were supplied.**

Personal cheque or Money order for the full amount only will be accepted and should be made out to **EVANGELINE KENNEL CLUB.**

No post dated cheques accepted. Post Dated means a date later than the date on which the entry was received. Entries cannot be processed unless the date of the cheque is current. All NSF cheques will be subject to a charge of \$20.00. N.S.F. cheques are considered non-payment of entry fees and are punishable by disciplinary action and cancellation of awards. All fees must be paid before the show

No entries may be accepted, altered, canceled or substituted after the official closing date and time except for as provided in these rules.

Attention USA exhibitors: Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor.

Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank you

Junior Handling will be held at noon. Deadline for entries is 11:00 am. Dogs competing in junior handling must be entered in the show in one of the regular classes or on Exhibition Only

Important Note Regarding Emails & Faxes

It will be the responsibility of the exhibitor to ensure that any electronic submission, either email, facsimile, or any document transmitted electronically, reaches the proper authority or recipient, within the times and limits as regulated for each document in the CKC Rules & regulations. Sent fax receipts, and/or, copies of sent emails, will not be taken as evidence of receipt by recipients.

ENTRY INFORMATION

1. All entries must be received by the closing date and time, accompanied by the proper entry fees and submitted on an official CKC entry form. **Please type or print clearly.**
2. **INCOMPLETE ENTRIES WILL BE RETURNED.** Agents and handlers please note that **full name and address of owners MUST** be filled in and to whom ID's are to be returned. (**Section 13.1.2, Dog Show Rules**)
3. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom entries were made.
4. To comply with CKC regulations, we will be unable to accept or substitute any entry reaching the Show/Trials Secretary after the closing time and date.
5. Only dogs eligible for CKC registration may enter these shows. The Committee reserves the right to refuse any entry subject to CKC rules.

General Information

- The precincts of the shows and trials will be the building and its entrances.
- The Evangeline Kennel Club will use care and diligence for the safety and welfare of the dogs and exhibitors but will not be responsible in the event of an accident to dogs, exhibitors or spectators.
- No canteen available but there are many places to eat close by.
- **The Superintendent will be in complete charge of these trials.**
- It shall be the duty and obligation of the trial giving club to see that a judge, club official, ring steward, volunteer of competitor at an obedience or rally obedience trial held under these regulations shall not be subjected to indignities of any kind. The Trial Committee chair shall report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. (Sect. 17.7 of the Rally Obedience rules & sect. 19.7 of Obedience Trial rules)
- Only a dog individually registered, or eligible to be registered, in the stud book of the Canadian Kennel Club may compete in these trials.
- Bitches in season may not compete. Entry fees will be refunded provided the request is accompanied by a veterinarian's certificate stating bitch was in season within the 10 day period preceding the trial and must reach the secretary on or before the date of the trial.

Event Registration Number (ERN)

All dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will require an Events Registration Number (ERN)

To obtain an ERN number simply do the following:

1. Send a photocopy of the dog's registration certificate reflecting current ownership, for example AKC Registration Certificate with a written request for an ERN number.
2. Include with the above a cheque or money order in the amount currently required payable to the Canadian Kennel Club.
3. Ensure that you provide us with your full return address to enable the ERN number to be sent to you.
4. Faxed requests will be accepted. Please indicate your Visa/MasterCard number expiry date, cardholders name and signature.

This Event Registration Number MUST be applied for within 30 days of the first day of entering a CKC event. Dogs may be entered as "LISTED", however, failure to apply for an ERN number within 30 days will result in cancellation of any wins, awards or scores.
