The Gate Code for our NSGSDC Trials will be 7677. Please do not try to advance through the open gate behind another vehicle. We are not sure how long the gate will remain open. The responsibility is yours!

Unfortunately, there will not be "Day of Entries" either day as the trials are full.

NOTE - Please use the main front entrance only. Armbands will be available for pick up at the Front Desk. This is the only entrance that will be used during the trial.

\*Obedience Judging is based on: Utility - 6 dogs/hour, Open - 7 dogs/hour, Novice A, B, C, Intermediate - 8 dogs/hour & Pre-Novice - 9 dogs/hour.

\*Rally Obedience Judging is based on: 15 dogs/hour plus a 10 min walk-through time per class.

\*Exhibitors are advised to check Judge's Sheets when posted and to immediately advise of any inaccuracies. It is the exhibitor's responsibility to know the rules pertaining to the trials.

\*The precincts of the trials will be the building and its surroundings.

\*No prong or spike collars permitted on site.

\*All exhibitors will be responsible for the clean-up of their dogs anywhere on the trial site and surrounding areas.

\*There will be crating in the room adjacent to the trialing area.

\*The Venue will be open at 7:30 am on Saturday and 8:00 am on Sunday.
