When using the Agility Rocks Online Entry, you will be required to create a username and password and enter your information and your dog(s) information just as would normally be required on the Entry Form. Select the trial that you are entering (MG7 Agility) and then click the waiver page and then enter. You are required to email a copy of the confirmation of your entry to the

Once the entry limit has been reached the entry program will close the trials. Confirmations will be emailed after the entries close.

Wait List:

In the event that a trial day fills before you can enter, please send an email to the Trial Secretary at maryjane.sears@gmail.com with your name, date and the number of runs you are requesting. (You do not have to complete an entry.) Please put Wait List in the subject line of the email.

No entry will be accepted that is incomplete or that is submitted without full entry fees. Exhibitors must abide by any errors made in entering their dog(s) regardless of how or by whom the entries were made. MG7 reserves the right to refuse an entry, subject to CKC rules.

Temporary Competition Number (TCN) Fees of \$11.50 per trial are payable with the Entry Fee for dogs that do not have their individual registration number or ERN at the closing date.

Attention Foreign Exhibitors:

Please note that fees are due and payable in Canadian dollars.

Eligibility:

To compete in these trials, a dog must be at least 18 months of age registered with the CKC and have a registration number, or an ERN, TCN, PEN, CCN or MCN, or be eligible for the same. Dogs may not be lame.

Bitches in season are not permitted to compete. When a bitch comes into season after entry has been submitted, a refund of the entry fee will be made as long as a Veterinarian's Certificate, certifying the bitch was in season within the 10-day period preceding the trial, reaches the Trial Secretary on or before the start of the trial.

No dog may be brought within the trial precincts if it is known to have a communicable disease or has recovered from a communicable disease within the last 30 (thirty) days prior to the event or has been housed within 30 (thirty) days with other dogs with a communicable disease. Entries may be refunded for dogs/bitches that pose a threat of communicable diseases on the day of the trial provided a letter from a veterinarian stating such is presented to the Trial secretary prior to the commencement of the trial.

Temporary Competition Number (TCN) - Effective January 1, 2023:

A Temporary Competition Number (TCN) must be obtained before submitting an entry for an event. The same TCN must be used for all event entries for a dog until the dog is permanently registered. Once a dog is permanently registered or has an ERN, the TCN will be replaced with the Registration Number or ERN. A TCN cannot be used for Listed Breeds (MCN) or dogs that will require a Performance Event Number (PEN) or Canine Companion Number (CCN). Listed Breeds that do not yet have a Miscellaneous Class Number (MCN) will be eligible to apply for a TCN.

There is no fee to obtain a TCN, however, exhibitors will still be required to pay TCN Fees (formerly called Listing Fees) when entering events using a TCN.

A TCN may be obtained online via the CKC website where the number is issued instantly. Exhibitors may also mail in a printed application or contact CKC Shows and Trials by phone for a number. If your dog does not have a registration number or ERN and has already competed in a CKC event and earned points, scores or awards, before applying for a TCN online, exhibitors are encouraged to check their dog's profile to determine if the CKC has already created a TCN for that dog. There will be a tab called TCN Dogs in the owner's Portal account.

Non-Purebred Dogs Require a CCN to Complete Their Entry:

These trials are open to non-purebred dogs. If entering your non-purebred dog (includes mixed-breed and unrecognized-breed) in these trials, your dog will be required to have a Canine Companion Number to complete the entry form. Please check the CKC Policy and Procedures Manual Chapter 6.34 (found online at the CKC website http://www.ckc.ca/en/Events/Overview-of-Events/Agility) for requirements to obtain your dog's CCN. CCN Application Form online at http://www.ckc.ca/en-US/Files/Forms/Membership-Services/Registrations/Canine-Companion-Number-Application. Event Registration Number (ERN):

All dogs that are foreign-born and owned, and enter Canada for the sole purpose of entering CKC events, will require an ERN. Effective January 1, 2023, the policy has been changed to allow Listed Breeds registered with a different Canadian registry to also

apply for an ERN. Canadian-born dogs that are registerable by a breed association in Canada recognized by Agriculture Canada may obtain an ERN.

An ERN must be applied for within 30 days of the first day of entering a CKC event to avoid cancellation of any awards, scores or wins. Dogs may be entered as LISTED. An ERN may be obtained by contacting the CKC by phone at 1-855-364-7252 or by fax at 416-675-6506 or information@ckc.ca or http://www.ckc.ca.

Non-CKC Member Participation Fee (Canadian residents):

Effective January 1, 2011, the CKC has instituted a non-CKC member participation fee for awards and titles for a resident of Canada who is a "non-member" of the Canadian Kennel Club. These fees apply only to dogs wholly owned by a non-CKC member and are not applicable to CKC members. Non-CKC member participants must either obtain a CKC membership or pay the non-member participation fee within 30 days of notification or the CKC will cancel any awards and titles. Prizes, Awards and Ribbons:

Rosettes will be awarded for Qualifying Scores and Flat ribbons will be awarded for 1st to 4th qualifying placements in each class. A Rosette will be awarded to the Top Dog each day.

In addition, the MG7 Club will award a Rosette to the "Top Herding Dog" each day.

General Information:

- 1. Move-ups are allowed to the next level between days or 15 minutes before the start of the next trial on the same day by completing the required Move-Up Form.
- 2. Senior handlers (65+) or handlers with a disability may request a modified course time or point requirement as of Jan 1, 2020. Please ensure you check the box on the entry form to qualify.
- 3. Participants in the trials will be required to volunteer. A volunteer Sign-Up Sheet will be sent out once entries close.
- 4. Venue: 100' x 100' Enclosed Ring outdoors on artificial turf. No cover will be provided in case of inclement weather.
- 5. Manual timing will be used.
- 6. Indoor crating will be available.
- 7. Trial Precincts: Fetch Agility Field, parking lot and the front lobby, office and washroom in the building.
- 8. No equipment familiarization will be offered for Novice dogs.
- 9. Warm-up jumps will be provided in proximity to the ring area.
- 10. Please clean up after your dog.
- 11. Exhibitors are responsible to be familiar with the CKC Rules. Rules & Regulations are online at: http://www.ckc.ca/en/Events/Overview-of-Events/Agility.
- 12. MG7 will use care and diligence for the welfare of the dogs and exhibitors but will not be responsible for, or assume any liability in the event of an accident or other misfortune to dogs, exhibitors or patrons.
- 13. It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.
