Entry Fees (Cdn or U.S.): **TD or UTD test: \$95.00; TDX or UTDX test: \$110.00**

A TCN (Temporary Competition) fee of \$11.30 Cdn or U.S. must accompany the entry of a dog for which a CKC individual registration number, or Event Registration Number (ERN) is not shown on the entry form.

ELIGIBILITY:

- TD Test: There is no prerequisite for a CKC TD test.
- TDX Test: A CKC TD title is a prerequisite for entering a TDX test.
- UTD Test: A CKC TD title OR a UTD Pre-Test Certificate is a prerequisite for entering a UTD test.
- UTDX Test: A CKC UTD title is a prerequisite for entering a UTDX test.
- A dog eligible for a PEN number must have the number prior to entering, and may not enter as a Listed/TCN dog.
- Canadian entrants who are not CKC Members: An annual Non-Member Participation Fee for awards and titles will be charged for dogs wholly owned by a non-CKC member. This fee is not applicable to CKC members or dogs co-owned by CKC members. Non-CKC member participants must either purchase a CKC membership or pay the Non-Member Participation Fee within 30 days of notification, or awards will be cancelled by the CKC.

Entry is limited by club and site resources

Field & Urban Tracking Tests: June 14-15, 2025: General Information

SATURDAY: Field priority* (TD & TDX)* ~ SUNDAY: Urban Priority* (UTD & UTDX).

*Exchanges per CKC tracking rules 6.2.2 and subject to club and site resources.

Field entries will be priority on Saturday, and Urban on Sunday. If you wish to send a *second* Field or Urban entry for the opposite day, we may accept some of those IF the priority levels have not filled.

Second entries require a separate entry form & payment cheque. (Do not combine payments).

ENTRY & PAYMENT INSTRUCTIONS: And *Note re possible Postal Strike

- Make cheques payable to "THUNDER BAY KENNEL & TRAINING CLUB"
- Entries may be mailed, couriered, or dropped in the CCC Drop Box (See Entry Form). *Entrants are encouraged to mail entries to arrive before May 22nd due to a possible postal strike (you can still withdraw up until closing). IF there is a strike and we don't have your entry yet, you may contact the Secretary for alternatives.
- U.S. Exhibitors: We accept U.S. cheques or U.S. bank money orders in U.S. funds. Please do not mark U.S. cheques as "Payable in Canadian funds", as the bank will not accept them.
- An NSF cheque will be subject to a \$40.00 service charge. The Entry fee plus NSF service charge must be paid in cash prior to competing. Sorry, We do not accept electronic payment.

AFTER ENTRY: ENTRY DRAW, ALTERNATES, REFUNDS, TEST AREAS:

- Entrants will be notified by email or phone when their entry has been received by the Test Secretary.
- An Entry Draw will be held (if necessary) on Wednesday June 4th at 6pm. Exhibitors will be notified within 24 hours of their placement into each test or on the Alternate List.
- A Club Worker Draw (per Rule 6.6.2) may be utilized if enough entries are in a class and if eligible entries are received from Club Workers as defined by the TBK&TC Tracking committee.
- An entry of a non-titled dog in a given class (level) will be given preference over the entry of a dog already having the CKC title in that class/level. (Rule 6.1.17). Purebred dogs - untitled or titled - have preference over entries of Mixed Breed or Unrecognized breeds (see rule 2.2.4)
- If an entered dog is withdrawn after the Closing date, a refund will be given if the vacancy is accepted by an Alternate. Alternates will be contacted in Catalogue order and may accept or decline. Remaining Alternates as of test day are encouraged to attend the Track Draw in case absentee spaces become available.
- Cheques for entries not drawn will be returned or destroyed at exhibitor's option.
- Exhibitors may not train on the tracking fields or urban areas designated for a test, within 10 days of the test.

MEETING PLACE & DRAW FOR TRACK ORDER:

Sunday, June 15th: 9:00 am* Draw order for Sunday tracks

- *Secretary or Chair will advise all Entrants of any changes to the above-noted estimated draw times.
- Any primary entrant(s) who is absent at the assigned draw time will forfeit their position if there are alternates present. Please be sure to arrive on time for your draw.
- Bitches in season will be permitted to compete, but 'may' be assigned the last track at the judge's discretion. Please advise the Test Secretary as soon as possible of this condition.
- DRIVING: This is an event 'in motion'. Please listen for instructions as we depart & arrive at sites (we may park you in a different location than the Judge & Tracklayer vehicles). Do not drive or walk onto fields or around urban sites without direction. In convoy, allow the next exhibitor to follow the Judge vehicle. Please don't depart the convoy while we are moving, (or someone may inadvertently follow you!). Thank you!!

DISCIPLINE: Rule 14.7 The test-giving club has the duty and obligation to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Club shall promptly report to the CKC any infringement of this regulation.
