Obedience Judging is based on: Utility - 6 dogs/hour, Open - 7 dogs/hour, Novice A, B, C, Intermediate - 8 dogs/hour & Pre-Novice - 9 dogs/hour.



Rally Obedience Judging is based on 15 dogs/hour plus a 10 min walk-through time per class.

- ✓ Exhibitors are advised to check Judge's Sheets when posted and to immediately advise of any inaccuracies.
- ✓ It is the exhibitor's responsibility to know the rules pertaining to the trials.
- ✓ The precincts of the Trials will be the building and its surroundings.
- ✓ No prong or spike collars permitted on site.
- ✓ All exhibitors will be responsible for the clean-up of their own dogs anywhere on the trial site and surrounding areas.
- ✓ Venue will be open at 7:30 am on Saturday and 8:00 am on Sunday. Since the trials are full there will be no Day of Entries.

Trial Guidelines




To manage congestion in the staging area, it is recommended that you keep your dogs leashed and under control. There will be a marked practice area set up in the staging room for one exhibitor at a time. Please be considerate and make this space available to the next competitor if they wish to use it.

Spectators are welcome in the trialing area. Please respect the Competitor in the ring.

As in the past, we will provide a warm-up space in the trialing area for the next dog only waiting to compete. There will be no crating available on the blue floor of the Trialing area.



Important Reminders Pertaining to the Venue




- Winter is here in full force so please be careful walking and driving this weekend
- No outdoor shoes, no socks and no bare feet in the Trialing area
- No food or drink (water only) in the Trialing area (blue floor)
- No smoking on the premises
- Parking only on the side of the venue building and in the front parking lot
- No parking past the second side door as it is not owned by Ace It
- No exercising dogs on the opposite side of the street, private area


The Dartmouth Kennel Club will be following any health guidelines outlined by the Nova Scotia government. This trial is being held in compliance with the CKC Rules and Regulations for Obedience and Rally Obedience Trials.

The running order will be posted on a board at the entrance to the staging area. Competitors should check off their numbers when they arrive to indicate that they are present. Rally scores will be posted on the running order board. We ask for your understanding and patience. The board is the only place scores will be posted.



Competitors are responsible for being ready to be in the venue in time for their run. The stewards will not be responsible for finding competitors to inform them of their turn in the ring.
