DIRECTIONS TO SITE – 91 DEWITT ROAD, RUSAGONIS, NEW BRUNSWICK

From Fredericton: Follow the Hwy 101 until Hwy 655. Turn left onto Waasis Rd, go apx. 3.5 km's and turn right onto Wilsey. Go through covered bridge turning left onto Rusagonis Road. Go apx 3.5 km's and turn right onto Sunpoke, another 3.5 km's and turn right onto Dewitt. Tests are at #91 Dewitt Road, Rusagonis, NB, apx. 1 km on left.

From Saint John/Oromocto/Moncton: Follow the Trans Canada until Exit 297. At the end of the ramp, turn left and go past the Irving Big Stop and go to the end of the road. Turn right, go 1.3 km's and turn left onto Rusagonis Rd. Go apx 3.5 km's and turn left onto Sunpoke Road. Go another 3.5 km's and turn right onto Dewitt. Tests are at #91 Dewitt Road, Rusagonis, NB, apx. 1 km on left.
