 contact Show & Trials Division CKC 1-855-364-7252)</u>, BEFORE SUBMITTING AN ENTRY FEE FOR AN EVENT. The
 same TCN must be used for all event entries until the dog is permanently registered.
- Entry Forms must be completed in full and accompanied by ENTRY FEES AND, if applicable \$10.50 Temporary Competition Fee.
- Please Note CKC Ruling: Canadian Resident non CKC Members running a wholly owned dog cannot win a placement towards awards unless they pay a non-member participation fee or a membership fee to the CKC. CKC Registration or ERN must be applied for within 30 days of the trial or all awards will be cancelled.
- All participants must be familiar with CKC Rules and Regulation 21.7: In summary, it provides that any Person participating in a Trial shall not be subjected to an indignity of any kind. Violations of this rule shall be dealt with in accordance with the rules and regulations of the Canadian Kennel Club.
- Males and Females will be run in the order of the draw. Bitches in season may not compete and must be withdrawn.
- Any dog not appearing within 15 minutes of its time to run may be disqualified.
- Dead Ducks will be used in all stakes.
- Standard CKC Rosettes will be awarded.

RELEASE AND INDEMNIFICATION OF LANDOWNERS:

All requests for refunds must be in writing and must be received within 2 days of the last day of the trial and, unless otherwise agreed by the field trial committee, must be accompanied by a Veterinarian's certificate.


