

Exhibitors will enter the venue through the door at the back of the parking lot to the rear of the building where they will check in and collect their armband. This is the only entrance that will be used in the trials as the facility is open to patrons in the front bar area on Saturday from 1-5 only.

Masks are not mandatory but please consider others if you are not normally in their company and keep your distance. Hand Sanitizer will be available throughout the venue.

All dogs must be in control at all times and on leash except during the test. Exhibitors may wait in the hall ways for their turn. (This may be restricted Saturday for a portion of the day due to the function.)

<u>DKC respectfully asks "hide" information not be shared with other competitors and that no posting of testing be placed on social media until the end of the trial weekend.</u>

The only dog permitted in the trial area is the dog being tested.

### Reminders Pertaining to the Venue

Please note: There is a small wedding at the facilty on Saturday so please park up by the back door as much as possible. Please do not park directly adjacent to the side of the building, it is a fire lane.

Food and drink are allowed in the crating area (please remember that facility is licenced and make safe food choices). Refrigerator is available. Coffee & Tea will also be available if requested)
