In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the Non-Member Participation Fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. (For a Membership application, please go to www.ckc.ca under CKC Services and Forms On-Line). The Non-Member Participation Fee is fee paid in the calendar year (January – December) in which the dog achieved its title and/or titles.

ATTENTION FOREIGN EXHIBITORS

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. Judging will not commence prior to 8:00 am

The show precincts will be a 150-foot (45m) perimeter from the exterior of the rings.

The obedience venue will be Field 1, within the perimeter outlined by the road from the house to, but not including the trailer/RV sites.

Catalogues will be provided at no cost to exhibitors.

The Trial Chair will be in full charge of the trials, governed by CKC rules.

If, because of riot, civil disturbance, or other acts beyond the controls of the management, it is impossible to open or complete the trial, no refund of Entry Fees will be made.

No entry will be accepted unless all particulars called for on the entry form are shown thereon. **INCOMPLETE ENTRIES WILL BE RETURNED. NO ENTRY WILL BE ACCEPTED UNLESS ACCOMPANIED BY ENTRY FEES.**

TELEPHONE ENTRIES CANNOT BE ACCEPTED.

It is your responsibility to verify the receipt of any electronic entries prior to the advertised closing date.

NOTEWORTHY FARM SHOW SERVICES, reserves the right to refuse any entry, subject to CKC Dog Show Rules.

Identification cards and judging schedule will be mailed / emailed as soon as possible after entries close.

Conflicts between Dog Show Rules and the New Breed Standards. The Board of Directors of the CKC, has ruled that where a conflict arises between the Breed Standards and the Dog Show Rules that the Dog Show Rules will take precedence.

Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entry was made. Changes or cancellation of any entry after closing date is prohibited.

In the event that the dog is absent, excused by a veterinarian or Judge, disqualified, or barred from competition by action of the bench Committee, no entry fees will be refunded.

To avoid noise and confusion, there will be no individual dogs called to the ring by loudspeaker. Delays waiting for dogs will not be possible and handlers with several breeds must arrange for alternate handlers if judging times for their breeds conflict.

Only dogs eligible for registration with CKC may enter this show and trial.

The Miramichi Kennel Club reserves the right to refuse any entries, subject to CKC rules.

A dog awarded Best In Show at an All Breed Championship Show will be credited with five points inclusive of any points won at the Breed or Group level. In no case may a dog earn more than five points at a single show. **NOTE: In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall NOT be included in the calculations of Championship Points.**

Sexually-Altered Championship Points

Championship points will be awarded as per Chapter 15, with the exception of 15.1.11. The winner of an Altered Best in Show shall be awarded points according to the total number of dogs in competition following the point schedule in Section 15.1.2.

HOW THE EVENT IS RUN

Please read this carefully

You are responsible for reading the club waiver (attached) which you will **electronically sign** with your online entry. Your helper (if you bring one) must complete a paper waiver and bring it to the tests (or email it to

patrickmudge2@yahoo.ca beforehand). **You are**

responsible for calculating/checking your own points and knowing if your dog has achieved any titles. Your dog's Sprinter points (earned *after* August 28, 2019) are now available on your CKC online portal. The

calculations and handicaps are available via the Sprinter Rules & Regulations from the CKC website at:

January-1

On arrival for your scheduled time slot:

1. When you arrive, go to the main check-in station for the lameness and in-season inspection. You will need to swab your bitch with a tissue for in-season check and all entries will also be measured.
2. **Two to three dogs before your run**, proceed to the start line waiting area with your dog and have your Catcher (which may be you or your helper) proceed directly to the finish line **with a leash**. ***Unless it is a dog's very FIRST Sprinter Test weekend, Catchers CANNOT wait at the start line then walk/run down the chute when their dog steps to the start line for their turn. The Catcher must ALREADY be at the finish line and ready to catch the dog as the dog steps to the start line with their Releaser.*** Dogs may run "naked" or wear a flat, snug-fitting buckle catch collar with nothing hanging from it that can become entangled in the line **(NO running in martingale or slip collars and NO tags on catch collars)**. You may walk your dog to the start line in a martingale, slip collar or harness, but it **MUST** be removed prior to releasing them.
3. Once your dog runs and is caught and leashed, **clear the chute area**, and prepare for their second run. For safety reasons, **please stay CLEAR of the chute when walking your dog back from the finish line**.
4. The running order is cycled through **TWICE** (repeat steps 1-3) and dog the runs its second, and final, run for the day.
5. Once you have completed your two runs per dog, collected your ribbons and times from the table, and taken your photos, please feel free to stay and enjoy the day at Noteworthy Farm, have lunch at the Woodsmoke Café and cheer on your friends. There are other events you might want to participate in.

OTHER EVENT INFORMATION

You will need to crate your dog in/by your car. There will be no shade provided so please keep your dog cool by keeping windows open, using shade cloths, and providing fresh water (Water is available on site). There's plenty of room for pop-up tents.

All competitors must bring ***TWO* leashes**, one each for the Releaser and Catcher. **A slip leash is ideal for the Catcher.** You may bring your own helper to act as your Catcher or Releaser. If you are not bringing a helper, you may list another exhibitor as your helper or request that a club volunteer release your dog. **This information will be gathered in a form via email ~2 weeks before the tests.**

Also, Noteworthy Farm would appreciate and will post any event pics/candids anyone wishes to share. (again to patrickmudge2@yahoo.ca)

Please ask for help when getting your title and Q ribbons from the check-in table. There are different rosettes for each Sprinter title and club members will help you get the right one.

There will be a "photo booth" set up near the parking area with title/event boards. Feel free to take some pictures of your dog with their ribbons.

**The Whippet Club of Eastern Canada and Noteworthy Farm will be following all current federal, provincial, and local COVID rules at the time of the tests ** Further information, if required, will be emailed to participants with the running orders prior to the event

Important Notes: Please respect instructions, pick up after and maintain control of your dog. **Retractable leads, prong collars, and electronic collars are not allowed on the premises. Owners may have their dog wear a muzzle, if they desire. Dogs may run "naked" or wear a flat, snug-fitting buckle catch collar with nothing hanging from it that can become entangled in the line. You may walk your dog to the start line in a martingale, slip collar or harness, but it MUST be removed prior to releasing them.** There is a risk of injury for all active sports; you can reduce this risk by warming up and cooling down your dog, only running your dog when you feel the field and weather

are appropriate and staying aware of your environment and any safety hazards. A \$10 fine, payable to Miramichi Kennel Club, will be levied for any dog loose on the field from the time of inspection until the completion of all events for the day. A \$10 fine, payable to ECSA, will be levied for any exhibitor not picking up after their dog. Events run rain or shine.

It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the CKC Sprinter Rules & Regulations are available from the Canadian Kennel Club online or via mail. Tel: 1-800-250-8040.

CKC Regulation: It shall be the duty and obligation of the trial giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Test Chairperson shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Eligibility: Purebred or mixed-breed dogs must be at least 12 months of age that are: (a) Individually registered with the CKC, (b) Have an Event Registration Number (ERN), (c) Have a Performance Event Number (PEN), (d) Eligible for registration with the CKC, or (e) Have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed (f) Have a Canine Companion number (CCN) if it is a mixed-breed.

Bitches in Season: Bitches in season shall not be eligible to enter these tests.

Awards and Prizes: Qualifiers will receive flat ribbons. Rosettes will be provided for dogs achieving a title during these events.

- Lamé dogs or bitches in season will be excused and their entry refunded, provided notice is given prior to or during roll call.
- Dogs not present at roll call shall be scratched.
- Azawakh’s may compete but must have a Miscellaneous Certification Number (MCN)
- Dogs not registered with the CKC must have a TCN. TCNs are replacing the current system of entering events with dogs as “listed”, and allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN).

CKC NON-MEMBER PARTICIPATION FEE POLICY

A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC. The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld. All Premium Lists will carry a note stating the fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members. TEMPORARY COMPETITION NUMBER (TCN)

Effective November 1, 2019, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require a Temporary Competition number (TCN). This TCN does not register a dog for breeding purposes as defined in the Animal Pedigree Act, but rather enables a foreign-owned dog to be awarded titles by the Canadian Kennel Club. Each dog must have its own number. To obtain a TCN, go to the CKC website and register online. This number will automatically be generated once submitted and will be a 9 character registration number such as TC-AB1234567

A hound entered in the Singles stake shall be barred from competition in the Open or Veterans stake at the same trial. A dog that is declared ineligible can compete in the Single stake at a trial.

CONDITIONS:

Open and Veteran Stakes will be split in any breed has more than 20 dogs entered at the time of the draw. All dogs will run twice in braces or trios unless excused, dismissed or disqualified. - Attained 100 championship points in the open or mixed stake competition.
- Attained 1 first or 2 second placements by defeating dogs in head to head competition.

Field Champion Excellent (FChX) will be awarded to the hound which has fulfilled the following requirements:

- Is a Field Champion of record.
- Obtains 200 additional points in competition.
- Attains at least 5 first placements in competition. This includes first placements won while attaining an FCh.

- Field Champion Excellent title shall be a repetitive title, with a numerical designation. After completing the FCHX title, a hound shall be awarded the next level of title each time it fulfills the requirements of an additional 300 points and 5 first placements with competition. First placements in excess of 5 may be carried forward, and the process shall be indefinitely repeated (FCHX2, FCHX3 etc.).

Novice Courser (NC) shall be awarded as a suffix to the registered name of any hound which has fulfilled the following requirements:

- Attain 3 qualifying scores in the open stake under a minimum of 3 different judges.

Advanced Courser (AC) shall be awarded as a suffix to the registered name of any hound which has fulfilled the following requirements:

- Attain 10 qualifying scores in the open stake under a minimum of 3 different judges.

- Scores earned for the Novice Courser title shall count as three of the ten scores required.

Advanced Courser Excellent (ACX) shall be awarded as a suffix to the registered name of any hound which has fulfilled the following requirements:

Veteran Field Champion (VfCh) shall be awarded as a suffix to the registered name of any hound which has fulfilled the following requirements:

- Attained 50 championship points in the Veteran Open or Veteran Mixed Stake competition.

- Attained 1 first or 2 second placements against other hounds

Veteran Field Champion Excellent (VfChx) will be awarded to the hound which has fulfilled the following requirements:

- Is a Veteran Field Champion of record.

- Obtains 50 additional points in competition in the veteran stake.

- Attains at least 4 first placements in competition. This includes first placements won while attaining a VfCh.

- The Veteran Field Champion Excellent title shall be a repetitive title with a numerical designation. After completing the VfChx title, a hound shall be awarded the next level of title each time it fulfills the requirements of an additional 50 points and 4 first placements with competition. First placements in excess of 4 may be carried forward, and the process shall be indefinitely repeated (VfChx2, VfChx3 etc.).

NON-MEMBER PARTICIPATION

FEE POLICY

Effective January 1, 2011

a) A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC. The fee will be \$59.40, plus applicable taxes.

b) The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.

c) In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld.

d) The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

TEMPORARY COMPETITION NUMBER (TCN)

Effective November 1, 2019, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an Temporary Competition number (TCN). This TCN

does not register a dog for breeding purposes as defined in the Animal Pedigree Act, but rather enables a foreign-owned dog to be awarded titles by the Canadian Kennel Club. Each dog must have its own number. To obtain a TCN, go to the CKC website and register online. This number will automatically be generated once submitted and will be a 9 character registration number such as TC-AB1234567

MIXED AND UNRECOGNIZED BREEDS

These events are open to mixed and unrecognized breeds. In order to compete, mixed and unrecognized breed dogs must have a Canine Companion Number (CCN) from the Canadian Kennel Club and must have a CKC-approved microchip. Mixed-breed dogs must be spayed or neutered.

Unrecognized breed dogs do not need to be spayed or neutered. A dog eligible for a CCN may not be entered as a listed dog. If a dog is not registered individually in the CKC studbook it may be entered as a listed dog per CKC rules for this designation, as of July 1, 2018; exhibitors must apply to the CKC for “temporary competition number (TCN), before event closing date”.

Event rulebooks and application forms for the CCN, TCN and Non-Member Participation Fee are available on the CKC website.

TITLES SHALL BE AWARDED ON THE BASIS OF THE FOLLOWING:

Three titles will be awarded for dogs that pass the Chase Ability Program event the required number of times. For purebred dogs, these are suffix titles that will appear on a dog's pedigree with a higher level title superseding a lower level title.

1. Chase Ability (CA) – Awarded to a dog that passes the Chase Ability event three times under at least two different judges.
2. Chase Ability Excellent (CAX) – Dog pass the CA event a total of 10 times (CA + 7 additional passes)
3. Chase Ability Excellent 2 (CAX2) – Dog passes the CA event a total of 20 times. A higher number title will be awarded for every ten (10) passes.

RIBBONS:

Flat ribbons for qualifying run

Rosette maybe awarded for dogs completing the Chase Ability Program title.

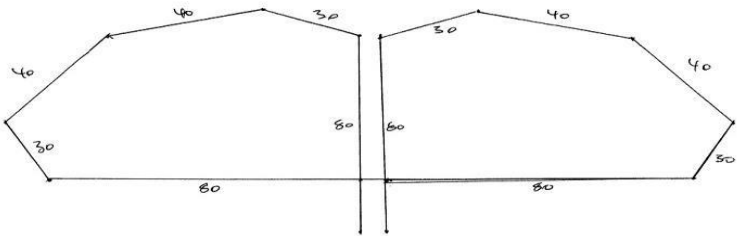

ELIGIBLE BREEDS: Chase Ability Program participation is open to all purebred and mixed breed dogs at least 12 months of age that are individually registered with the CKC; or have an Temporary Competition Number (TCN); or have a Performance Event Number (PEN); or eligible for registration with the CKC; or have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed; or have a Canine Companion Number (CCN) if it's a mixed breed.

Dogs with breed disqualifications are eligible to enter. Females in season may not enter. A dog may enter only once per event. Dogs run as singles.

300-YARD COURSE: This distance is for dogs shorter than 12 inches at the withers or brachycephalic ("flat-faced") dogs. **Dogs will run one loop.**

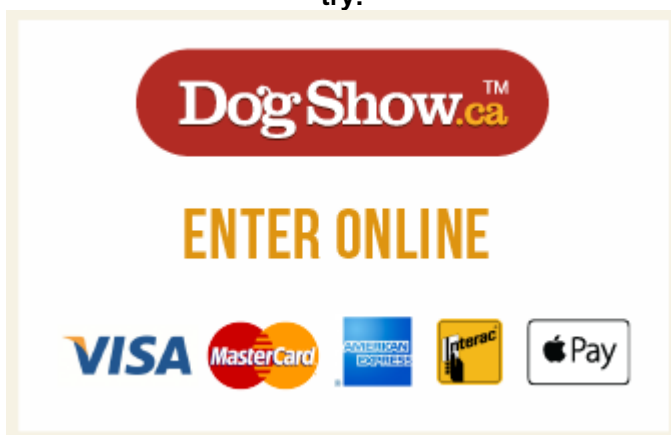
600-YARD COURSE: This distance is used for all dogs that do not run the 300 yard course. **Dogs will run both loops.**

If there is a question as to which course a dog will run the judge will decide.

CONDITIONS: All dogs will run individually. Slip leads recommended when starting your dogs. Muzzles may be used at owner's discretion. Dogs not present at roll call shall be scratched with no refunds. NO EXCEPTIONS. Lame dogs or bitches in season during roll call will be excused and their entry fees refunded.

ATLANTIC EXTRAVAGANZA'S NADD DOCK DIVING COMPETITION

- A NADD Registration Number is required to enter. Available through the NADD website: <https://northamericadivingdogs.com>
- Splashes include up to **three minutes** on the dock for **one optional practice jump** and **two judged jumps**. You must inform the judge prior to your jump if you want it to be considered a "practice jump".
- This event is an **Open Splash** event. This is done at Portable Dock trials and other shows that have timing conflicts with other dog events. The time for each splash for the day will be set such as 9am for example for all the splashes. You have **between the posted start time and end time** (either before AR starts or the end of the last day, usually 3pm) to complete your splashes for the day. When you check in you will be handed "Splash Cards" for each splash that you pay for. When you are ready to jump during the day, hand a splash card to the wrangler to get put into the running order. It is the handler's responsibility to be sure to be present it before their turn to jump. Please be aware

that at many events, the running order board fills very quickly and early in the day.

- **Please Note:** You must pay for all pre registered splashes at time of check-in. Any splashes not paid for will be put back into the event's on-site registration availability list and result in a no-show. If you are registering multiple dogs there will be a no-show for each dog. You are responsible for all pre-registered splashes.
- Each distance jumping Splash allows **2 judged jumps**, back to back. The longest jump of them will be your Qualifying Score.
- You can earn a **[Diving Dog Title](#)** at this event. You must have five Qualifying Scores within a Division. NADD titles are recognized by the AKC and CKC through their recognition programs.
