Keltie Lang "Problem Solving for the Advance Handler" Workshop

Hosted by Cal K9 Obedience Club of Calgary February 8 & 9, 2020

This Seminar will be geared toward those handlers working at the MOTCH/GMOTCH level (or those at the OTCH level aspiring to that level)

Keltie will be focusing on how to maintain enthusiasm and accuracy when campaigning, avoiding trialing burn out, maintaining consistency in performance and damage control when things go wrong in certain exercises. Learn how Keltie manages to consistently be at the top of her game no matter how many trials her dog is in.

Saturday - Heeling, Warm up, Physical Fitness & Body Awareness:

Heelwork is not only the most difficult concept to teach a dog; it also requires the most maintenance and is the most physically and mentally demanding exercise required of the obedience dog. Heelwork exercises will be done as a group, with the focus on precision and mental/physical conditioning. Warm up will focus on how to effectively and efficiently warm your dog up prior to going into the ring without wasting their energy and tiring them out. Physical fitness and body awareness helps maintain the dog's understanding and thought process. This will involve exercises such as Drop on Recall, Change of Position, Stands out of Motion and Front and Finish skills.

Sunday - Heeling, Maintaining Enthusiasm & Accuracy, Problem Solving & Mental Toughness

More precision heelwork drills will be covered throughout the day. Avoiding burnout and maintaining enthusiasm, precision and accuracy in the retrieving exercises, change of positions, directed jumping and broad jump will be addressed.

Based on participants needs, problem solving in all of the exercises will be discussed. As important as it is to motivate our dogs, we must also motivate ourselves. As such, maintaining mental toughness and stamina for both dog and handler will be covered.

The above are general outlines of what each day will entail, many exercises will be covered throughout the weekend.
