

## **GENERAL RULES AND INFORMATION**

A description of all Conformation, Obedience and Rally Classes and Rule and Regulations can be found at www.ckc.ca

- 1. This show is held INDOORS at the Camrose Regional Exhibition Grounds (4250 Exhibition Drive, Camrose, Alberta)
- 2. This is an UNLIMITED entry Conformation dog show. Performance shows entry limited to the timing restrictions of each judge.
- 3. The show building will be OPEN at **3pm on Thursday** for exhibitors. Booths may be set up after 11am Thursday.
- 4. DAY OF TRIAL ENTRIES are permitted at this show. MIXED BREEDS are allowed in performance events with CCN.
- 5. RALLY-OBEDIENCE will be held in a **55' x 40' ring**. OBEDIENCE will be held in a **37' x 40' ring**. The Precincts of the Rally trials are the ring and the immediate area surrounding the ring. Only dogs entered in the trials are permitted within the Precincts of the Rally trials.
- 6. It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to INDIGNITIES. The Conformation Show or Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalog. (19.7 CKC Conformation Show and 20.7 CKC Obedience and Rally-Obedience Trial Rules and Regulations.)
- 7. ENTRY FEES WILL NOT BE REFUNDED AFTER CLOSING DATE in the event that a dog is absent, disqualified, excused by a veterinarian, judge or show official, entered incorrectly, barred from competition by an act of the BRCA or CKC, or due to riot, civil disturbance or other acts beyond the control of the CKC or BRCA except as follows:
  - a) TRIAL FEES WILL BE REFUNDED WHEN A BITCH ENTERED INTO THE OBEDIENCE OR RALLY SHOW COMES IN TO SEASON within 10 days of the show. A veterinary letter certifying that the bitch came into season within 10 days prior to the show must be delivered to the Show Secretary prior to the commencement of that trial's judging.
- 8. NON-MEMBER PARTICIPATION FEE:
  - a) An annual non-member fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
  - b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or pay the non-member fee.
  - c) These fees apply only to dogs wholly owned by non-members of the CKC.
- 9. The Camrose Regional Exhibition will LOCK the doors at 10 p.m. each night of the show and OPEN the doors at 6:00 a.m. each morning. CRE staff will patrol the building overnight but will not be responsible for any liability in the event of an accident or other misfortune to either dogs, exhibitors, patrons or their property.
- 10. All EMPTY rings are to be kept free of dogs one hour before the show and during the show.
- 11. Entries will be ACKNOWLEDGED after the closing date. Judging schedule and receipts available online or by mail.
- 12. Dogs must be EXERCISED in designated areas only. If you exercise outside you must clean up after your dog.
- 13. All dogs in the show building must either be REGISTERED in the show, "IN TRANSIT" or registered for the Eye Clinic.
- 14. All entries must be CLEARLY filled out. The BRCA or the Show Secretary will not correct incorrect entries.
- 15. SIGNS advertising puppies or other services will not be permitted in the benching area or around the rings
- 16. PARKING at this show. A fire lane will be marked along the barns adjacent to the South and West parking areas. DO NOT park in any fire lane or around the barns. PERFORMANCE exhibitors may park in the North or South lots. CONFORMATION exhibitors may park in the North or West or South lots.
- 17. RV CAMPING will be in the north parking lot only.
- 18. Exhibitors and helpers will not need wristbands. Public attendees will be given wristbands.
- 19. A food truck will be operating out of the concession. Cathy French Photography will provide coffee and snacks in the morning.
- 20. The building will be CLEANED each night and anything left behind in the day-benching or ringside area will be removed. Tables and other high touch surfaces will be cleaned regularly throughout the day.
- 21. There will be a PHOTOGRAPHER at this show.
- 22. BRCA has a ZERO tolerance of abuse of any description involving any person involved with BRCA Shows, including spectators.

The following classes will be provided, divided by sex.

#### **REGULAR CLASSES**

JUNIOR PUPPY - 6 months & under 9 months on the day of the show

SENIOR PUPPY- 9 months & under 12 months on the day of the show

**<u>CANADIAN BRED</u>** - for dogs born in Canada, Champions in any country excluded.

<u>12 – 18 MONTH CLASS</u> 12 months and under 18 months on the day of the show.

BRED BY EXHIBITOR - shall be for dogs owned and handled in the ring by the breeder.

**OPEN CLASS** - shall be for all Dogs.

**SPECIALS ONLY** - This class will NOT be divided by sex. A dog may be entered for "Specials Only" and such dog shall compete for Best of Breed award. If eligible it must compete for the award of Best of Opposite Sex. All awards the dog earned at the show will be canceled if, at the time of closing of entries for the show, the dog was not registered individually in the records of the Canadian Kennel Club or if the dog has not earned all the championship points required for championship status. The entry of a Listed Dog in this class is NOT Allowed.

#### **NON-REGULAR CLASSES**

<u>VETERAN CLASS</u> - In this optional class for All Breed Shows, dogs must be 7 years of age and over on the day of the show. Dogs entered in this class may be spayed or neutered. The awards for this class are: Best Male Veteran and Best Female Veteran, Best Veteran in Breed, Best Veteran in Group, Best Veteran in Show. A Veteran awarded Best Veteran in Breed is not required to stay to compete for Best Veteran in Group. A Veteran awarded Best Veteran in Group is not required to stay to compete for Best Veteran in Show.

**BABY PUPPY CLASS** – Dogs over 4 months of age and under 6 months of age on the day of the show. The award for this class are: Best Baby Male and Best Baby Female, Best Baby Puppy in Breed, Best Baby Puppy in Group, Best Baby Puppy in Show

**BRACE CLASS** - This class shall be for two dogs of the same breed (not necessarily of the same sex).

**EXHIBITION ONLY** - Dogs entered in this class may not compete in the regular breed classes.



# **OBEDIENCE:**

**PRE-NOVICE** – shall be for any dog which has not earned the title of P.C.D. (Pre-Companion Dog) in Canada. Dogs in this class may be handled by the owner or any other person.

**NOVICE "A"** - The Novice A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has not earned the title of CD. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families, and must be eligible to handle under Section No person who has exhibited a dog that has earned a CDX title shall be allowed to handle a dog in this class. When a dog is wrongfully entered in this class, any score awarded will be cancelled

**NOVICE "B"** - The Novice B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has not earned the title of CD. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all seven (7) exercises unless he has two (2) or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises. No dog may be entered in both the Novice A and Novice B class at any one trial.

**Novice C** class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title CD or any higher obedience titles. Dogs in this class may be handled by the owner or any other person. A person may enter more than one (1) dog in this class. The same handler must handle each dog in all six (6) exercises unless he has two (2) or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises. Dogs may compete in the Novice C class indefinitely. Scores earned by dogs entered in the Novice C class are not eligible for High in Trial and do not qualify a dog for any title. Dogs may be entered in the Novice C class in addition to any other official or unofficial classes for which they are eligible

#### INTERMEDIATE NOVICE - as per Obedience Trial Rules & Regulation

**OPEN "A"**- The Open A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title of CD but has not earned the title of CDX. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. Only one (1) dog per handler is allowed in this class and that person must handle the dog in all exercises. Any person who has exhibited a dog that has earned an OTCH title may not handle a dog in this class. When a dog is wrongfully entered in this class, any score awarded will be cancelled.

**OPEN "B"** - The Open B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title of CD. Dogs that have earned the title of CDX or any higher obedience titles may enter in the Open B class. A dog may also be entered in the Utility class in the same trial. Dogs in this class may be handled by the owner or any other person. A person may enter or handle more than one (1) dog in this class. The same handler must handle each dog in all seven (7) exercises. Prior to the start of judging, the judge will choose which of the six (6) numbered routines is to be performed. These choices will not be disclosed to exhibitors until they are posted at ring side at least 30 minutes before the start of each class and never more than one hour before the start of the trial. In future assignments, judges are required to alternate the six (6) routines so they will be used approximately the same number of times.

**UTILITY "A"** – The Utility A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title of CDX but has not earned the title of OTCH. Any person who has exhibited a dog that has earned a MOTCH title may not handle dogs in this class. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. Owners may enter more than one (1) dog in this class. The same person must handle the dog in all exercises. When a dog is wrongfully entered in this class, any score awarded will be cancelled.

**UTILITY "B"** – The Utility B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title of CDX or OTCH. Dogs in this class may be handled by the owner or any other person. Owners may enter more than one (1) dog in this class. The same person must handle the dog in all exercises. No dog may be entered in both the Utility A and Utility B classes at any one trial. Prior to the start of judging, the judge will choose which of the six (6) numbered routines will be performed. This choice will not be disclosed to exhibitors until it is posted at ring side at least 30 minutes before the start of the class and never more than one hour before the start of the trial. In future assignments, judges are required to alternate the six (6) routines so that each will be used approximately the same number of times

# **RALLY OBEDIENCE**

- **RALLY NOVICE A:** Dogs competing in this class may not have earned the R. N. title or any CKC Obedience title other than P.C.D. No handler who has exhibited a dog through its CKC C.D.X. title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. All exercises are judged on leash, and all dogs must enter and leave the ring on leash.
- **RALLY NOVICE B:** Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged on leash, and all dogs must enter and leave the ring on leash.
- **RALLY INTERMEDIATE:** The Rally Intermediate Class is an elective class and earning the title is not a requirement to enter Rally Advanced Classes.(CKC rules, 10.1.2) This class shall be for dogs that have earned the R.N. title. A dog completing the R.I. or any other obedience or rally titles may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. This class (performed on leash, no jumps, no A or B division) may be entered indefinitely. Judges would ordinarily use the same course for it as for their Advanced Classes, substituting one other exercise for the jump required in Advanced.
- **RALLY ADVANCED A:** This class shall be for dogs that have won the Rally Novice (R. N.) title but have not won the Rally Advanced (R. A.) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title. All dogs must enter and leave the ring on leash.
- **RALLY ADVANCED B:** This class will be for dogs that have earned the R.N. title. A dog completing the R.A. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash. All dogs must enter and leave the ring on leash. No dog may be entered in both Rally Advanced A and Rally Advanced B at any one trial.
- **RALLY EXCELLENT A:** This class shall be for dogs that have earned the R. A. title, but have not earned the R. E. title or any CKC Obedience title other than P.C.D. No handler who has exhibited a dog through its CKC C.D.X. title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. All exercises are judged off leash. There is also a sit stay exercise after the finish sign. All dogs must enter and leave the ring on leash.
- **RALLY EXCELLENT B:** This class will be for dogs that have earned the R.A. title. A dog completing the R.E. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash. There is a sit stay exercise after the finish sign
- **RALLY MASTER**: This class will be for dogs that have earned the R.E. TITLE . A dog completing the R.M. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class.. A person may enter more than one dog in this class
- \*All dogs must enter and leave the ring on leash.
- \*No dog may be entered in both Rally Excellent A and Rally Excellent B at any one trial.
- \*No handler who has exhibited a dog through its C.K.C. Obedience CDX title shall be eligible to enter the 'A' class in Rally Novice, Advanced or Excellent.

# **CHAMPIONSHIP POINTS**

15.1.2 The schedule to be employed in the determination of the number of points awarded Winners shall be as follows:

| Dogs<br>Competing* | 1 | 2 | 3 - 5 | 6 - 9 | 10 - 12 | 13 + |

\*Includes the dog awarded Winners

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points.

15.1.8 In addition to championship points allocated at the breed level, a dog awarded Best of Breed which also places in the regular Group competition shall be credited with the following additional points provided that a dog was defeated at the Group level.

15.1.9 A dog may not be credited with more than five (5) championship points in a single show.

15.1.10 Permission shall be granted a club or clubs to hold shows in such a way that any dog may earn three (3) sets of championship points on the same day, provided that one or more of those sets of points is awarded at a specialty for that breed or group.

**15.1.11** A dog awarded Winners that also places Best in Show at an all-breed conformation show shall be credited with five (5) championship points inclusive of any points earned at the breed and group level.

15.1.12 In order for a dog to be recognized as a champion and its owner provided with a championship certificate, the dog must: (a) earn at least 10 championship points under at least three (3) different judges; (b) be registered in the records of the CKC, have an Event Registration Number (ERN) or have a Miscellaneous Certification Number (MCN); (c) have earned at least one 2-point win either at the breed or group level.

15.1.13 The Board interprets the words "earn at least 10 championship points under 3 different judges" to mean: (a) Three (3) or more Winners awards at not less than three (3) different shows, under three (3) different judges at the breed level; (b) each of the three (3) judge's awards must be one or more championship points won at Winners, Best of Winners, Best of Breed or group placing; (c) all points required for championship status may be earned at Winners, Best of Winners, Best of Opposite Sex, Best of Breed or group placing.

# As of July 2021, the rules for awarding of Grand Champion and Grand Champion Excellent have changed. Please see CKC Conformation Rule 15.2 Grand Champion (GCH) & 15.3 Grand Champion Excellent (GCHEX) for details.

# **<u>RESERVED BENCHING FOR</u>** <u>CONFORMATION AND PERFORMANCE</u>

Unreserved benching will still be available ..

We've had many requests for smaller spaces for exhibitors with fewer dogs. To facilitate this we are going to smaller spaces in the middle area away from the walls. Book the number of spaces you need for your dogs (2 dogs per space). If your friend books a few for themselves, we'll put you together. We still have the Large and X-Large spaces along the walls.

Book your space early. You can book your space before you book your entries.

If your club wants tables for an Auction, PLEASE book a Large or XL space and text Al Nilson @ (587) 989-7351 to have your space located with good traffic flow.




