Head west on 109 (Hwy 9) to 8th Line Amaranth and head North for approximately 13 km. Property on Right.

From Shelburne:

Head west on Hwy 89 to 8th Line Amaranth and head South for approximately 12 km. Property on Left.

Test Rules

Course and Game:

- FDJ, FD, and FDA will be a single course with bird field.
- FDX and FDXCh will be a single course.
- Chukar will be used in all categories. Ducks/chukar and/pigeons will be used in the FDX water retrieve.
- Gunning will be done by "official" gunners only.
- FDJ, FD and FDA dogs will be run individually, FDX and FDXCh dogs will be run in braces.
- Handlers must carry a starter pistol, and for safety reasons **all entrants must wear some blaze orange clothing and/or hat.**
- If a dog is not present at its starting point within 5 minutes after it is called for by the judges it may be disqualified.
 - Qualifying scores will be available at the **end of each test** from the Test Secretary.

Other Rules

- No training or running of dogs on the grounds during, before or after the tests.
- Bitches in season are not permitted on the grounds.
- A current record of vaccination may be re-

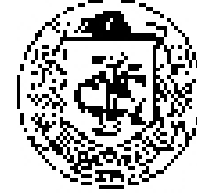
