

**Eligible Participants:** This is a team sport between 2 handlers and 1 dog. Participation is open to all purebred and mixed-breed dogs at least 12 months of age that are:

- Individually registered with the CKC
- have an Event Registration Number (ERN), or
- have a Performance Event Number (PEN), or
- have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed,
- have a Canine Companion Number (CCN) if it's a mixed breed.
- have a Temporary Competition Number (TCN)

Enter online at Dogshow.ca or by sending the waiver and the entry form that are at the end of the premium to the event secretary email address.



#### Fees:

No entry will be accepted without payment in full. Tendering of an NSF cheque in payment of entry fees will be considered nonpayment of entry fees and is an offence punishable by CKC disciplinary action and cancellation of awards. Overpayments and duplicate entries will be considered a donation to our trophy funds. Thank you!

Please note that the waivers <u>MUST</u> be signed, emailed to the event secretary or brought to the trial. Waivers & entry forms are at the end of this premium. Without the waiver your dog will cannot run.

#### Withdrawals of Entrees:

\*\* An exhibitor has the right to withdraw an entry up to the closing date and time as published in the premium list. This may be done by telephone, but written or electronic notification must by received by the Event Secretary no later than the official closing date and time. If written notification is not received the closing date and time the dog will remain entered in the event \*\*

#### **General Information:**

- The Event Superintendent (ES) will oversee the events that will be governed by CKC rules
- Sprinter Rule books are available from CKC (updated January 1, 2024)
- Entries made through Dogshow.ca will be acknowledged by email with a receipt.
- We welcome all exhibitors, including persons with disabilities. If you require
  accommodation of a disability, please make your needs known to the club in
  advance. Please contact the event secretary by July 16, 2025, to ensure that we can
  do our best to accommodate your needs.
- Sprinter Rules and Regulations 3.1.4 (m) "It shall be the duty and obligation of the
  event-giving club to see that a judge, club official, volunteer or any participant at an
  event held under these rules is not subject to indignities of any kind. The event
  Committee Chair shall promptly report to the CKC any infringement of this
  regulation, and the CKC shall have the authority to take such action as it deems fit
  on receipt of a report indicating this has occurred."

#### **Essential need to knows:**

- Bring shade and water for yourself and your dog
- Lame or unfit dogs will be excused and their entries will not be refunded
- Do not leave dogs unattended. Tie outs are not permitted
- Bitches in season MUST wear clean, dry, snugly fitting panties specifically designed for the purpose of precenting/containing discharge
- Dogs not at roll call / inspection shall be scratched and no refunds will be provided
- Dogs are expected to be aroused and excited in the presence of the lure, however handlers must be able to control their dogs for everyone's safety or they will be excused, and no refunds will be provided
- Muzzles fitted, flat buckle collars (no tags) and catch collars are permitted. The dog may run "naked"

- Flexi leads, pinch / prong collars or e-collars are not permitted
- No loose dogs on the property at any time. First off leash offence when its not their turn will be charged a \$10 fine. Second offence will be excused no refunds provided
- Your dog needs a catcher and a releaser. Please ensure the catcher is at the finish
  line and visible to the releaser before bringing the dog to the start. Teams managing
  more than one dog should have a third "runner" handler. Please ask for help during
  rollcall if you have dogs running back-to-back and adjustments can be made to the
  run order within reason.
- Ensure your dog has relieved themselves prior to entering the course and they are warmed up properly before entering the course and cooled down after the sprinter test
- Clean up after your dog and yourself

#### **Event Details:**

- Entire lure area is outdoor in a fully fenced area
- Dogs run once per trial there are 4 trials during the day
- No persons are permitted to walk the track during active competition. If the release enters the track more then 3 meters from the start line, the team will be eliminated
- Give other dogs and handlers room at least 10 feet
- Inspections will start at 8:00 am at the Event Secretary tent (EV). Line up in front of the car beside the EV tent
- First run will be at 8:30 am
- Run order will be posted and available for handlers to see.
- Dogs finishing their event must be caught, leashed, and exit the field before the subsequent dog is permitted to enter the field

# **Earning Points:**

The dog's time to complete the 100-meter dash is converted into kilometers per hour (kph). A handicap system is applied to a dog's kph to determine the number of points earned. The handicap system is based on the height of the dog at its withers:

- o 18" or greater handicap is 1.25
- o 12" up to less than 18" handicap is 1.5
- o Below 12" handicap is 2.0

Points – 360 divided by the dog's time produces the dog's kph which is multiplied by the dog's handicap to result in the number of points earned.

Please be sure to enter the correct height category.

If you are unsure of your dog's height, please measure them.

#### Awards and Titles:

A qualifying ribbon will be awarded to each dog that achieves a score. Ribbons will be distributed after each of the 4 trials. Title ribbons will just be a congratulations on your new title not specific titles. Below are the titles:

- Novice Sprinter (NS) awarded at 150 points
- Sprinter (S) awarded at 500 points
- Advance Sprinter (AS) awarded at 1000 points
- Sprinter Excellent (SX) awarded at 1500 points
- Sprinter Excellent 2 (SE2) awarded at 2000 points
- Sprinter Excellent 3 (SE3) awarded at each additional 500 points from SE2

# **Special Access:**

Pool on site and is available for use by the sprinter competitors. \$20.00 for unlimited use, wrist band will be provided upon payment. Waivers available on site and are to be signed prior to use of the pool.
