The Fun & Purposes of Fun Matches:

The purpose of fun matches is to encourage good behaviors and enthusiasm in a real trial environment. Toys, tugs, clickers, targets are permitted in the ring while you are running. Dogs are also allowed to run at a jump height lower than what they would run in a sanctioned trial. Runs will be times and judged

General Information:

This fun match will run by AAC rules and regulations.

Classes will be offered at Starters, Advanced/Masters at all jump heights.

Courses will be nested therefore the A-frame will be set at 5' for everyone and there will be no broad, double or spread jumps.

Obstacles which will be in use are: A-Frame, Weave Poles, Flexible Tunnel, Collapsible Tunnel, Tire Jump, Single Bar, and Wing Jumps.

The event is being held at the Access Communications Field located on Park and Arcola. Washrooms will be on site. There is also plenty of room for crate, tents, and parking. Spectators are welcome. The event will still run in the rain.
