Hold the instructor(s), organizer(s) and associated parties and the owner or lessor of the premises and any such employees of the aforementioned parties harmless for any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing while in or upon the match premises or grounds or near any entrance thereto. I (we) personally assume all responsibility and liability for any such claim for damages or injury to the dog or property, whether such loss, disappearance, theft, damage or injury, to be caused or alleged to be caused by the negligence of the club or any of the parties afore-mentioned, or by the negligence of any other person, or any other cause. I (we) hereby assume sole responsibility for and agree to indemnify and hold the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves) or an account of damage to property, arising out of or in consequence of my (our) participation in the match, howsoever such injuries, death, or damage to property may be caused by negligence of the aforementioned parties or any of their employees or agents or any other person.
