# **EXHIBITOR INFORMATION and JUDGING SCHEDULE**

#### Location:

Karl's Field, Moose Jaw Exhibition Grounds

#### **Benching:**

There is ample ringside benching. Please bench along the west and north side of the ring (along the tree lines).

Please refrain from walking your dog along the south side of the agility ring.

#### Set up:

The field will be open on Friday May 30<sup>th</sup> from 4pm – 6pm for set up. We will be open at 7am both mornings.

### Move ups & Day of Entries:

Same day move ups will be allowed between each trial.

Day of entries will be allowed if our daily run limit has not been reached.

Both must be done 1 hour prior to the start of the trial or before the courses have been posted.

#### **Lunch Break:**

Lunch break duration will be at the discretion of the judge. The afternoon trials will follow promptly after the lunch break.

A lunchtime BBQ will be offered by MJDC both days.

#### Ring Crew:

Please sign up for ring crew if you are not running a dog in a class or event. Ring crew sign-up sheets will be posted for each class. **We are in need of extra course builders this weekend.** 

#### **On-Site Camping:**

There is a limited amount of *dry* and *serviced* options on-site. You must confirm with the event secretary if you plan on camping on-site.
