Permission has been granted by the Canadian Kennel Club for the holding of this event under CKC Rules and Regulations. To comply with instructions issued by the CKC we will be unable to accept, cancel, alter or substitute any entry reaching our Test Secretary after the closing time and date.

THESE EVENTS HELD UNDER THE RULES OF THE CANADIAN KENNEL CLUB

TEST DETAILS:

- Running order will be determined by a draw; if possible handlers with more than one dog will run in non-consecutive order. Include name of handler on entry form. A running list will be available at the tests.
- A dog that is individually registered in the records of the CKC (or has an ERN or PEN), and has completed the requirements for a WC or WCI may be transferred to the next level provided the request is submitted to the test secretary in writing by 6 pm the day prior to the test.
- Pigeons and/or game birds will be used on land.
- Ducks will be used in water for both the hunt and working certificate tests.
- All qualifying dogs will be awarded a rosette or ribbon.
- Separate entry forms should be completed for each dog and each test entered.
- All handlers in the hunt test must wear dark or camouflage clothing. No white or light clothing is allowed in the working certificate test except in WCX for the blind.
- All dogs must be kept under control at all times.
- Bitches in season may NOT be entered in the WC tests or the Hunt tests. Refunds will be given upon receipt of a veterinarian certificate PRIOR to the test.
- Lunch/Dinner will be available at the headquarters for a nominal fee.
- If you want a confirmation of your entry please provide a valid email address on your entry form.

Post Entries: Entries for Thursday WCI and WCX test: Dogs completing the WC or WCI test may MOVE UP to the next test as long as the request is submitted in writing within 15 minutes after the ribbon presentation for the previous test.

Cheques dated after close of entries will not be accepted. Returned cheques will be assessed a \$40.00 service charge.

Please do not send entries by Registered Mail or Express Post. To comply with instructions issued by the Canadian Kennel Club, we will be unable to accept any entry reaching our Secretary after the closing time and date. Please allow ample time for delays in the mail.

ATTENTION US EXHIBITORS: Personal cheques will be accepted however, they must be payable for the FULL AMOUNT OF THE ENTRY, payable in US funds. Discounted cheques will not be honoured. Do not mark personal cheques payable in Canadian funds or "at par".

Tendering of an NSF cheque in payment of entry fees will be considered nonpayment of entry fees. The owner of a dog entered in this show is entirely responsible for any error in the entering of his dog, regardless of how, or by whom the entry was made.

EVENT REGISTRATION NUMBER FOR FOREIGN DOGS

Effective Jan/1992 all dogs that are foreign-born and foreign-owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an ERN - Event Registration Number. For information on obtaining an ERN, visit the CKC website: <http://www.ckc.ca> At the latest, the ERN must be applied for within 30 days of first day of entering a CKC event.

NON MEMBER PARTICIPATION FEE (section 24-12-3) (April 2011), will be charged to a resident of Canada, who is a non-member of the C.K.C. The non member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. In order of the title to be awarded, the non member will have a choice to: either become a C.K.C. member or pay the non member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. All premium lists will carry a note stating the fee applies only to dogs wholly owned by non member residents of Canada and is not applicable to C.K.C. members. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
