PAYMENT AND CLOSING TIME

Cheques dated after close of entries will not be accepted. **To comply with instructions issued by the Canadian Kennel Club, we will be unable to accept any entry reaching our Show Secretary after the closing date and time. Please allow for ample time for delays in the mail.** Overpayments and duplicate entries will be considered a donation to the SKOC. Thank you!

WITHDRAWAL OF ENTRIES

An Exhibitor has the right to withdraw an entry up to the closing date and time as published in the premium list. This may be done by telephone, however written or e-mail notification must be received by the Show Secretary no later than the official closing date and time. If written notification is not received by that time, the dog will remain entered in the show.

ADDITIONAL PRIZES

HIGH DOUBLE COMBINED HIGH TRIPLE COMBINED

High double combined will consist of the highest combined scores from Advanced B and Excellent B to receive a rosette in each trial.

High triple combined will consist of the highest combined scores from Advanced B, Excellent B and Master to receive a rosette in each trial.

Note: Competitors are responsible to keep track of their scores and present them to the secretary at the end of each trial for verification. Ties will be broken by the fastest combined time.

YOUTH PRIZES

Highest Score 12 years of age and under

Highest Score Ages 13-16

Ties will broken by time.

Note: Competitors are responsible to declare their eligibility.

MAT TIME

Friday evening 5:30 – 8:30pm - \$15.00 per 10 minutes. Sign up by emailing jerri.mcphee@sasktel.net. Mat time MUST be pre-booked and prepaid (via e-transfer) to hold your spot. There will be no refunds for mat time.

DAY-OF-TRIAL ENTRIES

Day-of-trial entries will be accepted both March 18 and 19, 2023. Entries must be made at least 1 hour before the start of the trial. Day-of-trial entries will be cash only.



A service charge of 10% will be assessed. This includes entries sent online or post using a credit card or Interac for payment.

DIRECTIONS

3010 ARLINGTON AVENUE, SASKATOON

The entrance/exit to the Saskatoon Kennel & Obedience Club is located on the north side of the building at 3010 Arlington Avenue along alley/park.

BENCHING

No Benching available at this venue.

ADDITIONAL INFORMATION

- ◆ The scoop-up requirements will be strictly enforced.
- ◆ There will be **NO "In Transit"** area provided. Only dogs entered in official classes are permitted within the precincts of the trial (6.7.2).
- ◆ There will be no "over night" kenneling.
- ◆ Only approved CKC collars will be allowed.
- ◆ SHOWING correct information on the entry form is the responsibility of the entrant. However, Exhibitors incorrectly entered in the "A" class are permitted to move the dog to the corresponding "B" class up to one hour before the start of the trial. The SKOC takes no responsibility for omissions or errors made on the entry forms. The Show Committee reserves the right to refuse any entry subject to the CKC rules.
- ◆ THE PRECINCTS of these trials shall be the training building and paved parking lot at 3010 Arlington Avenue (also referred to as the training building).
- ◆ KNOWLEDGE of the Canadian Kennel Club Rules is the responsibility of the entrant. Rule books may be obtained from the CKC, 200 Ronson Drive, Suite 400, ETOBICOKE ON M9W.
- ◆ The SKOC will use due care and diligence for the welfare of the dogs and exhibitors but will not be responsible for, or assume any liability in the event of an accident or other misfortune, either to dogs, exhibitors or spectators.
- ◆ All dogs must be under complete control at all times.
- ◆ 20.7 It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an obedience or rally trial held under these regulations, is not subject to indignities of any kind. The Trial Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

PLEASE NOTE:

When entering the same dog in multiple classes using a PAPER ENTRY FORM, a separate entry form MUST be filled out for EACH class.

Payment may be made using a credit card (VISA, MasterCard, American Express). Paper entries can only be paid by cash or cheque.

There will be no food or drinks available for purchase.
