### **GENERAL INFORMATION**

**PAYMENT:** Please make all cheques or money orders payable to Forbidden Plateau Obedience Tracking Club. E-transfers may be sent to <a href="mailto:FPOTCPAYMENTTRACKING@Gmail.com">FPOTCPAYMENTTRACKING@Gmail.com</a> (PASSWORD:TRACKING) no sooner than one month prior to test.

A Temporary Competition fee (10.50) as established by The Canadian Kennel Club must accompany the entry of a dog for which a Canadian Kennel Club individual, registration number or Event Registration Number (ERN) is not shown on the entry form.

**The test is limited entry.** We shall be accepting entries by Mail, Email attachment, hand delivery or courier. Entrants will be notified by phone or email that their entry has been received. Entry fees will be returned within 10 days of the day of the test to Alternates who did not participate in the test.

**DRAW FOR ENTRY:** A random drawing of all entries received by the closing date and time will take place to determine placement in the test or on to an Alternate list. The drawing will be at 7:00 p.m. on Friday, April 9, 2021 at the test secretary's residence. 620A Bunting Place Comox.

**CLUB WORKER OPTION:** At the entry draw Two UTD and One UTDX tracks will be reserved as per CKC Rule 6.6.2. "Club Worker" is defined by FPO&TC Policy.

MEETING PLACE AND DRAW: Rendezvous is scheduled for 7:00 a.m. each morning, April 24th and 25<sup>th</sup> 2021 at Home Depot 388 Lerwick RD, Courtenay, BC. where the draw for tracks will take place. Any primary entrant(s) who is absent at this time will forfeit their position to the first Alternate present. Due to Covid-19 restrictions the test secretary will be handling draw items. In Catalogue order, participants will advise the secretary which item they would like, and she will display the corresponding number.

**BITCHES IN SEASON** may compete, however, they will run last. Please advise the Test Secretary upon arrival.

**AWARDS & NO-HOST LUNCHEON**: Due to restrictions, there will be no luncheon held fallowing the tracking test. The Judge will present ribbons to all the successful teams at time of passing. Also, the Club will award keepsake trophies to those same teams.

**REFUNDS**: When an entered dog is withdrawn after the closing date, refunds will **only** be permitted when the vacancy is accepted by an "Alternate". If a position becomes available, Alternates will be contacted in catalogue order and asked to either accept or decline the position. (i.e. if #1 declines #2 will be contacted, etc.)

**COVID-19:** Due to Covid-19 restrictions a gallery will not be permitted during tests. Once you have completed your test you are asked to go home. A "Home Base" will be at the rendezvous site, and participants are asked to keep the required distance while waiting for your turn. Only the Judge, Track layer, Superintendent, dog and handler will be allowed at any given site.

Articles will be carried and scented by the track layer. Extra articles will be kept in a plastic bag. All participants are encouraged to bring a bag for articles and protective gloves if you want to pick up the article after your dog has indicated it. Alternatively, you can leave the article on the ground for the track layer to pick up.

**RULE 14.7:** It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

**Limitation of Liability:** In attending this test, competitors, spectators and guests acknowledge they do so at their own risk and that of any dog. They also agree, upon submitting an entry form, that they will not hold liable the CKC, the FPOTC or its officials, the Judge or the landowner(s) for any loss, damage or injury, however arising, to themselves, their dog(s) or any other chattels.

Exhibitors may not train on the tracking fields (this includes urban areas designated for an urban test) within 14 days of the test.

## Effective January 1, 2011 Non-Member Participation Fee

- \* A non-member participation fee will be charged to a resident of Canada who is a non-member of CKC.
- \* The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- \* In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
- \* All Premium lists will carry a note stating the fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.
