IMPORTANT INFORMATION REGARDING THIS SHOW

PLEASE READ BEFORE ENTERING

RULES REGARDING ATTENDANCE AT AMBERLEA MEADOWS EQUESTRIAN CENTRE

This is our first time at this venue and as such there are some specific rules that we must ask everyone to adhere to:

- 1) All attendants **MUST** remain in the show grounds and parking areas ONLY. No one is allowed in the barns, indoor or outdoor arenas, or paddock areas.
- 2) <u>Stay clear of the animals at all times! NO petting or feeding the horses. DO NOT attempt to interact</u> with them period.
- 3) Parents: You are fully responsible for your children at all times. If they are caught unattended and in violation of the rules in regard to the attendance areas or interacting/feeding horses you will all be expected to leave the grounds immediately with no refund of entries or other fees.
- 4) Waste garbage **MUST** be disposed of in the proper receptacles. NO DUMPING of garbage into the concrete stall bins.
- 5) Blatant violations of these rules will result in bench hearings.

COVID-19:

The Government of Alberta has moved into Stage three of the "Open for Summer Plan", which means that virtually all restrictions have been lifted and all public health orders have been rescinded, with the exception of isolation and quarantine requirements and masking mandates in healthcare settings.

As such the following remains in place:

You are legally required to stay at home and isolate if:

- 1) you are experiencing cough fever, sore throat, shortness of breath, runny nose or loss of taste or sense of smell, that is not related to a pre-existing illness or health condition.
- 2) You have been in contact with a confirmed case of covid-19.
- 3) You have tested positive for covid-19.

Masking at the show is not mandatory with the following exception: If a judge is wearing a mask in the ring, please be respectful and wear your mask as well.

We encourage everyone to be respectful of others and try to social distance and maintain good hygiene practices wherever possible.

Do not gather in large numbers at the ring side. There will be lots of room for everyone to space out and rings and tents will be set up to facilitate social distancing.

Hand sanitizer will be available at the rings and washrooms and we encourage you to bring your own.

Bring masks! If you require a mask and don't bring one, the club will supply one to you for a fee of \$5.00.

By entering these Shows & Trials you are agreeing to the conditions set above and the disclaimer found later in this Premium List. Please read and agree to all the rules we must enforce to be able to hold this show.

RV PARKING

RV parking is limited this year. Good news is we are in a very short vicinity of dog friendly hotels and there
is a very large area for day tenting. We encourage everyone to seriously consider their options when
attending the show. If you are close and have a minimal number of entries, perhaps try not to bring your RV
this year.

RV Parking is Limited to 100 Units

No day of arrival RV spaces, only prepaid and pre-booked sites will be available.

In consideration of the horses who use the Derby Field no vehicles are allowed on the main show site. As this venue is new to us we ask your understanding with regards to the number of RV units we can accept in the area adjacent to the Derby Field and know that it is possible that those arriving late will be a fair distance from the ring area. There is ample room for day tents and if you are bringing an RV you might consider packing a day tent as well. We thank you in advance for accepting all the rules and regulations we must impose in order for us to hold this show. It will be different but ... it will be a show!

As we are uncertain of Alberta Health Services/Government restrictions at the time of this show we ask all our dog friends to respect the rules that may be in place at the time of the show and agree to stand together ... by standing apart

Introducing Our Judges

SANDRA ANDERSON

Sandra Anderson has been a Scottish Terrier fancier since 1968 when the foundation bitch for Chess Kennels was obtained from Tayann Kennels in Brockville, Ontario. In 1979 Sandra judged her first Sanction match in Montreal and was permitted by the Canadian Kennel Club to judge Terriers in 1988 and is now licensed to judge 3 groups and Best in Show. She has judged in Canada, the United States, the Czech Republic, China and Columbia, this has included 10 Specialties for Scottish Terriers.

There have been over 37 Scottish Terrier Champions from Chess Kennels and many specialty winners. Sandra has schooled the Scotties and one Deerhound in obedience and agility. One of her Scotties is now at the excellent level in Rally-O and is active at therapy visitations with that same Scottie. Sandra is a member, past president and show chairman of Rideau Terrier Club, a 35-year member of the Scottish Terrier Club of America, 25-year member of the Canadian Scottish Terrier Club, and a founding member of the Chateaugay Valley Kennel Club. She has given breed presentations to judges groups and mentored for the Scottish Terrier Club of America in New England.

Before the Terriers Sandra bred Weimaraners, which were conformation and obedience trained. She has also owned Scottish Deerhounds, a Wirehaired Fox Terrier and has bred Sealyham Terriers, Lakeland Terriers and Weimaraners. Sandra taught obedience for a 4-H program in New York for several years. Sandra is a trained floral designer and dressmaker and is currently the owner of a grooming business.

DEL BEAULAC

My career in dogs began in the late 80's when I purchased my first purebred dog; a Belgian Shepherd.

In 2005 Penny bought her first Whippet Gr. Can BISS MBIS Ch. Brushwoods She B Smokin and went on to be an Owner Handler to many Best In Show Awards and Top Whippet In Canada many years in a row. Penny became a Breeder Owner Handler in 2007 of Bretica Whippets with multi Best in Show and Specialty Winners in Canada, and USA; breeder-Owner of Canada's Top All Breed Puppy in 2014; Best Of Winners winner in 2014 at the American Whippet National, and bred and owned Americas Top Whippet Brood Bitch for 2019. To name a few of the memorial wins as a Breeder Owner Handler.

Penny has owned Whippets, Dobermans, Pomeranians, English Setter, Miniature Long Haired Dachshunds, Pointer, Alaskan Malamute, and Rottweiler.

Instructor of Penny's Conformation Bootcamps for many years and enjoyed every minute of teaching people to show their own dogs.

JAMES REYNOLDS

Mr. Reynolds has been involved in the sport of dogs since 1956. As a breeder he was most involved with Scottish Terriers and his Renaldo kennel owned or bred over 30 Canadian and 15 American champions many of whom were Best in Show Winners. He began judging in 1967 at the Ottawa Kennel Club show for Canada's centennial year and became an all-breed judge in the early seventies. He judges all breeds in Canada and has been permitted to judge all breeds by the AKC in the United States. His assignments have been on five continents and have included judging Best in Show at some of the most prestigious clubs including Best in Show at Westminster in 2006, Best in show at the anniversary show of the Ladies Kennel Association in England and Best in Show at Australia's largest show "The Melbourne Royal". He has also officiated at World Shows in Switzerland and Germany as well as the Pacific International in Tokyo. He has had the great good fortune to officiate at over 70 national breed specialties in the U.S.A. During 2019 he judged for the 15th time at Westminster and officiated at the Yorkshire Terrier Club of America national and the Rhodesian Ridgeback Club of America national in 2018. He has judged many Scottish Terrier specialties including the American national in the late 1980's. (Mr. Reynolds is also judging the Alberta Lure Coursing Association Specialty, the Bullmastiff Fanciers Specialty and the Canadian Scottish Terrier Club Specialty at this show)

WILLIAM and JUDI BYRNE

CONFORMATION

The following CKC conformation classes (divided by sex) will be offered:

Junior Puppy: for dogs 6 mths of age but under 9 mths of age. Senior Puppy: for dogs 9 mths of age but under 12 mths of age 12-18 Months: for dogs 12 mths of age and under 18 mths of age

Canadian Bred: for dogs born in Canada; champions in any country excluded.

Bred by Exhibitor: for dogs owned and handled in the ring by the breeder.

Open: for all dogs.

Specials Only: dogs which are registered individually in the records of the Canadian Kennel Club and have attained championship status may be entered in the 'Specials Only' class, Exhibition Only; for all dogs over 6 mths of age and eligible for registration with the CKC (non-competitive class).

Baby Puppy (4-6 Mths): offered Friday, Saturday, Sunday. For dogs 4 mths of age & under 6 mths of age - dogs will compete in this unofficial class for Best Male/Best Female, Best Baby Puppy in Breed, Group & Show. They do not compete for Winners.

Exhibition Only: dogs entered in this class may NOT compete in any regular class but may enter and compete in Non-Regular classes or parades.

Exhibition Only 4-6 Months: for dogs 4 months & under 6 months whose owner has also entered a dog in one of the regular official classes.

OBEDIENCE

Pre-Novice: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has not earned the title PCD (Pre Companion Dog) title in Canada. Only dogs that have NOT earned the CD title may enter Pre-Novice.

Novice A: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has not won the title of CD. Only one dog may be entered in this class by any one exhibitor. The handler in this class must be the owner, co-owner or a member of their immediate families.

Novice B: for any dog of any recognized or listed breed, mixed breed or unrecognized breed has not won the title of CD. Dogs in this class may be handled by any person. More than one dog may be entered by any handler, but each dog must have a separate handler for the 'sit' and 'down' exercise. Novice C: for any dog of any recognized or listed breed, mixed breed or unrecognized breed has gained a CD or any higher obedience titles.

Novice Intermediate: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned a CD or higher obedience title. Dogs may compete in the Novice Intermediate class indefinitely. Scores earned by dogs competing in this class are NOT eligible for High in Trial.

Open HA & 18A: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has won the title of CD but has not won the title of CDX. The handler of any dog in these classes must be the owner, co-owner or a member of their immediate families. Only one dog may be entered in this class by any one exhibitor.

Open HB & 18B: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has won the title of CD and any dog that has earned the CDX or any higher obedience titles may enter either of the Open B classes. A dog may also be entered in the Utility class in the same trial. Dogs in this class may be handled by any person.

Utility A: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has won the title of CDX but not the UD. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. Handlers may enter more than one dog in this class. The same person must handle the dog in all exercises.

Utility B: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title of CDX or UD. Dogs in this class may be handled by the owner or any other person. Owners may enter more than one dog in this class but the same person must handle the dog in all exercises. No dog may be entered in both the Utility A and Utility B classes at any one trial.

Rally Novice A: dogs entered in this class may not have earned a CKC Rally Novice title or any CKC Novice Obedience title other than PCD.

Rally Novice B: Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. No dog may be entered in Rally Novice A and Rally Novice B at any one trial.

Rally Intermediate: for dogs that have earned the RN title. A dog completing the RI or any other obedience or rally titles may continue to compete in this class indefinitely. Dog handled by owner or any other person. A person may enter more than one dog in this class.

Rally Advanced A: for dogs that have earned the RN title but have not won the Rally Advanced title or any CKC Obedience title other than PCD. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class.

Rally Advanced B: for dogs that have earned the RN title. A dog completing the RA title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class.

Rally Excellent A: for dogs that have earned the RA title but have not won the RE title or any CKC Obedience title other than PCD.

Rally Excellent B: for dogs that have earned the RA title. A dog completing the RE title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Rally Master: for dogs that have earned the RE title. A dog completing the RM title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

SECTION 15.1.2

The schedule to be employed in the determination of the number points awarded WINNERS shall be as follows:

*includes the dog awarded Winners

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points.

SECTION 15.1.8

In addition to championship points allocated at the breed level, a dog awarded WINNERS which also places in the regular Group competition shall be credited with the following additional points provided a dog was defeated at the group level.

Section 15.1.12

In order for a dog to be recognized as a Champion and its owner provided with a Championship certificate, the dog must:

- a) earn at least ten (10) championship points under at least three different judges and.
- b) be individually registered in the records of the CKC or have an Event Registration Number or a Miscellaneous Certification Number.
- c) have earned at least one 2-point win either at the breed or group level.

15.2 GRAND CHAMPION

The title of Grand Champion may be earned after the completion of the CKC conformation championship. Points earned in completing the conformation championship are not included in the Grand Championship.

Section 15.2.3

To be awarded a Grand Champion title, a dog must attain a minimum of 20 points, which must include a minimum of two (2) wins of at least two (2) points each. Points may be gained at breed, group or Best in Show/Specialty level. Only the highest points earned at a single show are carried forward.

a. Grand Champion Point System

Points towards the Grand Champion title are attained at breed level and are awarded to BB, BOS, Select Dog & Select Bitch. Points are calculated based on the number of animals competing at the breed level for the Best of Breed winner and the number of similar-sex dogs competing for the other three (Best of Opposite, Select Dog, Select Bitch). The following schedule shall be employed in the determination of points awarded at breed level for all levels of GCh.:

- c. In order to obtain a Grand Champion title, a dog must obtain at least two (2) points after 12 months of age.
- d. In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points.

15.2.4 GRAND CHAMPION BRONZE (GChB)

The title of Grand Champion Bronze may only be earned after the completion of the CKC conformation title Grand Champion is attained.

- a. Points for this title are only accumulated after the completion of the Grand Championship and do not include the points earned in attaining the Grand championship.
- b. To be awarded a Grand Champion Bronze title, a dog must attain a minimum of 50 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best in Show/Specialty level. Only the highest points earned at a single show are carried forward.
- Points accumulated prior to July 1, 2021 may be used to attain the GChB title, however, a minimum of five (5) points must be earned after July 1, 2021.

15.2.5 GRAND CHAMPION SILVER (GChS)

- a. The title of Grand Champion Silver may only be earned after the completion of the CKC conformation title Grand Champion Bronze is attained and do not include the points earned in attaining the Grand Championship Bronze.
- b. To be awarded a Grand Champion Silver title, a dog must attain a minimum of 100 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best in Show/Specialty level. Only the highest points earned at a single show are carried forward.

15.2.6 GRAND CHAMPION GOLD (GChG)

- a. The title of Grand Champion Gold may only be earned after the completion of the CKC conformation title Grand Champion Silver is attained and do not include the points earned in attaining the Grand Championship Silver.
- b. To be awarded a Grand Champion Gold title, a dog must attain a minimum of 200 points, which must include a minimum of two wins of at least two (2) points each.

 Points must be gained at breed, group or Best in Show/Specialty level. Only the highest points earned at a single show are carried forward.

15.3 GRAND CHAMPION EXCELLENT (GCh.Ex)

15.3.1 The title of Grand Champion Excellent may only be earned after the completion of the CKC Grand Champion Silver title. Exhibitors will be required to submit to Shows & Trials the Grand Champion Excellent Record Sheet documenting the additional requirements. The Grand Champion Excellent Record Sheet Form is located on the CKC website. the points earned in attaining the Grand Championship Silver.

15.3.2 To earn the title a dog must have earned the following during their career as a Special:

- a. one (1) Best in Show or a Best of Breed at a breed National specialty (where a minimum of 10 dogs have competed).
- b. three (3) Group 1st, or three (3) breed specialty Best of Breed wins.
- c. a CKC performance title from any CKC event. Titles excluded are: CGN, Herding Novice Tested Certificate, all Instinct titles from all events, as well as all Sprinter titles and all Chase Ability Program titles.
- 15.3.3 Best in Show, Best of Breed at a National Specialty, 3 Group wins, or 3 Specialty Best of Breed wins, must be attained after the completion of a regular championship. The performance Title may be attained at any time in the dog's career.

NOTE:

- Exhibitors are required to complete the Grand Champion Excellent Record Sheet form located on the CKC website and forward it to CKC upon completion of requirements above.
- 2. Grandfathering of the previous version of the Grand Champion Excellent title will be honored up until July 1, 2022.

RULES GOVERNING THESE SHOWS

- Dogs must be kept on a leash at all times while on Amberlea property and must not be walked near horses.
- There shall be no interaction with the horses by anyone, at any time!
- Benching in designated areas only no benching out of your vehicles or on roadsides.
- The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of these shows and trials, which will be governed by CKC rules.
- ANYONE PARKING IN THE FIRE LANES OR OTHER AREAS DESIGNATED AS "OFF LIMITS" WILL BE REMOVED FROM THE SHOW WITHOUT REFUND OF ENTRIES OR FEES.
- All recreational units must have buckets underneath for their drains. Those discharging of any water on the grounds will be removed by order of the health department and subject to a fine.
- A judge officiating at this show held under CKC rules shall not be subjected to any indignities of any kind during the progress of the show. (4.7.1)
- A show-giving club will be held responsible during the show for the conduct of exhibitors and spectators. Any person acting in an abusive or objectionable manner must be removed from the show on complaint to the Show Superintendent (5.1.6)
- There is to be NO SMOKING in the ring area.
- Dogs must be on the show grounds 1 hour prior to judging of their breed.
- If you must leave the grounds, dogs in your care must be moved inside. DOGS MAY NOT BE LEFT UNATTNDED IN ANY OUTDOOR ENCLOSURE. FAILURE TO COMPLY may result in excusal from the show.
- If because of riot, civil disturbance or other acts beyond the control of the Northern Alberta Canine Association, it is impossible to open or to complete the show, no refund of entry fees will be made.
- The welfare of an exhibitor's child is the responsibility of the exhibitor. It should be understood that exhibitors will exercise control and restraint over their children. The Northern Alberta Canine Association will not be responsible for injury to any child whether by accident or any other cause.
- All vehicles are left on Amberlea property at your own risk. No security is provided.
- All day parking, RV parking, tent benching must be vacated within 1 hour following Best in Show on September 12th.
- No abuse of parking personnel, NACA members or volunteers will be tolerated!! Anyone found behaving rudely or abusing our volunteers will be removed from the show with no refund of entries or fees.

ENTRY AGREEMENT

In consideration of the acceptance of entries made in these all-breed shows, obedience trials, agility trials or any of the associated Specialties, and of the holding of these shows and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold the Northern Alberta Canine Association and associated Specialty Clubs, their members, volunteers, directors, governors, officers, agents, superintendents, or show secretaries, and the owner or lessor of the premises Amberlea Stables Ltd. operating as Amberlea Meadows Equestrian Centre and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim.

I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club(s) or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in these shows and trials, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
