This test is held under the rules of The Canadian Kennel Club 200 Ronson Drive, Suite 400 Etobicoke, ON M9W 5Z9 Entries will close once the trial limit has been reached, even if the closing date has not arrived. Additional entries will be assigned a position on an 'Alternate List' in the order received. The Test Secretary will notify all entrants of their acceptance into the trial or their position on the Alternate List by email (*preferred*) or phone as entries are received. If entries do not fill in the levels offered, the tests may be interchanged as per CKC rules.

U.S. Exhibitors please pay by bank or postal money order in **Canadian funds ONLY**, do not mark U.S. cheques "payable in Canadian Funds" or "at par", they will not be accepted.

Entries must be mailed to the postal address of the Test Secretary. Payment must accompany each entry. Faxed, emailed, or hand delivered entries will be rejected. Each entry MUST be sent in a separate mailing envelope.

An NSF cheque will be subject to a \$20.00 service charge. The Entry fee plus the NSF service charge must be paid *in cash* prior to test.

Any overpayment of entry fees will be considered an Awards Donation.

Awards

Rosette - offered for passing teams at the completion of the test each day.

A digital picture suitable for photo printing will be sent to each successful exhibitor via email, free of charge.

Notice To All Canadian Residents Only: New CKC Rule Section 24-12-3. Non-member participation fee

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.

A TD title is a prerequisite for entering a TDX test. Certification is NOT required to enter a Canadian TD test. A dog eligible for a PEN number may not enter as a listed dog but must have their PEN number prior to entering the test.

INDIGNITIES: Section 14.7 Tracking Rules: "It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind." The Tracking Test Chair shall promptly report to the CKC any infringement of this regulation".

MEETING PLACE AND DRAW FOR TRACK ORDER

The Draw will be held each day at the **Fifty-Niner Restaurant**, Hwy 59 & Dunning Rd. A map will be sent to all exhibitors. Arrive early for breakfast!

Draw for tracks each day will be at 9:00 a.m. Caravan to first track at about 9:15 am.

Any primary entrant who is absent at the assigned draw time will forfeit his/her position to the first Alternate present. Please be sure to arrive on time for your draw.

ALTERNATES

Alternates are encouraged to attend the draw in case there is a withdrawal or noshow of a confirmed entrant. Should someone withdraw at any time prior to closing, alternates will be informed in order of their rank on the Alternate List as soon as possible, to allow them time to prepare for the trial.

SPECTATORS & TEST SITE RULES

Spectators are welcome and encouraged to attend! Be at the draw each morning for directions to the tracking sites. A Club Official will be present to advise spectators where to observe the tests. Spectators AND entrants will be directed to parking and "off track" areas, PLEASE be co-operative and respectful of the sites.

NO OFF LEAD DOGS ALLOWED, AND CLEANUP IS MANDATORY!!

BITCHES IN SEASON

Bitches in season may compete, however they will run the first or last track at the judge's discretion. Please advise the Test Secretary immediately upon arrival at the meeting place, or earlier if possible.
