JUDGING SCHEDULE:

All competitors are responsible for having their dog ready for their run.

Rally judging is based on the formula of 15 dogs per hour. Exhibitors should remember that there could be move-ups or absentees when calculating their judging time. Please inform the table steward if there is a possible conflict with handling multiple dogs in the same class or adjacent classes.

Lunch will be taken at the judge's discretion and posted at ringside.

Judges Briefing and Walk through for Advanced classes Trial 1 (Ring 4) will follow immediately after completion of Intermediate class Trial 2.

Advanced classes trial 2 (Ring 5) judges briefing and walk through will follow immediately after completion of Advanced classes Trial 1.

Judges Briefing and Walk through for Excellent classes Trial 1 (Ring 4) will follow immediately after completion of Advanced class Trial 2.

Excellent classes trial 2 (Ring 5) judges briefing and walk through will follow immediately after completion of Excellent classes Trial 1.

Judges Briefing and Walk through for Master class Trial 1 (Ring 4) will follow immediately after completion of Excellent class Trial 2.

Master class trial 2 (Ring 5) judges briefing and walk through will follow immediately after completion of Master class Trial 1.

Please note that classes with an A and B category may be run together at the judge's discretion.

GENERAL INFORMATION:

There is a private residence at the front of our property. PLEASE respect this and proceed slowly down the long driveway. 10 kph limit!

Check in is at the main entrance Registration desk when you arrive. Staff will be available to assist you if needed. Course maps will be available at check in.

ALL shoes MUST be changed to clean indoor shoes and dog paws cleaned/dried off in the entrance area of the facility.

There is no access to food or drinking water at this event. Please bring water for you and your dog.

There is space available for crating indoors at the Red Barn on a first come, first served basis. You are also welcome to crate from your vehicle, but we cannot allow your dog to bark constantly while in your car. All dogs must be crated or on leash when not in the ring (x-pens are allowed).

Handlers are responsible to keep their dogs quiet at all times, clean up after their dogs and exercise them in appropriate areas only. There will be containers to dispose of dog waste, but we ask that you take your other garbage home with you.

Any dog engaging in aggressive behavior at any time will be required to leave the trial grounds without refund.



NEW TITLE ROSETTES:

New title rosettes will be offered for \$10.00 on day of trial only (exact change please).

CKC has a Non-Member Participation Fee of \$170.00+ HST. This fee only applies to dogs wholly owned by nonmember residents of Canada and is not applicable to CKC members. In order for a title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.



<u>Directions to The Red Barn Event Centre</u>: 8464 County Road 27, Barrie, ON L4N 9C4

From the 400 Southbound: Take the Essa Road exit 90. Turn west on Essa (sign says Essa Road South). Turn right at Ardagh Road. Follow Ardagh to County Road 27. Go South on County Road 27 (aka Town Line Road). Property is on the west side of the road down a long driveway. There is a private residence at the front of the property.

From the 400 Northbound: Take the Innisfil Beach Rd exit 85. Turn west at the lights onto Innisfil Beach Rd. and continue to CR 27 in Thornton (the road will end). Turn right onto CR 27 and head north for 3.2km, then turn left to stay on CR 27 (the sign is small). Look for the 20th Sideroad on your left and then McKay Road on your right, that's your cue to slow down. Continue north on CR27. After passing Mapleview Dr. W. you will go down a big hill, the Red Barn is on your left at the bottom of the hill. Property is on the west side of the road down a long driveway. There is a private residence at the front of the property.
