Show precincts shall consist of 30 feet in all directions of the ring area.
Ring is 100 feet by 100 feet, grass surface, fully fenced
Obstacles shall meet the specifications in the CKC Agility Rules and Regulations effective January 1, 2017.

Moving Up: Dogs may move up on the day of the trial prior to the commencement of each trial.

No electronic timers.

Effective January 1st, 2017:

- A non-member participation fee will be charged to a resident of Canada who is a non-member of CKC. The fee will be \$58.50 plus applicable taxes.
- The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot move up to the next level.
- The fee only applies to dog wholly owned by non-member residents.

Attention Foreign Exhibitors

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted however they are to be payable in Canadian Funds. Your understanding and co-operation is appreciated. **Thank you.**

Eligibility: To be eligible to compete in an agility trial, the dog must be registered with the CKC, be eligible for registration with the CKC, have an ERN, or have a CKC Miscellaneous Certificate number. A dog may be spayed, neutered or debarked.

Bitches in Season are not permitted to compete. The judge of an agility trial must remove from competition any bitch in season, or any bitch which appears so attractive to males as to be a disturbing element. When a bitch comes into season after entry of the bitch has been submitted to the trial Secretary and a Veterinarian's certificate that the bitch was in season within the ten day period preceding the trial, the Trial giving club will refund entry, service charges and listing fees.

Exhibitor information: Exhibitors, through submission of entry, acknowledge that they are knowledgeable of and will comply with the CKC Agility Rules and Regulations Effective January 2010. A copy of which may be obtained by calling the Central Order Desk of CKC at 1-800-250-8040

Agility Rules & Regulations

4.1.3: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.

Notice to all Foreign Exhibitors from the Canadian Kennel Club
Event Registration Number (ERN)

To obtain an ERN simply do the following:

- Send a photocopy of the dog's Registration Certificate reflecting current ownership with a written request for an ERN number.
- Please indicate coat type and size, if applicable
- Fee for an Event Registration Number with the CKC is \$55.00 Include your payment in the full amount in Canadian Funds.
- Payment may be paid with VISA or MasterCard, personal or business cheques, or money order. For Non-members please note that if paying by cheque, the cheque must be certified. Non-residents of Canada please note that discounted cheques or money orders will not be accepted due to fluctuating currency rates
- Provide us with your full return address.
- Faxed requests will be accepted. Please ensure that your VISA or MasterCard number is legible and you have included your expiry date and signature.

An ERN must be obtained within thirty (30) days of obtaining points, awards or scores to avoid cancellation. If factors beyond your control prohibit this or present a problem, please send a written request for a 30 day extension.
