BITCHES IN SEASON

If a bitch entered in the Obedience Trials comes into season after the closing date, please notify the Trial Secretary. We will refund all entry fees and listing fees if we are in receipt of a Veterinarian's Certificate stating that the bitch was in season within the 10 day period preceding the trial. This certificate must be delivered to or reach the Trial Secretary on or before the date of the trial.

OBEDIENCE TRIAL RULES AND REGULATIONS

The Exhibitor is responsible for knowing and complying with the Obedience Rules and Regulations of the Canadian Kennel Club.

Chapter 19 - Section 19.7 of the Obedience Rules and Regulations states: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience Trial held under these regulations, is not subject to indignities of any kind. The Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

EVENT REGISTRATION FEE

Effective Jan. 1/92, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an Event Registration Number (ERN).

The ERN number MUST be applied for within 30 days of the first day of entering a CKC event.

OBEDIENCE TRIALS TROPHY LIST

Through the generosity of members and friends, a Trophy and Rosette will be awarded for HIGH IN TRIAL in each trial.

A Rosette will be awarded for 1st to 4th place in each class.

The following awards are for German Shepherd Dogs only.

A Trophy and Rosette will be awarded to the German Shepherd Dog with HIGH COMBINED SCORE (Open B and Utility) in each trial. A Prize and a Rosette will be awarded to the HIGHEST SCORING VETERAN German Shepherd Dog in each trial.

THE TERRY SMITH MEMORIAL TROPHY

to be awarded to the Highest Scoring German Shepherd Dog (of the day) with a Tracking Title. Titles that will be eligible for this trophy are the following: TD, TDX, UTD, UTDX, SchH1, 2 or 3, TR1, 2 or 3.

A Rosette will be awarded to the top Junior Handler in the regular classes in obedience.

A special award will be presented to any dog finishing its Obedience title at these trials.

Awards will be given for qualifying scores only and must be picked up the day of the Show and Trial. No awards will be mailed. Eligibility for awards must be registered with the ring steward.

NON-MEMBER PARTICIPATION FEE

Effective January 1, 2011:

- a) A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC. The fee will be \$59.40 plus applicable taxes.
- b) The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- c) In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
- d) The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

MOVING UP

A dog that is registered in the records of the CKC or has a PEN, an ERN or a Miscellaneous Class Number (MCN) and has fulfilled the requirements for a title in accordance with these rules, may be moved to the next level of competition. The transfer must be submitted to the trial secretary on the appropriate move-up form by the owner or handler, one hour before the opening of the first trial on the day, schedule permitting.

CATALOGUES

Catalogues are available on a pre-order basis at a price of \$3.00 by indicating this on the entry form. Your catalogue will be waiting for you at the show. There will be a limited number of catalogues available for sale at the show for a price of \$5.00.

ENTRY INFORMATION

1. No entry will be accepted unless all particulars called for on the entry form are completed in full. Handlers or agents please note the full name and address of all owners must be filled in.
2. Incomplete entries will be returned. No entry will be accepted unless accompanied by entry fees. Telephone and telegraph entries cannot be accepted. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made.
3. There is no refund for duplicate cheques. Every effort will be made to find all duplicate entries, however if the entry has been processed and appears in the official catalogue, no refund will be made.
4. Substitutions or cancellations of any entry after the closing date is prohibited. The committee reserves the right to refuse any entry subject to CKC Rules.
5. **ENTRIES POSITIVELY CLOSE 8:00 P.M.TUESDAY MAY 5, 2015 or when the limit is reached** and must be in the hands of the Show Secretary by that date.
6. **LIMITED ENTRY:** Entry in each trial will be limited to the capacity of the judge to perform 7 hours of judging at the rate of 9 Pre-Novice dogs per hour, 8 Novice dogs per hour, 7 Open dogs per hour, and 6 Utility dogs per hour. Once a judge has reached his/her capacity, entries for that trial will be closed even if the closing date has not been reached. In the case of the entry limit having been reached, remaining entries will be assigned a position (by class) on a reserve list. Exhibitors will be notified of their position on the reserve list. If the entry of a bitch in season is pulled after the closing of entries, it may be substituted with one from the reserve list up to and including the day of the trial.
7. Identification cards and judging schedules will be mailed as soon as possible after the entries close. Identification cards must be presented upon arrival at the trial.
8. Tendering of NSF cheques in payment of fees shall be considered non-payment of fees and is punishable by disciplinary action. Any N.S.F. cheques will be subject to a \$25.00 service charge.

GENERAL INFORMATION

1. The Show Superintendent will be in full charge of the shows and trials which will be governed by CKC Rules.
2. The German Shepherd Dog Club of London will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons.
3. There is no refund for duplicate cheques. Every effort will be made to find all duplicate entries, however if the entry has been processed and appears in the official catalogue, no refund will be made.
4. If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to open or to complete the show or trials, no refund of Entry will be made.
5. Dogs should arrive in adequate time for their breed judging (allowing for absentees) and will be excused when not required for further judging. It is the responsibility of the exhibitors to have the dog at ringside when the dog's class is scheduled for judging.
6. Judging will commence at 9 a.m. Saturday May 16, 2015. A later starting time may be specified in the judging schedule. Starting time for both conformation and obedience will be specified in the judging schedule.
7. **No pinch collars will be permitted within the precincts of the Show and Trials.** *No cover will be provided in case of inclement weather.* **SHOW PRECINCTS:** *The Show precincts shall consist of all areas set out for rings, all shelters or facilities set aside for show officials, judges or exhibitors and handlers and 30 feet outside of the judging rings.*

DIRECTIONS

From Toronto:

Take the 401 West to Hwy 6 North (the second Hwy 6 exit). At the first set of lights turn left (Wellington Rd 34). Follow this road and at the roundabout take County Rd 35 and turn left. You will cross the 401. Turn left on to the first road - Concession 2 - there is a sign for Paddock Corners. Turn left into the first driveway. Look for fire signs 2926 or 6924.

From London:

Take the 401 east to Townline Rd (exit 286). Once you come off the 401, you will come to a set of lights. Turn right at these lights and then left at the next set of lights. You will be on Lake Rd. Follow this road until you come to a stop sign (there will be a small lake on your right). Keep right at the stop sign and the road turns into Concession 2. You will come to another stop sign (county Rd 35). Go straight through the stop sign and turn left into the first driveway. If you come to sideroad 20, you missed the driveway.

From the North:

Take the Hanlon Expressway (Hwy6) south to Downey Rd (the YMCA is on the corner). Turn right and follow this road out of Guelph and into the country. Go straight through the roundabout. Cross the 401, turn left at the first road (Concession 2). There is a sign for Paddock Corners. Turn left into the first driveway. The green fire signs are 6926 or 6924. If you come to sideroad 20, you have missed the driveway.

From the South:

Take Hwy 6 towards Guelph. This highway goes from 4 lanes to 2. You will go over a railroad bridge. Look for the sign for Leslie road and turn left (if you go into the little town of Morriston, you missed it). Follow this road to Side Road 20 and turn right. Sideroad 20 dead ends at Concession 2. Turn left. We are the 5th or 6th property on the right. Look for fire signs 6926 or 6924. If you come to the stop sign at County Rd 35, you missed it.
