No Entry can be accepted unless and until all particulars called for on the entry form are completed thereon, and accompanied by the Signed Waiver and full Entry Fee.

No FAX, telephone or electronic entries will be accepted.

Incomplete entries cannot be accepted and may be returned to the Exhibitor.

TCN-Temporary Competition Numbers

If a dog is not registered individually in the records of the CKC, it may be entered at a trial held under these rules with a Temporary Competition Number (TCN), providing that the number is obtained before the closing date of entries. Once the dog is permanently registered or has an ERN, the TCN will no longer be valid. TCN's can be obtained online through the CKC Member Portal. Exhibitors may also obtain a TCN by completing a printed application and submitting it to the CKC by mail, or by contacting the Shows and Trials Division at 1-888-364-7252.

Due to restrictions on the size of the gathering allowed under the COVID protocols, there has been a change to the volunteer policy. **All Exhibitors are required to help out a minimum of four (4) times a day.** We cannot have non-Exhibitor course helpers unless we further reduce the number of people permitted to enter and participate in order to meet the overall limit on size of the gathering.

Day-of-Trial Entries: If the schedule permits, Day of Trial entry will be available. Entries with full payment in accordance with the fee schedule must be delivered to the Trial Secretary *at least one (1) hour* before the start of the First Trial of the day.

Move-ups: A dog that fulfills the requirements for a title in accordance with the rules during the first Trial of the day, may be moved to the next level of competition for the next Trial, if the schedule permits. The transfer must be on the appropriate move-up form and submitted to the Trial Secretary by the owner or handler.

NSF Cheques: Tendering of a dishonoured cheque for entry fees shall be considered non-payment of entry fees, and is an offence punishable by disciplinary action and cancellation of awards. In addition, a \$40.00 service charge will be levied by the Club.

Refunds: No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical condition are not eligible for a refund.

LIMITED ENTRY means entries will close on the listed closing time or when the entry reaches 120 runs per event day. *When the advertised limit has been reached, all remaining entries may be assigned a position (by class) on the reserve list. Fees will not be refunded for any reason other than a bitch being in season and to those on the reserve list who did not participate in the trial.* The number of entries and/or exhibitors in any or all classes and/or levels and/or trials may be further limited due to COVID protocols.

New Title Rosettes – The Poodle Club of Canada is pleased to offer a rosette for each dog completing the requirements for an Agility Title at these events.

Please bring an envelope with your name, the dog's name and list the classes and height division you are entered in. When you have earned a ribbon please bring the envelope for us to put the ribbon in the envelope.

CKC REGULATIONS

It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Notice to Competitors-Special Information regarding COVID-19 Safety Measures/Rules.

Due to ongoing concerns with the coronavirus disease, we are asking for your cooperation to limit the possible spread of the disease, and ensure an environment which is safe and comfortable for all participants.

Please do not participate if you answer “YES” to any of the following in the 14 days prior to the trial:

- Are you experiencing any fever, cough, or have difficulty breathing?
- Have you returned from the USA or other international destinations?
- Have you been contact traced to a COVID-19 case?
- Have you had close contact with a person with acute respiratory illness who has been outside Canada?

Special Measures and Instructions:

- Face Masks/Face Coverings are required when on the property, including entering and exiting the ring, but may be removed during your run. Your cooperation and understanding are appreciated.
- Please park so social distancing is adhered to.
- **To adhere to Provincial limits on gathering size, you may not bring friends, children, spouses or others.**
- Course maps and the running order will be posted outside the building, feel free to take a picture with your phone as no paper maps will be available.
- All briefings will be done in the ring, social distancing, face mask/face coverings are required.
- All walk-throughs will be limited, masks or face coverings must be worn.
- Ribbons are not self-serve, please bring an envelope with your dog’s name, classes entered and height and we will make every effort to have ribbons available as quickly as possible.

Health, Sanitization & Trial Workers:

- The rest room attached to the garage will be the only facility available to competitors on an as necessary basis.
- We will have a team member cleaning all “touch” areas during the day
- Paper towels, soap, and hand sanitizer is available throughout the facility.
- Disposable gloves will be provided for course building and ring crew.
- There will be no leash runner, please bring a leash small enough to put in your pocket.

The **Ontario Ministry of Health** recommends these everyday steps to reduce exposure to the virus and protect your health:

- Washing your hands often with soap and water for at least 20 seconds; or use an alcohol-based sanitizer if soap and water not available, but do not overuse to avoid skin damage.
- Cough and sneeze into a tissue and dispose of it immediately. If a tissue is not available, cough or sneeze into your sleeve and not your hands.
- Try not to touch your eyes, nose or mouth.
- Avoid contact with people who are sick.
- Stay at home if you are sick.

The **Ontario Ministry of Health** also recommends that everyone in Ontario should do their best to avoid close contact with people outside of their immediate families. Close contact includes being within two (2) metres of another person. To avoid this, practicing Physical Distancing by being more than two (2) metres from another person is recommended whenever possible.

By signing the waiver you agree to abide by the rules/safety measures.

GENERAL INFORMATION

- The **trial precincts** shall consist of the agility course, parking lot, non-residential buildings and their surrounding areas.
- E-Timers will be used.
- Food and toys are not permitted in the course area or within 10' of the ring gates, and handlers are not permitted to use whistles, clickers, flexi's or other instruments or devices within 30' of the ring. Ring gates are available to be closed on request.
- Contact familiarization will be available to Novice dogs before the first Standard course of each day.
- The Trial Secretary and Show Superintendent are in full charge of the Trials.
- The Poodle Club of Canada and The Poodle Farm will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors, patrons or their property.
- Flexi-leads may not be used on The Poodle Farm property.
- No smoking, vaping or cannabis use is permitted on The Poodle Farm property.
- PLEASE STOOP TO SCOOP! Anyone not picking up after their dog *anywhere* on The Poodle Farm property will be asked to leave the event with no refund.

SITE INFO

- There is no shade for vehicles.
- Pop-up tents are permitted on grassy areas and may be used for dogs provided the dogs are quiet and securely contained in crates/X-pens. All shade structures must be spaced to permit physical distancing.
- No special area will be designated for reactive dogs.

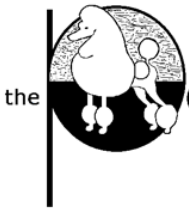
