This is a flat, grassed park area.

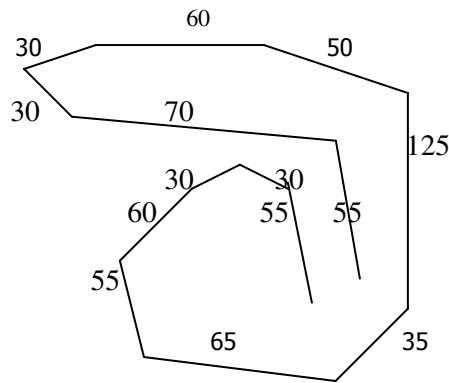
**DIRECTIONS TO FIELD:**

From Hwy #1 take Exit #87 (Clearbrook Road) and proceed north. Follow Clearbrook Rd. for approximately 3.3. km. You will pass Clearbrook Elementary School on your right and the park entrance is to the right immediately after the school, just before the road sharply curves to the left.

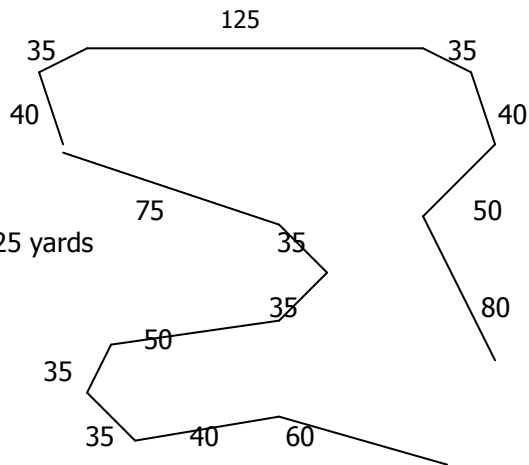
From the USA, From I-5, take Exit #256 in Bellingham, (Hwy.539 – Guide Meridian Road), proceed north and cross the border at Lynden/Aldergrove. Stay on this road (264<sup>th</sup> St/Route 13) for approx. 5 miles to Hwy. #1. Go east and follow directions as above.

### **ELIGIBLE ENTRY:**

For any Afghan Hound, Basenji, Borzoi, Scottish Deerhound, Greyhound, Ibizan Hound, Italian Greyhound, Pharaoh Hound, Saluki, Whippet, or Irish Wolfhound that is one year of age or older on the date of the trial. All entrants must be registered, or eligible for registration, with the Canadian Kennel Club. Hounds presently disqualified under CKC, AKC or ASFA coursing rules are ineligible.

### **STAKES OFFERED:**

OPEN: for all hounds including Field Champions.  
MIXED: for multiple breeds with entries of three or less, upon owners' agreement  
SINGLES: for any hound that is one year of age or older, not entered in the official trial. Will run individually, twice, on a full course. No Championship points awarded. **LIMITED TO 5 HOUNDS both days.**

### **EQUIPMENT:**

Gas powered drag line lure machine with white plastic streamers.

### **PRIZES:**

Prizes will be awarded to all Best of Breed winners and 1<sup>st</sup> in Mixed Stake. Rosettes will be offered all placements 1<sup>st</sup> thru NBQ. LMWA offers an award for the Hare To Party – most entertaining dog of the weekend.

### **CHAMPIONSHIP POINTS:**

Will be awarded as follows: 1st place - four times number competing to a maximum of 40 points; 2<sup>nd</sup> place - three times number competing to a maximum of 30 pts.; 3<sup>rd</sup> place - two times number competing to a maximum of 20 pts; 4<sup>th</sup> place - one times the number competing to a maximum of 10 points; NBQ - no points awarded.

### **ADDITIONAL INFORMATION:**

- Stakes will be split if the entry in any breed reaches 24 or more at Roll Call.
- Bitches in season/lame hounds will have entry fee refunded provided notice is given at or before Roll Call.
- Dogs not present at Roll Call will be scratched and entry fee not refunded.
- Coursing entries received after the closing date will be charged the late/day of trial fee.
- \$5.00 will be levied against the owner/handler of any hound loose on the coursing field.
- It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
- Anyone exhibiting unsportsmanlike conduct will be asked to leave the trial site.
- A valid rabies certificate is required to bring a dog into Canada.
- Overnight camping is NOT permitted at the site.
- Washroom will be available. No food concession will be provided.

### **IMPORTANT NOTICE:**

Effective July 1998, hounds entering their first trial in Canada must be tested with another dog, not a kennel mate, and certified running clean by a licensed judge. The CKC Hound Certification form (included with this premium list) must be completed and submitted with their entry at the hound's first trial. Hounds with the following are exempt: ASFA F.Ch. or LCM, AKC F.Ch., S.C. or D.C. , but are still required to submit the Hound Certification form with their name and exempt title(s) circled.

### **ATTENTION US EXHIBITORS:**

US owned dogs may compete with an Event Registration Number. This number must be obtained within 30 days of obtaining points, awards, or scores to avoid cancellation. An ERN can be obtained by submitting a copy of your AKC registration with a letter of request to the CKC offices. Request may be faxed using VISA). A \$9.40 listing fee per trial is payable for each dog not showing a CKC or ERN registration number.
