To assist with Social Distancing and limit close contact and document transfer:

Pre-trial check-in will be offered for dogs with a completed (2018) AAC ID card.

Dogs with 1 measurement on their AAC ID card, can continue to compete in the height indicated by that measurement, the final measurement to be completed at a later date.

AAC ID Cards:

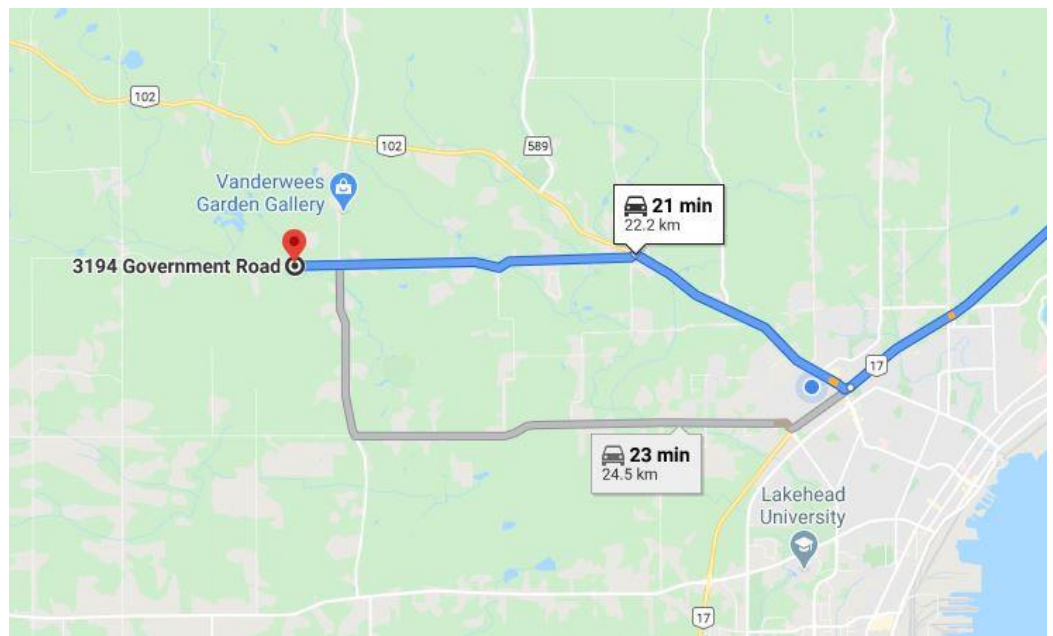
If your dog does not already have its AAC number, please complete the “Dog ID Card Registration” form found on the AAC website. <http://aac.ca/en/Dog-ID-Registration>
All dogs competing in an AAC trial MUST have their cards with them at the trial. Pending entries are not accepted. Legs and titles will only be issued to dogs with a valid AAC ID number. *Please allow up to six weeks for processing and delivery of ID cards.* All dogs must have a (2018) AAC ID card.

Check In & Measuring:

Check in and Measuring will be offered Saturday Sept 18 and Sunday Sept 19, 2021 at 8:15 am each day in order to have an opportunity to receive a measurement from each of our judge. Judges will resume signing Dog ID cards, this practice was paused in 2020 due to COVID-19 concerns. Dogs over 2 years of age must have at least one official measurement recorded on their Dog ID Card up to December 31, 2021. Temporary cards will only be issued to dogs under 2 years old in order to avoid having to measure these dogs at every trial. Dogs under 2 years of age may compete with their temporary card until they reach 2 years of age at which point they will require an official measurement. For dogs over 2 that have a temporary card from 2020, these are only valid until the expiry date noted on the card. After that date they will require an official measurement on their ID card. Any dog with one official measurement on their ID card does not need to have a final measurement recorded before January 1, 2022. Club must not tick “height card viewed” in Agility Rocks trial software until the handler has a signed, permanent ID card.

Directions to Site:

The trial will be held at 3194 Government Road, Thunder Bay ON



From the North – Drive south on Highway 17 turn right onto Dawson Road and continue until you reach the turnoff for Government Rd. Turn left on to Government Rd

and continue through the Mapleward Road intersection and on to the gravel portion of Government road until you reach 3194.

From the South – Drive north on Highway 17 turn left onto Dawson Road and continue until you reach the turnoff for Government Rd. Turn left on to Government Rd and continue through the Mapleward Road intersection and on to the gravel portion of Government road until you reach 3194

Additional Site Info:

Fully Fenced Ring, 100 x 90. Parking available along the driveway and to the left of the woodshed. There will be parking as well as space to set up tents and kennels available adjacent to the agility field, please bring your own chair. A tent, sun shade or similar is recommended. The site will be open Friday night between 7 and 9 for tent set up only. As this is a private residence there is no security on site but the family will be home. There is a spring on site and leashed dogs maybe taken down to the water, please follow the marked signage. Please note Sleeping Giant Dog Sports assumes no liability for loss or damage to items left unattended at the trial site, all belongings are left at your own risk. **** Dogs must be kept on leash when not in the ring or using the warm up jump. Please clean up after your dog.****

Local Entries:

Entries can be scanned and emailed to sleepinggiantdogs@gmail.com and payment made through EMT to the same address. Alternatively, local entries can be dropped off using contactless drop off in the mailbox at Please ensure your entry is complete, signed and in a sealed envelope containing your entry forms and payment.

Prizes and Awards:

A qualifying rosette will be awarded to all dogs that achieve a qualifying score in any class. Ribbons will be awarded 1st to 4th in each height division. Titling rosettes awarded for all new titles. Please advise the Trial Secretary of any titles earned during the trial.

Move Ups:

Move ups will be allowed at the trial. Move up forms must be completed and submitted to the Trial Secretary prior to the end of each day of trial. Move ups from previous trials must be reported to the Trial Secretary no later than **Sept 16, 2021**.

Obstacles:

Obstacles may include: A-frame, dog walk, teeter, weave poles, flexible tunnels, tire jump, spread jump, double bar jumps, broad jump, single bar jumps. All contact obstacles are rubberized. All obstacles have been inspected and conform to AAC specifications. ***Please note no table in use due to COVID-19 precautions for ring crew***

Giant Breed Height Concession:

– For dogs measuring over 22". Dogs considered giant breeds (see list below) or mixed breed dogs resembling giant breeds in terms of weight to height ratio, may jump one or two jump heights lower than their measured Regular height when they compete in the Specials category. Dogs who have double dropped in jump

height as a Special may enter the Veterans category and receive Veteran time at the age of five. *(They will not drop a third height)* For awards by jump height, giant breeds competing as a 16" Special shall be ranked with the other dogs in that same height and not in a separate category.

* **Giant Breeds:** Bernese Mountain Dog, Black Russian Terrier, Bloodhound, Bullmastiff, Dogue de Bordeaux, Great Dane, Great Pyrenees, Greater Swiss Mountain Dog, Irish Wolfhound, Kuvasz, Landseer, Leonberger, Mastiff, Neopolitan Mastiff, Newfoundland, Saint Bernard.

Accessibility:

Senior Handlers (65+) and Handlers with Disability may request a modified course time and a modified points requirement. Proof of disability or age will not be requested, the handler must indicate on the entry form if entering as senior/disabled handler (check SD box) to receive modified times/reduced number of points. A senior or handler with a disability may use a motorized scooter (if facility allows), cane, walker or similar physical aid with them in the ring if needed. Handler will also be allowed to carry the leash in their pocket, scooter/walker basket, around their neck – anywhere that makes it easy to pick up and use at the end of their run. Gamble Class - Handler will be judged by where their feet are for the gamble lines, regardless of their physical aid conveyance if any. Handler's dog shall be entered at its current competition jump height and category; modified time and reduced point requirements are a concession for the handler, not for the dog. If the senior or disabled handler chooses this option on the Trial Entry form, the dog will be scored with an adjusted course time and/or modified points for games. The dog will still be eligible to earn a Qualifying score with the adjusted course time and/or modified points. The dog will be eligible for placements based on its unadjusted score, and an indication will be made next to the placement column that the time/points concession is to be used to determine a qualifying score. Handlers can choose to have this option at any given trial, provided they enter as a Senior/Disabled Handler for the whole of the trial. For Standard, Challenge, Jumpers, Steeplechase, GP and Team, the score table will subtract the time prior to scoring the run, regardless of whether the dog was under the SCT for that division and category or not. For Gamble and Snooker, the score table will add 3 points prior to scoring the run.

Abuse:

Please note that abuse in any form of judges, competitors or volunteers will not be tolerated! Anyone disrupting the trial due to poor sportsmanship or abusive behaviour will be dismissed from the trial. No fees will be refunded and any legs earned to that point will be null. Remember, this sport is FUN for dog, handler, judges and volunteers!

Sleeping Giant Dog Sports appreciates our dedicated volunteers, however in order to limit the number of persons at the trial site volunteer start times will be pre arranged. We ask that volunteers wear a mask when volunteering in the ring, or at a service table. Your assistance as a volunteer is greatly appreciated. We cannot run the trial without volunteers, therefore your entry in the trial acknowledges that you are willing to volunteer as necessary. Lunch will be provided to full day volunteers where pre-arranged. All volunteers will be entered in the volunteer prize drawings. Level Progression:**Starters:**

Open to dogs that have not earned an ADC title.

Starters Games:

Open to dogs that have not earned two legs in that Starters Game.

Advanced:

Open to dogs that have an ADC title.

Advanced Games:

Open to dogs that have two corresponding Starters Games legs.

Masters:

Open to dogs that have an AADC title.

Masters Games:

Open to dogs that have three corresponding Advanced Games legs.

Class Descriptions:**Standard Class:**

This class demonstrates proficiency on all agility obstacles in a numbered course.

Gamblers Class:

This game demonstrates the handler's strategy and the dog's ability to work at a distance from the handler. The object of the game is to accumulate as many points as possible during the opening sequence and successfully complete the Gamble.

Snooker Class:

This game demonstrates the handler and dog's versatility as they work together against the clock. The object of the game is to accumulate as many points by successfully completing as many obstacles as possible in the prescribed order within time.

Jumpers Class:

This game demonstrates a dog's natural jumping ability. The dog is required to complete a course comprised of jumps and tunnels as prescribed by the judge.

Steeplechase:

This game demonstrates the dog's ability to run and jump at high speeds while maintaining control on the A-frame and weave poles. This class is open to all dogs eligible to compete in other AAC qualifying events at the Starters, Advanced or Masters Level.

Team Relay:

This game consists of 2 dogs, each with a different handler. The game demonstrates team spirit, strategy, and sportsmanship. This class is open to all dogs eligible to compete in other AAC qualifying events at the Starters, Advanced or Masters Level. This class is run in accordance with Masters Standard rules, regulations and course design guidelines.

Category Descriptions:**FEO (For Exhibition Only):**

Open to all dogs, 18 months of age or older with an AAC ID number, as described within the current AAC rules. The handler can choose to enter a dog FEO in any division, any class and/or any height but they will not be competing for placements, titles or prizes and the results will not be reflected on the dog's permanent record.

Regular Category:

This Category is open to all dogs, 18 months of age or older, as described within the current AAC rules. Jumps are set at the height determined by their measurement. At the handler's discretion, the dog may also run with jumps set one jump height higher than its regular jump height.

Specials Category:

The Specials Category shall be open to all dogs but is intended for dogs which are of a size or stature that limits their jumping ability. Once a dog has entered an official trial in the Specials class, they may no longer compete in the Regular class unless they make a special application entitled "Request for Official Move from Specials Class Level to Regular Class

Level". This move may only be done once during a dog's career. Dogs must run with jumps set at one height lower.

Veterans Category: This Category is for dogs seven years of age or older. This class is also open to dogs five years of age or older who have been competing in the Specials class level for a minimum of twelve months.

Single Drop and Double Drop Veterans: All Veteran Category dogs must jump at least one jump height lower than the lowest of the two Regular jump height options (Single Drop Veteran Dog), and may jump two jump heights lower (when a lower jump height is available), at the handler's discretion (Double Drop Veteran Dog). Handlers can opt to have their dogs jump at either allowable height at any given trial, provided they enter and jump the same height for all classes at that particular trial.

Junior Handler Category: This Division is open to handlers under 18 years of age, as described within the current AAC Rules, with a valid Junior Handler identification number. Junior Handlers may run under Junior Handler rules or as a Junior Handler under regular rules. If under Junior Handler rules, titles are awarded to the Junior Handler, not the dog and the dog MUST jump one height lower than their Regular height with the option of one further drop.

Additional information about the classes and title requirements is available in the AAC Rulebook, available online at www.aac.ca.

COVID-19 AAC Statement:

All participants are expected to follow Federal, Provincial, Municipal, facility and event guidelines. Clubs should be prepared to enforce the guidelines that apply to their event.

Trial hosts are free to set conditions limiting entry. Some examples could be: a limit in numbers, limit to club members only, or a limit based on place (province) of residence.

Specific guidelines established by the club must be published in the premium list, distributed to competitors, and posted visibly at their event.

Clubs MUST state their refund policy for all eventualities, including cancellation of the event, withdrawal of entry before closing and withdrawal at any time due to competitor illness.

Competitors are required to sign an agreement with the host that they will follow all requirements imposed by the club, in particular all COVID-19 related practices.

COVID Precautions in Effect:

- If you are experiencing symptoms of COVID-19, or if you or someone in your household has tested positive for COVID-19 and not yet received a negative test, or are awaiting test results, or have been advised to self isolate, or have traveled outside the country in the last 14 days please do not attend and notify the Trial Secretary as soon as possible
- Please remember to bring your own mask – masks will be required for any instances when the 2m requirement for social distancing cannot be maintained. This includes, but is not limited to, walkthroughs, briefings and course changes.
- Courses have been distributed by email each morning to help limit paper copies and passing documents. Please familiarize yourself with the course map to help limit congestion during walk through.

- Please note that there will be a porta potty and outdoor hand washing station on site. These will be disinfected throughout the days per local health authority guidelines. There will also be cleaning supplies and hand sanitizer provided to clean and disinfect high touch surfaces regularly.
- There will be signage and barriers delineating designated parking areas, dog pottying areas as well as warm up and on deck areas. Please watch for these signs and if you are unsure please ask! Our Committee members will be available to direct you.
- Please pay attention to others moving around you and work together to maintain social distance 2m at all times, if you cannot maintain a 2m distance please put on your mask.
- Remember frequent hand sanitizing, maintaining a 2m physical distance, and avoid touching unnecessary surfaces are the most effective ways to protect yourself.
- A trial logistics sheet will be emailed to all participants with their trial confirmation. Please review this document for specific procedures on how this event will be run in compliance with the most current local and provincial restrictions regarding outdoor events.
- We will be limiting the number of people on site in accordance with provincial gathering limits for our area and colour zone. Dog owners, handlers and family members are permitted but we ask that you limit who you bring with you where possible.
- Volunteers will be limited and we will ask competitors to volunteer where possible to help limit the number of people on site.
- Ring Crews will be limited to minimum numbers, we will work to be as efficient as possible but appreciate your assistance and cooperation.
- Walk through will be at the posted start time for each group, the ring steward will help stagger the group to ensure distance where possible during walk through.
- To support physical distancing please remain at your tent, crating area or vehicle or where possible.
- There will be signage indicating the warm-up area and tents for the people on deck, and in the hole, as well as a tent for the gate steward. As much as possible these tents or designated areas should be limited to one person at a time.
- Once you have completed your warm-up, move into the on deck area, then to in the hole and the gate steward will indicate when it is time to enter the ring.
- **There will be no leash runner for this event.** At the conclusion of your run please collect your leash and exit the ring so the next dog can start. Competitors may place the dog's leash in their pockets when running the course. The leash must be small enough to fit completely inside the pocket. Note: if the dog grabs the leash while running or jumps at the handler's pocket, this will be scored as an "E" (toy in the ring). If the leash falls out of the pocket during the run and the dog does not interact with it, there will be no fault. Competitors are encouraged to consider having two leashes; leave one leash at the exit gate prior to their run, and tossing the first leash outside the ring once they enter.
- The Table obstacle is not in use at this trial due to concerns for ring crew.
- Remember to bring your own chair. Where possible we ask that you crate out of your vehicle although there will be limited space for tents on the lawn.
- Water will be available on site, please bring refillable receptacles for both you and your dog. Lunch, snacks and other refreshments will not be provided, please plan to bring a lunch or any snacks.

REFUNDS due to COVID Related Cancellation

All entry fees will be fully refunded if the trial is cancelled due to lack of attendance, lockdown or COVID-19 related restrictions of any type. If an individual is unable to attend due to; self isolating, exposure to COVID-19, awaiting test results, symptoms of COVID-19 or other reason related to COVID-19 their entry fees will be refunded.

Notice to Competitors:

Competitors, through submission of entry, acknowledge that they are knowledgeable of AAC Rules and Regulations, including but not limited to the following:

- ✿ This event is held under AAC rules and regulations and is open to all dogs at least 18 months of age, purebred or mixed breed, except bitches in season, aggressive dogs, or dogs suffering from any deformity or illness which may affect the dog's physical or mental performance (judges' discretion).
- ✿ All dogs must have an AAC number before their entries will be accepted in an AAC sanctioned trial, which must be produced at measure in. Dogs with numbers pending will not be eligible to compete. Any dog without a card, under two years of age, or without two official measurements on their ID card must be measured before competing. A dog over 23" at the withers can have a signed ID card before two years of age. Dogs must have 2018 measurements.
- ✿ Competitors whose dogs measure up may run For Exhibition Only (FEO) if the dog is not prepared to jump the higher heights. No qualifying scores or awards may be earned.
- ✿ Entry forms may be photocopied, but **MUST** be complete and include the entry form, agreement and signature in their entirety.
- ✿ Entries forms must be accompanied by the proper fees to be valid. Payment must be received by the closing date and are payable in Canadian Funds.
- ✿ The host club reserves the right to refuse any entry for cause which they deem sufficient.
- ✿ By AAC rules, entries are not valid until full payment of entry fees has been made. Tendering of an NSF cheque in payment of entry fees shall be considered non-payment of entry. In addition, there will be a \$25.00 service charge for each returned cheque, regardless of whether the dog/handler compete in the event.
- ✿ After the closing date, refunds will only be given to competitors if a bitch comes into season or the dog or handler is injured sufficiently to prevent them from competing. The Trial Secretary must be informed prior to the trial date and a certificate from a veterinarian must be provided. All refunds made will be less any AAC or other administrative fees owing on the entry.
- ✿ All entries will be confirmed via email only where a valid email address is supplied. If supplying an email address, please ensure that it is valid and legible. If you don't have a valid email address and want your confirmation emailed, please ask a friend to receive it for you.
- ✿ No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, Acts of God, public emergency, an act of public enemy, or any other cause beyond the control of the organizing committee. *Please see section on COVID related refund policy on previous page.*
- ✿ We will accommodate handlers running more than one dog to the extent possible. Running order will be determined at the club's discretion. Any dog and handler not present for their run when their name is called will be ineligible to run, unless prior arrangements are made with the gate steward.
- ✿ **NEW - Collars in the ring** – dogs are allowed to wear a close-fitting collar, with no attachments, in the ring.
- ✿ No leads, food, toys or any other aids or devices shall be permitted in the ring. Toys and food shall not be permitted within 10 feet of the ring. Please be considerate of competitors and refrain from using clickers or squeaky toys while a dog is in the ring.
- ✿ **Toys will be allowed during FEO runs.** Toys may be of any general configuration & must be in a good state of repair (no stuffing or fur coming loose). Handlers are permitted to interact with their dog by tugging the toy. Food, food containing toys, audible toys and audible training aids are not permitted in the ring. Be considerate of the dog before and after you as the toy may distract the dog on course and/or may over excite the dog following you.
- ✿ All dogs must be penned, crated or leashed when not in the ring, and may not be tied to any obstacle, permanent or temporary, anywhere on the grounds of the trial site. Dogs are not to be left unattended unless appropriately crated. Please take responsibility for your dogs.
- ✿ **Any exhibitor whose dogs create unnecessary disturbances (including continuous barking while not on the competition field), or engage in unsafe or disruptive behaviour, may be asked to leave the trial site.** There will be no refunds for entries if an exhibitor is dismissed from competition for any reason.
- ✿ Any dog engaging in aggressive behaviour at any time will be required to leave the trial grounds. As well, any handler displaying inhumane or aggressive treatment of any dog while on site will be asked to leave. In such cases, no refund of fees will be given.
