COMPLIANCE

- At no time will more than 100 persons be permitted into the ring area.
- Please arrive at the parking lot no more than 60 minutes before ring time. Immediately following your ring time, you will depart the parking lot for the day unless you are returning for the Group Judging which has a designated ring time. (congregating in the parking lot is prohibited)
- Waivers must be presented upon arrival at the show gate and you will receive a wristband. No waiver no entry...no excuses.
- There will be no public or spectators permitted.
- Masks and/or face shields will be worn by all persons while onsite at the venue or adjoining parking lots. Masks mandatory in show precincts, parking lots, grooming and camping areas. ABSOLUTELY NO EXCEPTIONS.
- Please note the judging schedule has specific ring times for breeds, all breed group, limited breed group and Best in Show. There is a scheduled break at the beginning and following each ring call. This break will permit enough time to get specified number of dogs out of the ring area, and the next designated dogs into the ring area, grooming your dog prior to arrival is recommended although we recognize this could be a challenge.
- There is no hydro available for grooming in the parking area. As a courtesy to other exhibitors and to minimize congestion please do not arrive to the parking lot area more than 1 hour before your designated ring time.
- There will be a parking attendant onsite. As you approach the venue have your waiver ready and your mask on. You are asked to approach the entrance to the ring area 15 minutes before ring call and even though you are wearing a mask social distance (2 meters apart)
- It is your responsibility to be on time and ready to go when called. Upon completion of exhibiting your dog, you are to immediately proceed to your vehicle and depart the venue.
- Be sure to print off a judging schedule at home if possible.
- To assist the elderly, handicapped persons and for general transportation of exhibitors to and from the ring area, the club has rented golf carts. These are for the designed purpose only and will be driven by designated personnel as authorized by the club.
- There shall be no live streaming anywhere on the venue and no taking photographs in the ring area.
- Owners dropping off dogs to handlers on the day of a show must report to the parking area and meet the handler there or in the campground,
- Owners dropping off dogs must wear a mask while doing so and have a waiver completed. No waiver no entry.
- Campers please note. Camping is now in an actual campground with hookups. The fee is \$184 including tax, for the weekend, you have already paid \$80 which can be applied to the total or you are welcome to a full refund. Please send the balance of \$104 to

- Dogs and exhibitors must not be onsite between the hours of 10 PM and 6AM unless camping.
- All Grooming must take place in the parking area or adjacent grass area. There shall be no pop ups adjacent to the ring area. Temporary shade covers are permitted in the parking area, however please remember: TEMPORARY and not to be left up unattended.

THERE SHALL BE NO ALCOHOL CONSUMED ON SITE

• Washrooms are not considered under the regulations as indoors and are available to exhibitors.

These are trying times as everyone knows and the Wildwood KC and its staff remain diligent with regards to Compliance.

- There will be a Health Inspector, Safety Monitors, throughout the venue ensuring your safety and the safety of others.
- These monitors are representatives of the Wildwood KC and will report to the Show Chairperson or Show Superintendent any instances of non compliance or acts of verbal defiance, arguing etc. And without hesitation the person / persons will be asked to vacate the venue immediately. In addition, an Official Complaint will be filed by club with the Canadian Kennel Club.

The Wildwood KC acknowledges that these procedures are not the normal way of hosting an event, but in order to remain compliant we are going to follow the Regulations as set out by The Health Department.
