Move-Ups

Forms will be available at the Secretary's table. Previous trial move-ups must be submitted no later than Monday July 15th, at 5:00 pm MDT via email to the Trial Secretary. Same day move-ups must be submitted no later than 30 minutes prior to the start of the trial you choose to move-up into. Next day move-ups must be submitted to the Trial Secretary no later than 30 minutes before the end of trials on the original day.

Dogs may move UP (A stream) or DOWN (B stream) once completing a title.

Dogs may choose to Move DOWN to a B stream class for the next trial day if there is room/ at secretaries' discretion.

- Facility is handicapped/wheelchair accessible. - -
- Please use main entrance (front of building).
- The facility is an enclosed, indoor heated space with cement floor.
- Indoor benching is NOT available

Indoor benching is NOT available.

The Master/Senior/Crazy 8 indoor ring is enclosed with 25' x 25' lattice plastic fencing on three sides and a solid wall on the fourth wall.

The Instinct/Novice/Open indoor ring is 20' x 20' with reinforced X-pens on all four sides. The ring may be expanded for Crazy 8's if time/entries make this necessary.

Blinds

One indoor blind is a tented 10' x 20' space with chairs located a minimum of 15' away from the rings.

A second outdoor blind is 10' x 20' space with chairs.

5 dogs will be loaded in the blind for higher levels. 6 dogs will be loaded in the blind for Instinct Novice and Open.

Awards

Qualifying ribbons will be awarded for all qualifiers in all classes, including Instinct. Placement ribbons will be awarded for 1st through 4th in each height division for all classes except Instinct. New title ribbons and High in Class ribbons will also be awarded. Ribbon tabs will be provided for all new titles. B Classes will receive 1st through 4th, with one HIC for all height divisions combined. Master B placements will be awarded 1st to 4th in each height class and a HIC overall.

Grounds

Barn Hunt grounds include the side building housing the ring and adjacent grassy area (seen in red below). Bushes along the fences in the parking areas often have a significant number of burrs in them. Use caution when allowing your dogs near these bushes.

Parking

Parking is **NOT** permitted in the main Sleep Rover parking lot unless wheelchair or handicapped access is needed.

Parking can be found on 6a ST NE adjacent to the trial grounds. Angled parking only please.



- Withdrawals after the closing date due to injury of the dog will be eligible for a 75% refund of entry fees paid minus any non-refundable credit card/Dogshow transaction fees, if applicable, upon receipt of a note from your veterinarian. The note must be dated and emailed to the Trial Secretary prior to the close of the trial. If you have questions, contact the Trial Secretary directly at kouris.angela@gmail.com.
- Entry fee(s) will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.
- Entry fee(s) will not be refunded if the Trial cannot open or be completed by reason of riots, civil disturbances, fire, act of God, public emergency, act of a public enemy, or any other causes beyond the control of the organizing committee.

Mail in Entry Form

Please contact the Trial Secretary for the address if mail-in entry is desired. Entries must be received by the closing date in order to be considered.

Withdrawal & Refund Policy

- Competitors who withdraw any or all entries from a Fun Test, Trial or Trials prior to the closing date will receive a refund of all entry fees, minus any non-refundable credit card/Dogshow transaction fees, if applicable.
- Competitors who withdraw any or all entries from a Fun Test, Trial or Trials after the closing date are not eligible for a refund.
