ENTRY ELIGIBILITY

1. Dogs must be permanently registered with UKC, or have a Temporary Listing (TL) number in order to enter. No exceptions will be made. Entries for ineligible dogs will be returned.
2. Dogs must be 6 months of age on the day of the event.
3. An unentered dog may not be substituted for an entered dog.
4. Temporary Listings are not available at the event.

ENTRIES

1. **Pre-Entries:** Licensed Classes: \$25.00 per entry, KSH members: \$22.00 per entry. Pre-trials: \$10.00 per entry, KSH members: \$7.00 per entry. CASH or CHEQUE ONLY. Entries must be received by event staff before **May 10, 2019.** Entries received after this date will be charged Day of Show Price – NO EXCEPTIONS!
2. **Day of show entries:** \$28.00 per entry, KSH members \$25.00. Pre-trials \$10.00 per entry. CASH or CHEQUE ONLY.

SUBMITTING ENTRIES

1. Entries must be submitted on the current Official UKC Nosework Entry Form. Downloaded copies or photocopies of these forms may be used as well.
2. All entries must include the entire form for each dog and be signed. Incomplete entries will not be accepted.
3. Pre-entries may be mailed, or hand-delivered to the Event Secretary.
4. **Mailed Entries** must include the entire form for each dog and be signed. Mailed entries received without fees shall not be accepted.

PAYMENT

1. Payment may be made by cash or cheque.

3. Returned cheques do not constitute valid entry fees.

REFUNDS

1. Refund of entry fees will not be made for entries cancelled after the Pre-Entry deadline except in cases of extenuating circumstances which are approved by two members of the Kootenay Scent Hounds' Board of Directors on an individual basis.
2. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by Judge, or barred from competition by action of Event Committee.
3. In lieu of a refund, Novice A competitors who do not pass their PT1 will be able enter other PT1 runs offered during this event for free until they pass.
4. Please note that entry fees shall not be refunded in the event that a dog does not pass the required PT.
5. If, because of riots, civil disturbances, or other acts beyond the control of the host organization it is impossible to open or to complete a show or trial, no refund of entry fee will be made.
6. Every effort will be made to find all duplicate entries before processing. If a duplicate entry is processed, however, no refund will be made.
7. If, in the opinion of the host club, the wellbeing of dogs, exhibitors or spectators is at risk due to extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, or extreme heat, the host club may cancel or stop a show or trial before completion. No refunds will be made in such cases.

Site Information:

Driving Directions: From both Nelson and Castlegar: at the junction of Highway 3A and Highway 6, turn north onto Highway 6 (towards Slocan, and Nakusp). Turn onto your second right (you will see a fenced parking lot with school buses). If you reach the Evergreen Coop and Esso, then you've missed the turn.

Crating and Set-up:

There will not be indoor crating space available. Dogs must be crated in vehicles. Please be prepared for hot weather (shade cloths, fans etc.), there is limited shade on site. Owners are expected to pick up after their dogs.

Food will not be available on site, restaurants and grocery stores are within a 5 min drive.

Accommodations:

Hotel Information: Several pet friendly hotels/motels are located within Castlegar, as well as within Nelson. Castlegar options include the Quality Inn, Sandman Hotel, Super 8 Hotel, Fireside Inn, Flamingo Motel, Cozy Pines Motel, and Twin Rivers Motel. In Nelson, pet-friendly options include the Mountain Hound Inn, Alpine Inn and Suites, and the Hume Hotel.

Camping Information:

There will not be camping available on site. Local campgrounds include Pass Creek Regional District Campground (near Castlegar), Castlegar RV Park, Kootenay River RV Park (near Castlegar), the Nelson Municipal Campground (within the city of Nelson), Kokanee Creek Provincial Park (15 min north of Nelson towards Kaslo), and Springer Creek Campground in Slocan City (35 min north of the trial site on Hwy 6).

Awards to be Presented:

Ribbons will be awarded for completed titles (Novice Interiors, Novice Exteriors, Novice Nosework, Advanced Interiors, Advanced Exteriors, Advanced Nosework, Superior Interiors, Superior Exteriors, Superior Nosework, Master Interiors, Master Exteriors, Master Nosework), placements (1st through 4th), and for all qualifying runs. High-in-trial ribbons will also be presented to the qualifying team with the fastest time for each level in each trial.

Move-Up Policy:

Participants may move up to the next level provided that the level is offered at this event.
