Grooming Space

Grooming will only be allowed on areas tarped by the NKC, crates should be placed along the perimeters and grooming tables must be placed a minimum of 3 feet from the edge of the tarped area. This will help protect the floors from overspray. There is to be no spraying of any kind ringside/in any un-tarped areas. Please keep marked aisles clear.

In addition, as always you must bring your own floor covering for your set-ups. All exhibitors must cover the floor of their grooming area. Plastic, paper or fabric material which may be secured with painter's tape. (Duct tape is NOT permissible.) The floors have recently been replaced and there is a ZERO TOLERANCE POLICY for grooming on uncovered space.

Attention Foreign Exhibitors

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted.

Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor.

Please do not mark cheques "Payable in Canadian Funds" or "At Par." They will not be cleared by the banks.

To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation are appreciated. Thank You.

It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. No person may approach a judge either directly or otherwise, orally, in writing or electronically, to favour his entry.

Disciplinary action will be taken against any person who violates this rule, or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the action.

Terms of Service:

Sadly, we have had several issues with exhibitors using the photographer's set-up for candid's and/or not paying for pictures. Please respect that our photographer gives up their entire weekend to provide professional photography for our shows and deserves to be compensated. Because of this, proofs will not be sent until payment for the initial request has been made. Photos are \$30 and you will be able to view them on the camera. Personal use of the photographer's set-up is strictly forbidden as is the use of cell phones and personal camera's while dogs are in the set-up.

HEALTH REMINDERS

No dog may be brought onto the grounds or premises of an event if it:

- 1. Is known to have distemper, parvovirus, kennel cough or other communicable disease.
- 2. Has recovered from distemper, parvovirus, kennel cough or other communicable disease within the last 30 days (prior to the event).
- 3. Has been housed within 30 days prior to the even on premises on which there existed distemper, parvovirus, kennel cough or other communicable disease.
- * Clubs do have the right to remove a dog from the event premises and the exhibitor may be subject to disciplinary action if it is found that CKC rules have been contravened.

CORRECTING SHOW RESULTS – NEW FOR 2024

Section 9.9 The CKC will not consider a request for any corrections to results if received more than 90 days following the date(s) of the event(s).

Conformation Show Rules and Regulations: The Exhibitor is responsible for knowing and complying with the Conformation Show Rules and Regulations of the Canadian Kennel Club.

Moving Class Dog to Specials Only Section 8.9 of the Conformation Show Rules and Regulations has been

amended to allow a dog which is individually registered in the records of the Canadian Kennel Club, and has completed the requirements for a Championship, after the Closing Date for entries for a show, may be transferred from one of the Regular Classes to "Specials Only," providing the request for a transfer is submitted to the Show Secretary in WRITING at least one hour prior to the judging of your breed by the owner or handler. When one or more all-breed and/or specialty shows are held on the same day, in the same venue, the request for moving of class dogs to Specials Only must be made a minimum of one (1) hour prior to the breed judging scheduled start of the show for which the dog is being moved up to Specials Only.

Moving from Specials Back to the Classes Section 8.10.5 A dog can be moved back into the classes from a Special if it has been entered incorrectly, only where the shows have already closed.



Championship Point Ratings

A dog awarded Winners at a Championship Show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5), and the determination of the number of championship points to be credited to the dog awarded winners shall be as provided hereunder:

A class dog awarded Best in Show at an All-Breed Championship Show will be credited with five points inclusive of any points won at the Breed or Group level. In no case may a dog earn more than five points at a single show. In order for a dog to be recognized as a champion it must win at least 10 points under 3 different judges, which includes at least one 2-point win.

General Information

- 1. The Show Superintendent will be in full charge of the show, which will be governed by CKC Rules.
- 2. The Newfoundland All Breed Kennel Club will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors, or patrons.
- 3. Only dogs entered in the show will be allowed in the building.
- 4. All exhibitors are required to clean up after their dogs. Clean up bags and garbage bins are available for this purpose throughout the show site. There continues to be those who do not take responsibility for their dogs, jeopardizing the club's access to this venue. For this reason, exhibitors who permit a dog to soil on the show grounds without cleaning up will be denied entry to NKC shows and trials for one full calendar year. NKC has a zero-tolerance policy for unsportsmanlike conduct during and in relation to their events, including on social media.
- 5. The use of flexi leads, prong, spike, or electronic collars is prohibited on show grounds.
- 6. *Tripaw Pet Photography will be on-site as our official show photographer! Please note that the photographers set up is exclusively for use by Tripaw Pet Photography and may not be used by exhibitors for personal photos or candids.

- 7. If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to open or to complete the show, no refund of Entry will be made.
- 8. Dogs should arrive in adequate time for their breed judging (allowing for absentees) and will be excused each show when not required for further judging. It is the responsibility of the exhibitors to have the dog at ringside when the dog's class is scheduled for judging.
- Waiting for dogs will not be possible and handlers with several breeds must arrange for alternate handlers if judging times for their breeds' conflict.
- 9. Judging will commence at 9 a.m. each day. Starting time of each ring will be specified in judging schedule. The building will open at 8:00 a.m. each morning & close 30 minutes after completion of Saturday judging.
- 10. Building will be open at 7pm Friday evening for set-up. There will be absolutely no exhibitor access to the building prior to 7pm Friday evening.
- 11. Exhibitors MUST vacate the premises one hour after the judging of General Specials on Sunday.
- 12. SHOW PRECINCTS: Show precincts shall consist of the entire arena. NOTE: The Show Superintendent may restrict the placing of chairs, tables and crates and may limit the use of private exercise pens during show hours.

Meet Our Judges

Dr. Terill Udenberg, Vernon, British Columbia



Dr. Udenberg has been involved in the sport of exhibiting dogs for nearly thirty years, starting with Dobermans. After a short hiatus, he returned with Standard Poodles and eventually included Toy Poodles. He has been breeding Standard Poodles for over twenty-five years with the prefix "Tees" of Tees Blue Skies. He has had multiple Best in Show, and Best in Specialty winners including several top 10 dogs, but his love is exhibiting the young specimens of his breed. In 2017, the top three young standard poodles in Canada were all from the TEES breeding program.

Dr. Udenberg served on the Health Committee for the Pekingese Club of America. Dr. Udenberg was invited to speak on behalf of the Pekingese Club of Great Britain (on airway research) as an expert witness regarding changing the Pekingese Standard as proposed by the Kennel Club of Great Britain. The research included other breeds in the Brachycephalic group as well. As such Dr. Udenberg also

served on the CKC Brachycephalic Breeds Advocacy
Committee to address the changes in some breed standards
that are happening around the world and perhaps, soon in
Canada.

He has had the honour of judging many specialties in both the USA, Canada, New Zealand, China, and Australia, including: the Tibetan Terriers, Poodles, Boston Terriers, Pekingese, Pomeranians, Miniature Pinschers, Lowchen, Australian Shepherds, Basenji, Schipperke, and others. Dr. Udenberg is an avid veterinary volunteer in world disasters including Katrina, Guyana, Peru and in several spay/neuter programs in Fiji. He is an outdoors man who enjoys biking, hiking, kayaking and extensive travel for scuba diving throughout the world.

Maribel Sy, Cavite, Philippines



In 1981, we have acquired our first Shih Tzu and in 1983, me and my husband established Sunnyside Kennel. We have been involved in breeding, showing and handling Shih Tzus

with great success. Among them are: Owner/handled the first Phil Grand Champion Shih Tzu in the country, Phil. Grand champion Ben (imp. Japan); Owner /handled the 1986,'87.' 88 and '89 Top Shih Tzu and No. 2 Top Dog in 1987.'88 Multi BIS Phil Grand/Am Champion Louwan gunning Tootsie Pop; Owner/Handled the 1995 PCCI Top Dog Multi BIS Phil Grand/Can Champion Symarun Ultimate Fantasy "Rylee"; Breeder of the No. 1 Shih Tzu in Indonesia in 2000 BIS Phil grand/ Ind Champion Sunnyside change in Time; Breeder of the No. 1 Shih Tzu in Russia Multi BIS International/Russian champion Sunnyside Wild Moment "Mork.". We have also produced several champions and grand champions both here and overseas. Handled the Top Chow chow in the Phil, Am/Br/Ind/Phil HOF Ayran Hung Red Tiger.

I have been handling/showing dogs overseas since 1990.

Among the places I have handled are Thailand, Hongkong,
Indonesia, Malaysia, Canada and USA (at the American Shih
Tzu Club National Specialty in Minnesota). I am the only
Filipina who have handled and won at the Canadian
Nationals in 1993.

Aside from Shih Tzus, our kennel has been involved in showing and breeding other breeds among them German Shepherds, Dobermanns, Rottweillers, Pekingese, Dachshunds, Golden Retrievers, Maltese, Chow Chows, Yorkshire Terriers and Belgian Malanois.

I have served as a PCCI Director and have chaired the Rules

and regulations committee and Membership Committee. I am the past President of the Cavite Canine Club, Past Officer of the Phil Toy Dog Club and The Ladies Kennel Club. I am a licensed PCCI /FCI ring steward since 1995.

I got my first license for the Shih Tzu breed in year 2000. I am a PCCI /FCI/AKU International All Breeds judge. I can judge All breeds at championship level. I can award CACIB and challenge certificates to all breeds/ groups. I can judge General Specials.

I have judged in Australia, Canada, Japan, Thailand, Russia, Indonesia, South Africa, Malaysia, Singapore, New Zealand, China, India, Taiwan, Ireland and Sri Lanka.

I have judged all over the Philippines and some of parts of Asia, judged the Toy Dog Specialty club in Thailand, Golden Retriever Club Specialty, and Labrador Club Specialty, judged All breeds for the Spitz and Primitive Club of Thailand. Judged the General Specials at the Pedigree Winter Carnival show in Brisbane, Australia, All breeds and General Specials in Guwahati, India and the All breeds and General Specials at the Dobermann Club of Indonesia. I have judged the Oriental Breeds Society of Western Australia and The West Australian Kennel Club Winter Festival in Perth, Australia in 2009. Judged ALL Breeds Dog Club of South Australia in Adelaide and Canberra in November, 2011, Kennel Club of Taiwan Nov, 2011, New Zealand and New South Wales in Australia in April, 2012, Malaysia FCI show in March 2012, South Africa

in June, 2012, Sydney and Adelaide July 2012, JKC winter dog Festival Japan, Dec. 2012. China Kennel Union March, 2013, Japan May, 2013, Alberta, Canada May 2013, India Dec, 2013. Judged in South Shore Kennel Club Nova Scotia, Canada in June, 2014 and Kilbride and District Kennel Club (Ontario) and Manitoba Canine Association in Canada August, 2014. Judged several times for China Kennel Union in 2015, '16 and '17. Judged in Sri Lanka FCI show in March 2017. judged in Ireland in August 2017.

Learn how animals compensate to keep their centre of gravity.

Dr. Udenberg was a professor in both University and at the college level and is an expert in anatomy and physiology. As a veterinarian, he has a special interest in genetically inherited disease. His veterinary expertise is in Cardiology and Internal Medicine, Ultrasound and Acupuncture.

Dr. Udenberg is an internationally recognized "all breed" judge, he has judged in Canada, USA, and Australia and New Zealand, China, and Columbia, and frequently does seminars in several subjects including, "The Physics of Balance - a Scientific Approach," "Canine Reproduction," and in "Brachycephalic Obstructive Airway Syndrome.". As an official presenter for the Poodle Club of America, Dr. Udenberg has had the honour of mentoring many judges and exhibitor in the details of Poodles and continues to be an ambassador of the sport of showing purebred dogs.

Most recently, he gave seminars in both New Zealand and in Australia to the Dogs Judges association of each of these countries as their keynote speaker. We are very pleased to have Dr. Udenberg bring this opportunity to Newfoundland.
