Upon the completion of the fun tests, "one on one with the judge" time is available. Fee is \$5.00 for 3 minutes.

Workshop Tentative Agenda:

Review of Barn Hunt rules - (Dogs will be required to be in kennels for this portion)

Hands on - Practice stations - These (3 bale climb stations and 2 tunnels) will run simultaneously so should only take about a half hour to let everyone use the bales for climb and tunnel practice.

The introduction to the rat tubes - Each dog will need most likely 1-2 minutes at the rat tube station. They just need to show interest and be praised for it.

During the workshop, handlers will be allowed to participate with one dog only. **HANDLERS ARE ENCOURAGED TO ENTER ADDITIONAL DOGS IN THE FUN TESTS AND THE "ONE ON ONE" JUDGES TIME.**

EXHIBITOR INFORMATION

Individuals **are required to attend** the workshop to register in the Fun Tests. BHA registration numbers will not be required, as per BHA standards.

No flexi-leashes, electronic collars, bark collars, head halters or prong collars will be allowed on site. All dogs must be on a short leash and under control at all times. Dogs should be brought to the ring with collars or slipleads which can be easily and quickly removed and replaced. For further clarification, please review the BHA LLC Official Rulebook.

Dogs will be run in height order, with dogs being handled by the same person separated into different staging groups.

Bitches in season are eligible, but must be kept separate from all other dogs, and will be run at the end of the Workshop/Fun Test. Please advise the workshop secretary when you arrive. A separate exercise area will be designated for these females. As per Part 4: General Rules, Sec 1: Bitches in season must compete in panties specifically designed for the purpose of preventing/containing seasonal discharges.

Lunch and beverages will be available on site.

DOG AGGRESSION

Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the workshop/matches if justification is found to do so by the judge and/or trial committee.

ANIMAL SAFETY

The safety of the dogs and the rats are our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and are physically able to perform all course elements safely.

REFUNDS

Refunds offered only for injured or sick dogs with veterinary note. Requests for refunds must be made by the closing date. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.

CERTIFICATION OF AGREEMENT UPON REGISTRATION OR ENTRY OF DOG

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of the Barn Hunt Association, LLC in effect at the time of this event, and by any additional rules and regulations appearing in the premium list for this event, and further agree to be bound by the liability waiver enclosed with my entry. I (we) certify and represent that the dog entered is not a hazard (dog or human aggressive) to persons or other dogs. This entry is submitted for acceptance on the foregoing representation and Agreement. I (we) agree to conduct myself (ourselves) in accordance with all Barn Hunt Association, LLC Rules and Regulations and to abide by any decisions made in accord with them.

LIABILITY WAIVER

I (we) agree that the club holding this event, Regina Kennel & Obedience Club, has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event , I (we) agree to hold Barn Hunt Association, LLC, the event-giving club, Regina Kennel & Obedience Club, their members, directors, governors, officers, agents, or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any BHA LLC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons.

In consideration of, and as an inducement to the acceptance of my application for training classes or membership at the **Club**, I indemnify and hold harmless the **Club**, their employees, members, instructors, assistant instructors and agents from any and all claims, actions, causes of action, demand, damages, suit costs, charges whether legal or equitable, of every nature and land and howsoever arising and whether known or unknown but any person including but not limited to any member of my family or any other person accompanying me to any training session or function of the **Club**, whether on **Club** property or elsewhere.
