These dogs must be eligible for CKC registration as noted in Chapter 6, Section 6.1.1 Any qualifying scores earned in a sanction match do not count towards official titles. A match is intended to be a learning experience for trial officials, judges, stewards and exhibitors.

17.9 A dog may be entered in and participate in any class for which it has a CKC title, but is not eligible for ribbons or prizes in that class
