**Time:** Each dog and handler will be assigned a specific hour for their evaluation with the first evaluations starting at 8:15 AM. Bitches in season will be moved to the last group to be evaluated. Please inform the event secretary as soon as possible if your bitch is in season. You are asked to arrive on time to check in and have your dog measured and photographed before the group mingle. Group photos for publication and the presentation of ribbons will be done in two groups, one at noon and the other at the end of the day.

Entries: Entry Fee is C\$ 80 per dog, payable to GRCGT. There is a 24 dog limit for the event. Entries will be by first received with a limit of 2 dogs / handler. Additional entries may be sent and if there are openings after the closing date they will be accepted in the order they were received. If there are more entries than spaces, a waiting list of up to 6 dogs will be maintained. PLEASE NOTE, if entering more than one dog, each dog needs a separate entry form and cheque. Post-dated cheques will not be accepted. Entries open Feb 21, 2015. Final closing date is July 11<sup>th</sup> 2015. Entries must include the agreement page and a cheque or money order payable to GRCGT. Entries by regular mail, drop-off, or courier only please. Send courier entries no signature required as secretary will not travel to post office for pickup. We will confirm receipt of entries by email.

USA Exhibitors: Personal cheques, payable in U.S. funds, and for the full amount of the entry, will be accepted. Personally discounted cheques will not be honoured. Please do not mark personal cheques "Payable in Canadian Funds" or "At Par" as such items are not cleared through the banks. Bank drafts or money orders in Canadian Funds are also acceptable.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog evaluated, I (we) agree to hold the GRCA, the host club, their respective members, directors, officers, agents, secretaries, committee members, evaluators, and the owner/lessor of the premises, and any provider of services at the event (and any agents, volunteers or employees of the same) (the "Released Parties"), all harmless from any claim, loss or injury which is alleged to be caused directly or indirectly to any person, dog by the act of this dog, or its owner or agent, while in or about the event premises or grounds or near any entrances thereto; and I (we) personally assume all responsibility and liability for any such loss or claim; and I (we) further agree to hold all of the Released Parties from any claim, loss, injury or damage to the dog or its handler, owner or agent.

• I (we) acknowledge that any evaluation, measurement or comment, whether written or oral, made at this event regarding the dog is not binding upon, and does not affect in any manner, the dog's qualifications at licensed dog shows sponsored by AKC or any other entity licensed to offer conformation shows or performance events for dogs.

• I (we) hereby assume the sole responsibility for and agree to indemnify, defend and hold harmless all of the Released Parties from any and all loss, cost and expense (including legal fees) by reason of the liability imposed by law upon the Released parties for damage because of bodily injuries, including death, sustained by any person or dog, including the undersigned, or on account of damage to property, arising out of or in connection with my (our) participation in this event however such injuries, death or property damage may occur or be caused, and whether or not the same may be caused or may have been alleged to be caused by the negligence of the Released Parties.

• I (we) agree that any cause of action, controversy or claim arising out of or related to the entry, exhibition or attendance at this event between myself (ourselves), the Host Club, or the GRCA, as to the construction, interpretation and effect of this agreement shall be settled by arbitration pursuant to the applicable rules of the American Arbitration Association, provided, however, that all applicable rules and procedures of the GRCA must first be followed as set forth in the bylaws of the GRCA.
