- To hold the Host Club harmless from any claim for loss of this dog by disappearance, theft, death or otherwise and from any claim for damage or injury, even if such loss or damage/injury was caused or alleged to be caused by negligence of the Host Club or any other person(s);

To assume the sole responsibility for and agree to indemnify, defend and save the Host Club harmless from any and all loss and expense, including legal fees, by reason of the liabilities imposed by law upon the Host Club for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person(s), including myself, or on account of damage to property, arising out of or in consequence of my participation in the event, however such injuries, death or property damage may be caused and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the Host Club or any other person(s);
