This trial is open to dogs of mixed breed or unknown origin as well as unrecognised breeds, a Canine Companion Number is required.

All obstacles shall meet the specifications in the CKC Agility Rules and Regulations effective January 1st 2020. The broad jump and wall jump will not be offered at this trial.

It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation. The Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.

CKC has a non-member Participation fee of \$63.90 + HST. This fee only applies to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members. "These events held under The Canadian Kennel Club".

To be eligible to compete in these trials, a dog must be 18 months of age and eligible for registration with the CKC, have an ERN or CKC Misc. Certificate, TCN or a CKC Performance Event Number. Spayed bitches, debarked dogs and neutered males are eligible to compete. Mixed breed dogs may enter these trials with a Canine Companion Number.

Bitches in season may not compete. When a bitch comes into season after the closing date. A vet's certificate certifying the bitch was in season within a 10 day period preceding the trials must reach the trial secretary on or before the start of the first trial. A full refund of entry and listing fees will be given.

As of January 1st 2020, as per CKC regulations, if a dog is injured after the entry has been submitted to the Trail Secretary, a Veterinarian's certificate, certifying the dog was injured before a 3 day period preceding the trial, must reach the Trial Secretary on or before the start of the trial. The club may refund the entry minus the TCN fee and a \$10 administration fee.

Senior handlers 65 years or older or handlers with a disability can request modified a course time or point requirement as of Jan. 1st 2020. You MUST indicate this on the entry form.

Entries open August 1st at 9.00am and close August 25th at 9.00pm. Day of entries will be taken until the courses for the day are released.

Entry fees: Early Bird \$22.00 per run, \$120.00 for 6 runs (same dog) Regular fee (after early bird date): \$25.00 per run After closing date & day of entries: \$30.00 per run

Flat ribbons will be offered in each jump height in each class for qualifying scores. Titling rosettes will be offered for new titles.

Judging schedule will be sent by email at least 6 days prior to the trial

Tendering of an NSF cheque shall be considered non-payment, all entries will be returned. A service fee of \$45 CDN will be applied to all returned cheques.

Entries withdrawn before the closing date will be charged an administration fee of \$10, refunds will not be processed until after the trial

Foreign exhibitors note that Canadian Funds ONLY will be accepted. Due to fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will only be accepted in Canadian Funds. Bank drafts or money orders in Canadian funds are preferred.

Temporary Competition Number (TCN) means a number issued by the CKC that allows a dog of unrecognized breed that is eligible for CKC registration to participate in CKC events. Dogs that require a Miscellaneous Certificate Number, Performance Event Number or Canine Companion Number are not eligible for a TCN. TCN fee, per dog per trial \$10.00 + HST.

Please note: each agility entry includes a \$4.70 + HST Recording Fee.

These events are held under the rules and regulations of the CKC, unbenched, unexamined, outdoors. To comply with the CKC regulations, we will be unable to accept, alter, cancel or substitute any entry reaching the event secretary after the official closing date and time for entries except for as provided in the CKC rules.

Covid 19 requirements (subject to change as required)

Maintain social distancing of 6', masks are required for course walk through Crates, shade tents and chairs will be placed with adequate distance between other participants Sanitize hands upon entry and exit of ring, before and after handling any equipment Enlarged course maps will be posted for you to take a picture, no paper copies will be available You are responsible to record your results from the posted result sheets (bring your own pen and paper) Ribbons will be placed in individual envelopes for collection at the end of the day or before you leave. EVERYONE is expected to help. **A \$10 fee will be charged to any individual not helping**.
