### DIRECTIONS FROM SWARTZ BAY FERRY TERMINAL

HEAD SOUTH ON HWY 17 TOWARDS VICTORIA FOR APPROX 11 KMS, TURN RIGHT AT MT NEWTON CROSS RD (TRAFFIC LIGHTS). TURN LEFT AT WALLACE DRIVE (4 WAY STOP). TURN RIGHT ON STELLYS X RD & SAANICH FAIRGROUNDS WILL BE ON YOUR RIGHT.

### DIRECTIONS FROM NANAIMO

HEAD SOUTH ON HWY 1 TOWARDS VICTORIA & TURN LEFT ONTO MCKENZIE TO HWY 17 HEADING NORTH TOWARDS THE SWARTZ BAY FERRY TERMINAL. AT APPROX 15KMS, TURN LEFT AT MT NEWTON CROSS RD (TRAFFIC LIGHTS). TURN LEFT AT WALLACE DRIVE (4 WAY STOP). TURN RIGHT ON STELLYS X RD & SAANICH FAIRGROUNDS WILL BE ON YOUR RIGHT.

### **\*PARKING - IMPORTANT\***

**PLEASE ENTER VIA THE MAIN GATES IN THE CENTER OF THE FIELDS** (BY THE 'HOME OF THE SAANICH FAIR' SIGN). THERE WILL BE TWO SMALL HORSE SHOWS TAKING PLACE AS WELL, SO OUR PARKING IS LIMITED TO THE AREAS SHOWN IN THE IMAGE BELOW. PLEASE DO NOT PARK BEYOND THE END OF THE RCMP BARN WHERE THE HORSE STALLS ARE. SHADE PARKING WILL BE VERY LIMITED, BUT THERE IS AMPLE CRATING SPACE INSIDE THE RCMP BARN. PLEASE GIVE THE OUTDOOR HORSE SHOW RING SPACE AND DO NOT POTTY YOUR DOGS ALONG THE FENCE LINE.
