Classifications

In all breeds, recognized by the C.K.C., the following classes will be provided for, divided by sex.

6 Months and under 9 Months on day of show. Junior Puppy Senior Puppy 9 Months and under 12 Months on day of show. 12 - 18 Months 12 Months and under 18 Months on day of show. Canadian Bred Dogs born in Canada

(Champions of any country excluded)

Bred by Exhibitor Dogs owned and handled in the ring by the breeder

Open For all dogs

Specials Only For Canadian Champions

Exhibition Only For all dogs over 6 Months of age and eligible for registration with the Canadian Kennel Club

Note: In all breeds, where classes are divided by colour, weight, or coat, indicate clearly in the class

division on the entry forms.

Temporary Competition Number (TCN)

TCNs allow dogs to temporarily participate in CKC events while pursuing permanent registration or an Event Registration Number (ERN) (if foreign).

Reminder: All unregistered recognized breeds must obtain a Temporary Competition Number (TCN) before entering an event.

This includes Baby Puppies.

TCNs replaced the previous system of entering dogs into events as "listed". Only 1 TCN is required for each dog and must be used for all event entries until the dog is permanently registered or has an ERN.

Dogs **exempt** from obtaining a TCN include Listed Breeds that require a Miscellaneous Certification Number (MCN), dogs that require a Performance Event Number (PEN), and dogs that require a Canine Companion Number (CCN) before entering into an event.

***** JUNIOR HANDLING *****

One Regular Junior Handling competition will be held each day.

Juniors MUST pre-enter. Use the special JH entry form and submit directly to Show Secretary prior to closing. There is no fee.

CKC Junior Handling rules apply. Dogs must be entered in a regular class or in Exhibition Only.

*****BABY PUPPY CLASS*****

The Baby Puppy Class is for dogs 4 months and under 6 months on the day of the show. Dogs entered in the Baby Puppy Class do not compete for points.

Puppies entered in this class will participate & compete for Best Baby Puppy in Breed, Group, & Show. There is NO LISTING FEE for Baby Puppies who are unregistered!!!!!

Prize List

Rosettes will be offered each day as follows;

Best In Show, Reserve Best In Show, Best Puppy In Show, First - Fourth In Group, Best Puppy in Group, Best Baby Puppy in Group & Show;

Notice To All Foreign Exhibitors

Effective January 1, 1992, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering C.K.C. events will no longer require a C.K.C. registration number, but will require an **Event Registration Number (ERN)**. This ERN does not register a dog with the C.K.C. for breeding purposes as defined in the Animal Pedigree Act, but rather enables a foreign born and foreign owned dog to be awarded titles by the C.K.C. Each dog must have its own number. This Event Registration Number must be applied for within 30 days of the first day of obtaining points, awards, or scores to avoid cancellation. If factors beyond your control prohibit this or present a problem, please send a written request to the CKC for an extension.

Notice To All Canadian Residents Only

Section 24-12-3. Non-member participation fee

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.

Chapter 20: Champions and Championship Points

Section 1. A dog awarded Winners at a Championship Show held under these Rules shall be accredited with a number of championship points (ranging from 0 to 5) and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

Section 2. The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:

Section 4. In addition to championship points allocated at the breed level a dog awarded WINNERS which also places in the regular Group competition as provided in Chapter 4, Section 8(j) of these Rules shall be credited with the following additional points, provided that the dog has defeated another dog at the group level, save that no more than five (5) points will be credited to a dog for a single show:

A class dog awarded Best In Show at an all-breed championship show will be credited five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five points at any single show.

General Information

The Show Superintendent will be in full charge of the Shows and Specialty Shows, which shall be governed by the Canadian Kennel Club Rules.

Print your entries carefully. Include your complete address. Errors made on entries by exhibitors or their agent must stand regardless of how or by whom entries were made.

No entry will be accepted unless accompanied by the correct entry fee. No refund of entry fees will be made if it is impossible to open or complete any show because of riot, civil disturbance, or other acts beyond the control of The Lakehead Kennel Club.

Entry fees will not be refunded should the dog be absent, sick, lame, in season, or excused by a Veterinarian, the Judge, or the Show Superintendent.

The Lakehead Kennel Club reserves the right to refuse any entry, subject to Canadian Kennel Club Rules. Dogs must be ready for judging; individual dogs will not be called. Judges will not wait for any dog holding up a Breed or Group. Dogs not entered in the Show are not allowed.

Exercise areas must be used. The Show Committee will take all precautions and use all methods to keep the Building and surrounding area as clean as possible. Exhibitors are expected to do their part as well.

Covid protocol & Regulations

DEPENDING ON RESTRICTIONS IN PLACE AT THE TIME OF SHOW

General Safety Practices • LKC and all show participants shall follow federal, provincial, and local guidelines that apply to the area and site where the event is held. • Practice social distancing consistent with guidelines. Do not congregate in groups larger than five; or within your own family circle only.

WAIVERS & SITE ACCESS

COVID 19 Signed Waiver MUST be submitted with entry and a new copy signed, dated, and presented EACH DAY upon arrival at show site to receive Access Wrist Band. No form, No access, No show, No exception!

Waiver must be signed by everyone participating at the show.

AGENTS AND ASSISTANTS

If you are using a handler or other exhibitor to show your dog, they MUST be identified on the "agent" line in the entry form. This is required for contact tracing. If the exhibitor has multiple dogs, they are allowed an assistant, but they must also be identified on the agent line.

An exhibitor/handler with 4 or more breeds may remain on the show site in a designated place until all their breeds have been shown. These 4 or more breeds are to be benched with the identified agent and all grooming will still take place only in the vehicle

MASKS

The correct wearing of masks (covering the mouth, nose, chin) is mandatory, by all event participants while within the precinct of the event. • The only time masks may be removed is while eating or drinking & then the mask must be immediately put on again. If exhibitors are sitting in their vehicles, masks may be removed. • In the event someone has a medical exemption from wearing a mask, then sadly they will have to secure someone to handle their dog(s) for them. While we respect medical exemptions, we also have to respect keeping others as safe as we can. • If you use disposable masks, we ask that you please cut the strings/elastics before properly disposing of the masks in the garbage. • People without a mask will be asked to leave the event. • Masks will not be provided by, or be available from LKC.

. HAND WASHING, SANITIZER & DISPOSABLE GLOVES

• Each Judge & Ring Stewards' table will have hand sanitizer on it (for use by Judge & Ring Steward). • Wearing disposable gloves is not encouraged. The COVID virus gets on them in the same way it gets on your hands. Your hands can get contaminated when you take off the gloves. • Signage will be posted to emphasize the importance of frequent hand-washing & proper hygiene practices. • Hand Sanitizing stations will be available, but you are also encouraged to bring their own hand sanitizer. • Everyone is encouraged to wash their hands as often as possible. "Wash your Hands, Wash your hands"

SOCIAL DISTANCING

Mandatory 2 meters Social Distancing will be maintained at all times (unless you are within your designated 'bubble').

• Exhibitors will maintain 2 m distance from competitors at all times while within the rings. • Exhibitors will "show the bite" to the Judge. • Exhibitors will only approach ringside as their ring time is approaching (5 minutes prior). • Except for individual examinations, a physical distance of 2 m will be maintained at all times. • Each table shall have hand sanitizer and each ring steward/judge shall have their own pen. If any of the equipment falls in the ring, please allow the steward to replace it. • Exhibitors are not to touch items on the Judge/Ring Steward table.

RIBBONS

• Judges will not touch or present ribbons. The Ring Steward will place the ribbons for the class on the table at the ring exit. Please be sure that, as an exhibitor, you know what ribbon(s) you have earned. The Judge will be clear in their placement indication. • Exhibitors will pick up their placement ribbon(s) as they exit the ring. • PLEASE − no recycling of ribbons. If you do not wish to keep your ribbons, please do not touch the ribbons.

GROOMING

Grooming allowed only INSIDE your vehicle No tables or chairs set up in parking lot.

JUDGES & JUDGING

• Judges will not physically examine the dog's bite but will have the exhibitor display the bite. • Judges will clean their hands frequently using hand sanitizer, hand wipes, etc. • Judges will: wear masks at all times while in the show ring & on the show grounds unless eating, bring their own materials and equipment for their own use only (e.g. CKC Standards, pens), limit interactions to ring procedure instructions. • Judges will not touch ribbons, will clearly indicate class placements (for benefit of both exhibitors & ring stewards) • Except for individual examinations, a physical distance of 2 m will be maintained at all times. • Best of Breed Judging: - To ensure "Social Distancing" and Exhibitor safety, breed judging may be split into groups (if warranted) with the Judge making cuts from each split. The cuts will then be brought back for the final Breed judging & placements.

ADDITIONAL INFORMATION •

No Public Catalogue will be available. Please know your number(s) when picking up armbands. ● Please pick up after your dogs. ● No public dog bathing station. ● Be self-sufficient: bring sanitizer, bring personal use masks, no masks will be available.

- Do not bring & leave personal belongings to ringside (chairs, towels, coolers, grooming equipment, water/spray bottles, etc). Other than a crate for an exhibitor with more than 1 dog in a breed, anything you bring to ringside MUST go in the ring with you! Do not leave masks, gloves, water bottles, litter, etc., behind at the show site. Please dispose of these items in the garbage bins. Avoid shaking hands, hugging, or other physical contact.
- Avoid touching dogs that are not your responsibility. Only Exhibitors with dogs will be allowed in staging areas (area just outside of each ring). Each ring will have a staging area. Avoid touching other dogs.

RING STEWARDS

- Ring Stewards will remain in the ring areas. Wear a mask. Maintain 2 m from others.
- Place ribbons on the table to be picked up by the exhibitor. The Ring Steward will not touch the judge's pens, materials and equipment. If required to do so, they will use hand sanitizer before & after doing so. Show Secretary Scheduling will be an important measure used to reduce numbers in the rings at one time. The Secretary will develop scheduling that will keep the number of people in the ring areas within posted limits. SAFETY MEASURES AND PROCEDURES COMPLIANCE There will not be any paper judging schedules available at the show. These are trying times as everyone knows, but LKC and its members remain diligent with regard to Compliance. All instances of non-compliance or acts of verbal defiance, arguing, etc., must be reported to the Show Superintendent and without hesitation the person / persons will be asked to vacate the venue immediately, and NO refund will be given. In addition, an Official Complaint will be filed by the club with the Canadian Kennel Club

.LKC acknowledges that these procedures are not the normal way of hosting an event, but in order to remain compliant we are going to follow the Regulations as set out by The Health Department.
