## **GENERAL RULES**

- 1. All dogs must be exercised in the exercise areas provided. Please clean up after your dog.
- 2. No refund of entry fees will be made if it is impossible to open or complete the trials because of riot, civil disturbance, or other acts beyond the control of the Westman Rat Wranglers. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Judge or event committee.
- 3. Westman Rat Wranglers will use due care and diligence for the welfare of dogs and exhibitors but will not be responsible for, or assume any liability, in the event of accident or other mishap caused to either dogs, exhibitors or spectators, whether the results of accident or otherwise. A dog should not be touched without the permission of the owner or handler.
- 4. All entries must be accompanied by the required entry fees to be considered valid. A returned/NSF cheque does not constitute a valid entry. There will be a \$35.00 fee for all returned/NSF cheques. Please make all cheques payable to: Ramona Schreiber. Please forward all entries and payment to the trial secretary.
- 5. Exhibitors are responsible for complete, accurate and legible information on entry forms; illegible or incomplete entries cannot be entered in the trial. BHA entry forms preferred.
- 6. No refunds will be granted after the closing date without a veterinarian's certificate. Refunds will be processed at the conclusion of the trial.
- 7. Dogs MUST run "naked," without a collar/harness. Dogs should enter and exit the ring with collars/harnesses, which can easily and quickly removed and replaced. All dogs must be on leash at all times except when in the ring.
- 8. **Loud/Disruptive dogs:** Loud dogs must be located away from the ring/crating area and/or staged away from the other dogs getting ready to compete. Any dog behaving in a threatening or aggressive manner toward another dog or a person, may be dismissed from the trial if justification is found to do so by the judge and/or trial committee.
- 9. **Bitches in season** are eligible for entry, but will be required to be kept separate from all other dogs and will be run in panties at the end of their class in a separate blind. If bringing a bitch in season, please inform the trial secretary prior to the trial and you must inform all exhibitors at the judge's briefing.
- 10. Wednesday's trial will start at 4 PM and Thursday and Friday's trials will start at 8 AM, with the general briefing, followed by the judge's briefing and then the class briefing. The first blind will load after the class briefing and the first dog will step into the ring right after the first blind fills.
- 11. Class order: Wednesday August 14, 2019 Trial 1: Instinct, Novice, Open, Senior, Crazy 8s, Master. Thursday and Friday, August 15 & 16, 2019: Trial 1: Instinct, Novice, Open, Senior, Crazy 8's, Master Trial 2: Master, Senior, Open, Instinct, Novice
- 12. **CLUB GROUNDS:** East St. Paul Community Centre grounds (east of the Community Centre) located at 264 Hoddinott Road in East St. Paul, Manitoba. A 10' x 10" tent will act as the blind and will be located 20 feet from the ring. The single ring will be located under a tent, east of the community centre and south of the parking lot. There is a washroom available on site. The trials are being held on public property and is handicapped/wheelchair accessible.
- 13. Trial to trial move-ups/lateral moves will be allowed. Move-ups from Senior to Master require an additional \$5/class.
