### DETAILS

- Start times each day (approximately 8 am on Tuesday and 9 am on Wednesday) will depend on the number of dogs entered.
- FDXCh, FDX, FDA, FD for tests 2420227657 and 2420227658 will run first starting approximately 8 am Tues. June 11. FDJ for 2420227657 and 2420227658 will follow. FDXCh, FDX, FDA, FD for tests 2420228209 and 2420228210 will be run on Wed. June 12, starting approximately 9 am with FDJ for both tests to follow.
- All entries will be notified of the running order before the test. Changes often occur during the two days of tests so entrants should arrive at least one hour before their scheduled run. If any other changes are likely they will be advised by the Test Secretary as soon as possible.
- The BSCC reserves the right to limit entries.
- No entry will be accepted from any person not in good standing with CKC.
- If your dog has twice qualified with any of our Judges, notify the Test Secretary **BEFORE** the drawing takes place.
- Entrants are responsible to confirm receipt of entries and running times.
- FDJ, FD and FDA will be single course with bird field.
- FDX and FDXCh will both be a single course.
- Chukar partridge will be used in all categories. Ducks/chukar/pigeons will be used for the FDX water retrieve.
- Gunning will be done by 'official' gunners only.
- FDJ and FD dogs will run individually. FDA, FDX and FDXCh dogs will run in braces.
- Handlers must carry a starter pistol even when Gunners are available.
- Safety Gear: All entrants, judges, gunners, volunteers, and spectators who enter or are physically present on the test course, must wear blaze orange clothing and blaze orange head gear in any test where shotguns are used. (Clause 16.2 of CKC *Field Dog and Water Test Rules and Regulations for Pointing Dogs*).
- If a dog is not present at its starting pointing within five minutes after it is called for by the marshal or judges, it may be disqualified.
- There will be no training/running of dogs on the ground during, before, or after the tests.
- Standard CKC blue ribbons will be presented to all dogs with qualifying scores.
- Certificates will be given to the Top Brittany in each category
- A Gunner's Award (chosen by Gunners) will be presented from ALL dogs entered each day.
- Bitches in season are not permitted on the grounds.
- A current record of vaccination for the dog may be required.
- It is expected that everyone attending will behave in a manner that is respectful and appropriate to the dogs, owners, handlers, judges and volunteers.
- We believe that anyone or any dog participating in our field tests should not be subjected to an indignity of any kind during the test and that it is our duty and obligation to see that this is carried out. If anyone reports an alleged indignity to us, our Field Test Committee will conduct an investigation, make a decision or ruling and then report to the Canadian Kennel Club. The Discipline Committee of the CKC shall then have the power to take such action as it deems fit.
- The order and time of tests will be determined once the entries close on Thursday, June 6, 2024 at 5 pm. The order will be 'random'. Specific times cannot be assigned.
- **LATE ENTRIES** will be accepted but are subject to availability of birds, total number of dogs that can be reasonably run, and in the case of braced entries, whether a brace mate or bye-dog is available. If accepted, they constitute a legal commitment to pay and cannot be withdrawn or refunded. Late entries must reach the Test Secretary by 6:00 PM the day before each test day. Cash or E-transfer payments only for late entries.
- The drawing for the running order will take place on Sunday, June 9, 2024 at 8 pm at 535 Concession 1 Rd. S., Cayuga, ON. NOA 1E0
- By registering and payment of fees entrants agree to release the CKC, BSCC and its judges, members, directors, volunteers, and landowners from any claim for loss of damages respecting personal injury (including death) and property (including loss or injury to dogs) that might arise in any way from anything to do with the test. They also agree to comply with the requirements of the premium list.

### FDJ entries are \$60.00 each, all others are \$70.00 for each test entered. LATE ENTRIES ADD \$5 EACH: FDJ - \$65.00 each, all others \$75.00 each.

Note: A Temporary Competition fee as established by the Canadian Kennel Club must accompany the entry of a dog for which a Canadian Kennel Club individual registration number (ERN), Performance Event Number (PEN) or Miscellaneous Certification Number (MCN) is not shown on the entry form. Visit the CKC website for more details. Choose 'listed' on the registration form to indicate you are paying this amount.

All entries will be confirmed and you will be advised of the running order prior to the tests.

### **MORE INFORMATION**

**Immunization**: All dogs must have current immunization before being entered. **Bitches in season**: are permitted ONLY in FDJ of Test #4 and will be run at the end of the day. **Meals and Refreshments:** the BSCC will provide lunch and refreshments to judges, gunners, and other volunteers. Exhibitors must provide their own.

No Smoking: No smoking anywhere on the test site grounds or in the parking area.

### **MOVE-UPS**

**Move-up** forms for Test 2 (June 11) must be submitted in writing to the Test Secretary one hour before Test 2 starts. Move-ups for Test 3 (June 12) and Test 4 (June 12) must be submitted before the Secretary leaves the grounds on Tuesday, June 11. Move-up to a braced class is only permitted if another brace mate or bye dog is available.

### **GOOD SPORTSMANSHIP**

All who attend our tests, in any capacity, are expected to display conduct in a manner that reflects credit to themselves, their dogs, and the sport of purebred dogs, regardless of circumstance and location. Under Section 7 of the CKC *Field Dog and Water Test Rules and Regulations for Pointing Dogs (2023)*, the Test Committee and/or Judges have the authority to expel any individual who, in their assessment, displays unsportsmanlike behaviour.

**From Points East:** Keep straight onto Hwy-403 W/QEW. Bear left onto QEW. At exit 88, take ramp right and follow signs for RR-20 Turn right onto Hwy-20 / RR-20 / Centennial Pkwy N. Road name changes to Hwy-56 / RR-56. Cross Hwy-3 / Talbot Rd. Next right turn onto Concession 1 Rd S.

**From Points West:** HWY-403 East toward Hamilton. At exit 41, take ramp right for Garden Ave. toward Cainsville. Turn right onto Garden Ave, Road name changes to CR-18. Turn left onto Hwy-54 / CR-54. Turn left onto Hwy-3 / Talbot Rd. Turn right onto RR-17 / Thorburn St. Turn left onto Concession 1 Rd S.
